Email #6 ended with 07 AUGUST 2013 hospitalization for MRSA infection in my left leg caused by Dr. Badawi Mohammad Abdellatif refusing to spend CORIZON HEALTH funds on proper medical treatment. At hospitalization, my entire left leg was infected up to my hip. My foot, knee and hip would not flex. It first appeared nerves and muscles of my left leg would no longer function which in 2018 is partially paralyzed.

At Duane Waters Medical Center (DWH, which had recently lost hospital certification for medical horrors) in AUGUST 2013, I was put on Vancomycin I-V antibiotics for alleged "cellulitis" that began in MAY 2013. In SEPTEMBER 2013, I told CORIZON Dr. Rashed Bashir, "I have allergic reaction to something I eat. I don't know what it is. Can you give me an allergy test"? I said I sometimes get hives, my throat swells, lungs fill with fluid, blood pressure drops-out, and often I pass-out. Dr. Bashir said, "You think to much", then further ridiculed me. With a food allergy, the allergen often damages villi of the small intestine. Food is normally broken-down into small-chain proteins before absorbed into the bloodstream. The damaged villi cause long-chain proteins to be absorbed into the bloodstream rather than being broken-down before absorption. Long-chain proteins in the bloodstream plaque the arteries and obstruct blood flow. As skinny as I am, having never smoked tobacco, and not eating junk food, it should be unusual for me to have heart disease described hereafter.

In 2012 to 2016, I continually told Dr. Badawi Mohammed Abdellatif of shortness of breath (dyspnea), severe chest pains, lungs burning (angina), and often hypotension with passing-out after eating a bologna or peanut butter sandwich. Since I got no medical treatment whatsoever for any of this and CORIZON doctors forced me to eat processed meats, soy and peanut butter or starve, I began using coffee to raise my blood pressure when it began to drop-out.

In the morning of 01 JUNE 2015, I passed-out around 0600-hours after eating a bologna sandwich. My blood pressure was first measured at 50/20 mmHg but that never was entered into my medical record, only 70/40 mmHg which was a typical CORIZON falsification of a records.

On 23 AUGUST 2015, I lost vision in the right half of my right eye for about two-hours with such hypotension. On 26 AUGUST 2015, Kresge Eye Institute said this was hypertensive retinopathy. It again occurred in OCTOBER 2015 and JANUARY 2016. Through all this, I still was repeatedly telling Dr. Abdellatif of the dyspnea, chest pains and lungs burning (angina). From 19 JANUARY to MARCH of 2016, I continually had hives, my skin turned purple, throat and legs swelled, and I had constant shortness of breath. This was caused by eating soy and processed meats. It lasted the full 2-months. Dr. Badawi Mohammad Abdellatif entered into my medical record on 26 JANUARY 2016, "he has allergic reaction all over body". My skin stopped tanning after this occurred but medical personnel offer no explanation. Abdellatif never ordered any testing to determine cause of this reaction because CORIZON HEALTH, Inc. policy did not allow testing until a prisoner is at the point of IMMINENT DEATH.

Again, in MARCH to JUNE of 2016, CORIZON doctors and Michigan Dept. of Corrections

nurses ridiculed me and got hostile when I asked them for medical treatment and to put my "allergy" symptoms in my medical record.

In MAY 2016, Prisoners Elvis Williams broke-out in a heavy sweat then passed-out late one afternoon. A CORIZON HEALTH, Inc. doctor sent him back to his cell where he died of a Heart Attack about three hours later because the CORIZON doctor did not want to pay for hospitalization. For days later, Prisoner Morris Houston was repeatedly returned to his cell after being at Health Service for a digestive blockage caused by a hernia. After 10-days of being returned to his cell for this, I observed him with eyes that had turned fire hydrant yellow, told two guys to put him in my wheelchair and take him to Health Service. Houston died 3-days later in the hospital because the CORIZON doctor did not want to pay for medical treatment. I've seen over 100 prisoners die in recent years because of the CORIZON policy of profittering at the expense of human life. What is done in prison is just a practice for what is planned for the GENERALLY DUMB PUBLIC so this is prophecy of what everyone will get under forced GOVERNMENT HEALTH TREATMENT (not care), like one giant WWII Death Camp.

From 20 MAY to 12 JUNE of 2016, I went to Health Service at least 6-times for what I thought was pollen allergy because that's what Dr. Abdellatif always told me the chest pains were. With blood pressure of 210/100 mmHg, I was sent back to my cell at least 5-times to die of Heart Attacks. On 12 JUNE 2016, I went to Health Service with blood pressure of 260/130 mmHg and the nurse said, "The machine is broke". I said, "It isn't broke. You'd better do something," so the nurse gave me Nitroglycerin which brought my blood pressure down to 235/119 mmHg. The nurse then telephoned Dr. Abdellatif who reluctantly sent me to Henry Ford Hospital where the doctor told me the last 2-weeks of chest pains were "multiple Heart Attacks and angina". I was then sent to McLaren Hospital where the cardiologist told me that I had "multiple Heart Attacks and angina" over the last two weeks. My coronary arteries were 95% blocked. I had a triple-bypass operation on 23 JUNE 2016.

After the surgery, my left arm and left leg were totally paralyzed and CORIZON HEALTH doctors attempted to make me use a wheelchair. I told them, "Forget that. I want a walker"! I'm still stuck with a walker but attempting to get around on my own and hope to be jogging soon. (Letter #7 will be last of this series.)
