

Hello Mr. Taus,

As far as I can tell, you are upset with me for three items.

- 1) Regarding my assumption your conviction was somehow related to David. I made a mistake and then I made a public video and apology within 24 hours after that error was brought to my attention.
- 2) Regarding my initial questions to you which you considered an "interrogation". Do you not think I have a responsibility to ask questions of the prisoners which I put my own name and reputation on the line to advocate for? We have never met and yet someone suggested that I look into your case as they believed you are an innocent political prisoner wrongfully convicted of child molestation because you are an FBI whistleblower. Do you already have crowds of supporters out here in the public advocating for your innocence? Because if so, I don't see them. Put yourself in my position. How willing would you be to go publicly advocate for someone who has been convicted of your crimes? I don't hide behind screen names and anonymous channels. I use my real name. What do you think I get out of advocating for innocent men and women behind bars? Yes, I made a mistake initially with your case and I publicly apologized. I do not apologize for asking you questions which you consider "an interrogation".
- 3) I used the wrong picture of you. Again, I apologize. That picture has now been removed. It was an honest mistake.

I have ordered FBI, CIA, the Mob, and Treachery by Rodney Stich on 6/1/18.

I have completed reading "The Richard Taus Story Part One, to Be a Hero; An American Boyhood Memoir" by David Richard Taus as of 6/1/18.

I am on pg 280 of "To Be a Hero, Stolen Honor: Inside the FBI, CIA and the Mob" by David Richard Taus.

Note: I am aware of your sufferings and persecution and am in the process of learning more. It takes time as I have 40 prisoners that contact me on a regular basis and they all have horrific stories of abuse, mistreatment and false convictions.

And yes, I AM VERY DISSATISFIED with this government and I publicly call for the eradication of the FBI, CIA, BOP and DOJ. I could give you case after case of the FBI entrapping innocent men and women and ruining their lives.

Mr. Taus, I didn't know you or your name just a few weeks ago. Your case is a very complex which involves many books and much research. Communicating through this satanic prison industrial complex does not make things any easier. Over the course of the past few years, I have been visited by the secret service, lost my 20 year job, visited by US Marshals and FBI agents at my front door, targeted by the IRS for \$25k which I did not owe. My first wife of 27 years died of cancer so I am no stranger to grief.

Mr. Taus, let us be blunt with each other. The more I learn about your case, the more convinced I am of your innocence but I am also considered an anti-government, domestic terrorist by many in our society because of my belief systems regarding our corrupt corporate government. My youtube channel is on the verge of being taken down. It has over 10,000 videos on innocent political prisoners that were put up over a 9 year period. You are right in that you didn't solicit my help. I have many other prisoners that I can spend my time on. I will respect your wishes.

Option 1) You tell me to forget who you are and I will delete any reference to you and your books from all my websites. No hard feelings and I wish you the best and that Jesus Christ will work a miracle for your freedom without my involvement.

Option 2) I continue to communicate with you, read your books and the ones you recommended, educate myself about you, we both ask detailed questions of each other to get to know each other better and see where this goes.

You let me know what you want to do. I will try to answer any question you have for me but I expect the same in return. Below is what your webpage looks like as of 6/1/18. My counsel is that people need to get to know who you are by hearing your voice on the phone. They need to think of you more than just a name in a news article or a book. They need to hear you speaking on the phone and think of you as a living human being that is unjustly incarcerated. That is why I record prisoners when they call me so that people will think of them as living humans, not just convicted criminals with a number.


