Dear Mrs. Erin and Mr. Rudy,

Hello, hope all is well and good for you both! I sat down to do a Bible study from Evergle prison ministry. Got it in the mail yesterday. But you both are on my mind. From my next door cellie Tommy have conversation. Telling me talk with you. About your on the side of the road car trouble. Had it happen to me before too. Radiator once, universal join the second time. Lucky I had 4 wheel drive. When! glory!

I already wrote you once last week. Wanted to cover some of my needs, learn what your guidance can lead me to, plus, maybe it will be helpful in your posting my course on the internet. You can get full details from my appeal lawyer Mrs. Rachel Judge on exact location, people names, dates and such.

Here is my request. 7 yrs. ago the police in mobile Ala. Make up a story. They had the D.A., sheriff, judge help them sell it to the jury. In fact, the coroner went along with it and falsify the autopsy report. The doctor that

testified me and lied to the jury, claiming I misuse human being as objects. He been arrested on 4 drug charges, license pull, fired, and turn himself in re-hab to help get him out of a prison sentence. Hope he get well and admit to all the lies he did to dozens of people. I know of 4 other cases where the people got a death sentence, 3 got over turn, 2 got life, 1 still pending.

Here is the event. While I was on parole in MS, my mother husband died. April 2005. She was married 30 yrs, 28 to my dad, then 30 to my step dad. She was 82 yrs old. My siblings tried to put her in a rest home, but her house, and stuff. Well she summon me back home to become her full time care giver. Was a honor and privilege to love and work for mom. I sold my place, left the job. Come and work in the day at first, then as mother health went down, stay at her side day and night. We had a great time, mother passed on in Sept. 2006 For a 1 and 1/2 yr, she had a peaceful, happy life. I am her tenth child, only one not married. Only one who was willing to move in and love and help

her. I had a dual parole status, MS and AL. I live a godly, peaceful, christian life. Been drug free for 38 yrs. Since I was 21, for instant. Fast forward in Sept of 2011, 5 yrs. after mother departed to heaven. I was pick up and arrested for theft. I had purchased a U-haul utility trailer. Had had a dozen witnesses signed bill of sell. But was arrested by the guy grand mother. My parole officer believed in me. Check out the evidence. Ask the judge to release me. Got out on bond. Two month later, This man body was found dead on a police secure compound (firing range) piece of property that was closed.

The police in charge had found out I was on parole. and came to my parole hearing. Ask I be place back in prison. Parole officer said no, and he change the use u-haul trailer value on the spot during the hearing, from less than 500⁰⁰ which is 3RD degree, in what I was arrested for wrongfully. Into a \$2,800⁰⁰ value trailer, to cause it to become a first degree, well, when the judge let me out. This

police started to hound me, when the man was found dead. He began claiming I did it. Went around my neighborhood and told dozens of people I had done it. He disregarded all the real forensic evidence and started making up false evidence.

The supposed killing supposed to have happen in Sept. 2011. But I told the appointed lawyer where I was, what I was doing. To prove my innocent, which I was returning my sister to Searcy Hospital. A state mental hospital. She been there for 40, 50 yrs. She 10 yr. older than me. I lived her over a 100 time from 2005 to 2011. Had gotten her pass from a half a day to 10 days.

It happen she had a wk end pass the night the police claim I was in a fight and kill this man. I was returning her. I am on the video surveillance security camera in side and out. I sign the log roster record book, show my driver license #, pass my sister her clothes, and unused medicine over to the nurse. Probably saw half a

dozen worker. The lawyer said they did not need it. That I did not need to prove innocent. The state had to prove guilt. Well here is how I understand the hit. Andrew Park manufacture the whole lie. He claim to talk to 3 kids in April of 2012. 3, 4, 5 yrs. old. Both there mom and Dad was in prison in 2010, 2011. There grand mother Regina Norris was given custody. I carry them dozens of time to church, zoo, park etc. during these two yrs. Well in Sept. 2011 I purchase the trailer, got arrested for. The man who I got arrested had a warrant issue by his grand mother too. He hide out, did not get pick up. I went to the police station to clear my name of any wrong doing. Was arrested and got out 11 days later on bond. 2 months later Oct. 24, 2011 The man found dead. The police went to the grand mother house during there investigation. For months they started claiming I kill the man at my house, but video of him at the grand mother house clearly shows

he was not dead and it is from a neighbor surveillance yard camera. He has 6 views 2 of them view on Regina Norris's property, both partial drive way and front porch.

Because the 3 kids became too much for her. She call the other grand kids grand mother in Chicago Ill. In June 2011. She come by bus, pick up the littlest 3 yr. old. Took him back to Chicago, kept him until his mother was release in Nov. 2011

So, she again rode a bus; Come back and deliver him to her in Nov. 2011. in April 2012. The police talk to all 3 kids. After over a dozen bribes of toys, sweets. The 3 yr. old finally

repeated what the police told him to. Claiming uncle Dennis got in a fight, and kill the men. of course ~~no~~ none of it never happen. None of it! Well, he

got a dozen child care expert, other officials, and video the child claiming what they coach him into saying.

In reality, the toddler was in Chicago, but the police did not have enough sense to ask. He presume they all 3 was together the whole

time their parents was in prison. He built false evidence around this child. Who he put up to see what he did. He was only 3, he doesn't know yet a lie or truth. He too small. But the police claim he took the boy to the house, he pointed out the exact spot the fight happen. That I took the baby out side and hung it on a particular tree. The boy pointed it out. Because none, I mean none of all the dozen or 50 forensic science test done. Shows no trace of any body blood, my, his, nobody. The police got a "train dog" to go sit on the spot in the house, and go sit at the tree and told the jury. That it did it cause it smell the dead person body bones here. all manufacture lies.

What I need help in is rallying up some volunteer help, from a law school student, a innocent project group that specializes in helping wrongful convicted people, church member, or retired people, that live close by or in Chicago, Ill. area. The little boy was there

For 6 months, the grand mother show him off to family, Neighbors, ~~many~~ many church member saw and talk to him. Sunday school care work took care of him. People meet him, pastor etc. Took photo graphs with him. He had medical treatment do. One was from a bicycle accident that injury his ankle. needing a cast. He saw doctors, nurses, x-ray folks. I need medical record copies, all the document and referral. of eye witness account of meeting and watching the child at play. People move off, die, and well this should it been done in Jul, 2012, but it has not. I want to help save, preserve the truthful evidence of my innocent. I realize Ms. Erin, and Mr. Rudy that the bus tickets, their station video evidence might not be available after almost 7 yrs. But honestly, I believe a ton of evidence is still there, available to be gather up with a caring soul who is against injustice, and corrupt verdicts. I

am totally 100% innocent. They made up their case. On non-sense. I would like for you to help get some body both in Chicago on the kid movement, and in mobile, on my movement. and help me secure the truthful factual facts. They support my innocent. Are you able to set up a face book, or u-tube, or twitter, account with my course and or maybe a web site of both my innocent and what is needed to grow and prove my innocent. There in Chicago, maybe you can google folk there, who go to the grandmother's church and actually play with him, got photographs of him there. my appeal lawyer don't do trial circuit research, I hope my reversal will come this year. I decided to try and hire some body to help me get up the proper people to gather up truthful evidence. Before it is lost, I mean, God forbid I do 10, 15, 20, 30 yrs. here, then some body decide to go look for

the evidence. I been here on death row 2 yrs. 5 yrs. in the ad. jail. This shock is wearing off. I am innocent. My suffering is real. Lost liberty, relationships, all my worldly possession. Got a disgraceful, shame brand on my shoulder. I want the record clear. I want to be clear of this horrible crime. I did not do it. Please help in which ever area you know to do. I'll do phone interviews, am willing major media to help. t.v. network, shows like 48 hr. 60 minutes, 20/20, nightline, who ever. I'll become the poster board people for wrongful imprisonment. Due to the bias, prejudice of one Lt. Cog. He misquided and help to corrupt the whole investigation. Rail road, rig false lies to frame me. We could not stand for a ex offender to be in society. But I lived a peaceful, righteous lifestyle. I love being a christian, I seek to honor and love God, or I any fellow man. Contact who ever you can on my behalf. I need the connection on caring

people to get the truth before a
honest jury. Any effort, energy,
time with this objective in mind
is what I am requesting your service
for. To spread the news of it all.
To locate people in the needed
area, and for to people willing
to go there. To seek out
retirees who can do the test on
needed items to show that the
few the police did. Are not totally
accurate. These marks, was 10, 12,
15 yrs. old. Need them tested.
Signature on the bill of sell the
P.A. claim to the jury I faked.
It matches his signature cause it
is his signature. He got plenty of
things he sign. SS card, high school
diploma, food stamp form (The
week he suppose to have died too)
Just so much. Appoint and designate
all you believe who will be
available and good at either
talking to people in Chicago or
mobile, who good at gathering up
document research like the
hospital records, those who
can test items. I mean, I had

3 tool boxes in my vehicle, a
work tool knife was tested 4 times.
First 3, come back paint oil on
it. The fourth, was undecided, and
they used that one for the injury
to her. Claiming it was the murder
weapon and I just wash off the
blood. Same with the house and the
tree. All non-sense, made up lies.
Your expertise is needed. How
do we gather up the forces
to rally people around this just
cause? This injustice been
going on 7 yrs. almost. I
realize Mr. Rudy, many across our
great nation got it much worse than
me. I am in great health, good
shape. Almost 60 yrs. old, can't smoke,
do drugs, nor drink ~~alcohol~~ alcohol.
love working, repairing, building things,
love people, old and young. Never sought
to be famous, wealthy, just a regular
simple man. Thank you for all your
time, willingness and successful help
you're giving me. God bless you both.
