The following Executive Orders, recorded in the Federal Register and, therefore, accepted by Congress as law of the land pursuant to Title 12 United States Code, Section 95b, known inter alia as the Federal Reserve Act, can be put into effect any time an emergency is declared: 10995-All communications media seized by Federal Govern-10997-Seizure of all electrical power, fuels, including gasoline and minerals. 10998-Seizure of all food resources, farms and farm 10999-Seizure of all kinds of transportation, including equipment. your personal car, and control of highways and seaports. 11000-Seizure of all civilians for work under federal supervision. takeover of all health, education and welfare. 1 11001-Federal 11002-Postmaster General empowered to register every man, woman and child in the U.S.A. 11003-Seizure of all aircraft and airports by the Federal Government. 11004-Housing and finance authority may shift population from one loc-11005-Seizure of railroads, inland waterways and ality to another. storage facilities. 11051-The Director of Office of Emergency Planning (FEMA) authorized to put Executive Orders into effect "in times of increased international tension or financial crisis." He is also to perform such other functions as the President may direct.

12919 (June 3, 1994) created infrastructure for carrying out above orders and civilian work "without compensation," further defined in 13010. 13083, revised as 13132, makes all States subservient to the Federal Government. 13107 makes the Federal Government subservient to the United Nations and other countries. Public Law 106-25 (Oct. 18, 2000) and Treaty Document 104-29, give 70% of land mass of the U.S. to control of the United Nations.

The Federal Government, USA, Inc. (Articles of Confederation (Nov. 15, 1777); $\underline{4}$ USC, 101; $\underline{28}$ USC, 3002($\overline{15}$)), has slowly done the above since 1913. In October 1985, it became a crime to have more than a 90 day supply of food in any household. Ex.Ord. 11490. Goals 2000 turns public education into psychological indoctrination in government religion. Earth in The Balance, Al Gore, p. 62.

The Federal Government gave more than 15 million acres of U.S. property to control of the United Nations UNESCO Group as UN Biospheres. It forcefully moves U.S. Citizens off the lands, roads are blocked and U.S. Citizens not allowed to enter areas where U.N. military bases are set up. eg. Desoto Nat'l Forest, Smokey Mt'n Nat'l Park, etc. One giveaway was 1.5 million acres in Utah; one of only 3 "clean coal" deposits in Earth (Pres. Proclamation 6920, Sep. 18, 1996). A minor deposit is in Mexico; The other in Indonesia and owned by the LIPPO Group (PLA of Red China) that gave illegal campaign money to President Bill Clinton. Most of this is under the U.N. Biodiversity Treaty and World Bankruptcy of the U.S. (circa 1933 by FDR).

The Fed seized 200 billion dollars in private assets in November 30, 1995 to April 25, 1996 to meet payments of the Federal debt; taken from Government Employees Pension Fund, etc. Such seizures can only be done under martial law. Title 12 USC, Sec. 95a.

Public Law 104-193 required a National ID Card by October 1, 2000 but was temporarily suspended. Without it you cannot do business with the Federal Government - you cannot buy or sell. It's origin is Title 42 U.S.C., Sec. 666, the Deadbeat Parent Statute.

Effective October 6, 2000, <u>Public Law</u> 106-65, Section 1067, put the U.S. Attorney General in charge of weapons of mass destruction for U.S. military use in the U.S. This is for civilian gun confiscation. Public Law 87-297; <u>U.N. Treaty</u> (Aug, 1954).

Title 12 United States Code; The Federal Reserve Act, Etc:

Sec. 95a. Regulation of transactions in foreign exchange of gold or silver; property transfers; vested interests, enforcement and penalties

(1) During the time of war times of increased international tension or financial crisis, the President may, through any agency that he may designate, and under such rules and regulations as he may prescribe, by means of instructions, licenses, or otherwise -

(B) investigate, regulate, direct and compel, nullify, void, prevent or prohibit, any acquisition, holding, withholding, use, transfer, withdrawal, transportation, importation or exportation of, or dealing in, or exercising, right, power, or privilege with respect to, or transactions involving, any property in which any foreign country or a national

thereof has any interest,

by any person, or with respect to any property, subject to the jurisdiction of the United States; and any property or interest of any foreign country or national interest thereof shall vest, when, as and upon the terms directed by the President, may prescribe such interest or property to be held, used, administered, liquidated, sold, or otherwise dealt with out in the interest of and for the benefit of the United States.... (FDR changed "out" to "in" on March 9, 1933 to declare the People as enemy of the corporate government, USA, Inc.)

EXECUTIVE ORDER 10348

EX. ORDER NO. 10348, April 28, 1952, 17 F.R. 3769, which provided that Ex. Ord. No. 8399, April 10, 1940, 5 F.R. 100, as amended, set out above, and all delegations, designations, regulations, rulings, instructions, and licenses issued under such order, should continue in force according to their terms for the duration of the period of the national emergency proclaimed by Proclamation No. 2914 of December 16, 1950, set out as a note preceding Section 1 of the Appendix to Title 50, War and National Defense, was superceded by Ex. Ord. 11281, May 13, 1986, 31 F.R. 7215, set out as a note under section 6 of the Appendix to Title 50.

Sec. 95b. Ratification of Acts of President and Secretary of Treasury Under Section 95a.

The actions, regulations, rules, licenses, orders and proclamations heretofore or hereafter taken, promulgated, made, or issued by the President of the United States or the Secretary of the Treasury since March 4, 1993, pursuant to the authority conferred by Section 95a of this Title, are approved and confirmed. (Mar. 9, 1993, c. Title I, Sec. 1, 48 Stat. 1).

(Section 95b, modified by U.S. Congress in 1993, institutes a permanent state of declared emergency (martial law). At whim, the President of the USA may enact law. He does not have to go through Congress as we are led to believe. If Congress does not void an Executive Order within 90 days, it becomes law. It is a Presidential dictatorship. 95b was enacted in 1977 upon realization that for the first time since 1917 the U.S. was no longer in a state of war when the Vietnam conflict ended; Presidential Determination 97-32, Sep. 12, 1977, 62 F.R. 48729; PD 96-43, Aug. 27, 1966, F.R. 46529.)
