Thanks for the 2 emails. A friend wants the present address of Ed & Elaine Brown. Please send it if you know it. PTL! I've looked for it for years.

I will wait until I read the "Child Auctions" article before I telephone you, to save funds. It costs about \$4 for 15-minutes. I can call you collect or you can send funds and I'll pay from here.

Enclosed is a GTL form for sending me funds. Since I had to have someone sneak this in, I would appreciate it if you copy the form and send the original back to me. MDOC has a strange attitude about STAFF bringing us forms from up front.

I can send you a copy of my book, "Satanic Deception; a De Facto Government" if they will let me copy it. It may be 77 pages in book form or 44 pages in manuscript form. It's \$10⁰⁰ per page and about \$2.31 for postage. I'll have to figure out where MDOC misplaced it during a shakedown of my footlockers. "Child Auctions" is from the book.

I had food poisoning ~~on~~ 14 APRIL 2018 from a "Salisbury Patty". From 0001 to 0900 hours on 15 APRIL 2018, I vomited 5-times. I'm still weak but recovering and may have H. Pylori as a result. Thank God that Trinity Food Service will be terminated in JULY 2018 - if we survive their abuses.

Regarding "Child Auctions": 1997, I had to do everything I could to recall facts from the 1970s to save her two boys from the Society that held the auctions. I made an affidavit to those facts and wrote legal pleadings to help Linda Wiegand save her boys. It was strange when I walked into the library as Jesus had placed the exact book I needed as a discard on a shelf right in front of me. I opened the book, then it fell right to the page on a satanic priest she was going against. Her attorney called "my work" "brilliant" but I made sure that they knew it was the Lord, Jesus Christ.

At that same time, Connie Schleicher was in a Louisiana prison, held by the feds for 1-year with no trial on tax evasion. I ^{opened} ~~opened~~ 2 books at the library to find cases for me but both books fell open to the cases Connie needed. I wrote a motion & she was free in 2-weeks.

I do not speak over the telephone or email anything regarding my ministry or funds from songs but only write in U.S. Mail. The ministry ~~is~~ not yet running


because I have not been out to run it.


