Dear Brother Rudy,

Information on MI addresses to be released to began to pour in to me. I requested help 2-years with no results but things started coming within the last week. Thank You, Jesus. Two locations are in Ann Arbor, MI. I await an answer from the Veterans Administration in Battle Creek, MI. There is an address in IL which I prefer because they are Christians who will help me with rehab for medical problems and getting restarted. Someone must have recently begun praying for this. PTL!!! Matt 18:19-20.

I will give the Parole Board in and out of State options for discussion. Some ask, "Why would you stay in MI where they are trying to kill you?". There is unfinished business in MI to which travelling 500-miles is a hardship. I'm not afraid of them or death, and I believe the Beast is afraid of the Holy Spirit in me.

I was recently told by another witness to the same PUBLIC OFFICE MAFIA corruption of SE MI what a State Representative told him: The witness told the State Representative of corruption he had seen where State Judges took bribes and were involved with drug rings. Judge Michael J. Talbot was one of them. The witness said he wanted to make a police report on this corruption. The State Representative told the witness, "If you're going to do that, you should first sell your house and move out-of-State. Only then, should you make a police report. About the beautiful response to Ruth's Dream:

I see some dreams as a warning of possible things to come so we are prepared. This is a form of prophecy which has been since the beginning. It's a Spiritual version of martial arts training. YHWH wants us prepared to do the right thing in the WAR AGAINST EVIL and to HELP THE GOOD so we may affect the outcome for betterment of all who believe. I Peter 1:3-7.

Someone once said we control the end result in our dreams. If a dream keeps repeating, then we can cognitively plan while awake what to do in the next such dream and control the outcome. It worked for me.

If the repetitive dream incites fear, then while awake we can analyze why that unsolicited fear exists and think out the process for dealing with it. We may realize it is illogical to have any fear at all, or come to another understanding why the fear exists. The fear may have been "programmed" into us by parents or by the devil taunting to bend us to his desires. When the "bad" dream later occurs, we can activate our plan during the dream to eliminate the fear. For example: If the repetitive dream is about a structure collapsing under us to cause falling into pain or death, then just become like Superman and fly away so you don't fall. Understanding, knowing (Isaiah 6:9-10 (from my memory)) and dealing with it may end that "bad" dream forever because of knowing what to do in response to that particular "fear". Never give in to fear.

A dream may also be a preparation for worldly life events rather than an abstract fear. In a martial arts context, one of the first lessons is learning how to fall to prevent and/or minimize injury or pain. It is best to analyze and prepare beforehand on how to prevent our falls from grace and what to do if we accidentally slip from righteousness. A dream about a new experience may be a warning of something never thought of while awake to help avoid any evil. You could save many souls because you realized the danger and corrected it before happened.

Like the letter to Ruth said, a dream may be to teach of a thing not previously considered. Think of a repetitive dream about being hungry and naked in the cold of Winter. It may let you feel the pain and devastation of others so you can contemplate what Jesus would do, like in James 2:15-17. It may be to teach you of Godly Love for others in which there is no fear. I John 4:18.

Of the 20 or more Gospel songs I have written, all but one came to me in dreams. I immediately sat up and wrote down the words in the wee hours of the morning so the dream would not be lost to the cares of daily life. These songs have helped others.

Therefore, dreams often have a purpose that may be for our understanding or learning. When used properly, this is likely to help us and others along the Godly path with knowledge and Love that He freely offers. We are the example of Jesus to non-believers.

Do not fear those who can kill the body but cannot kill the soul. But rather fear Him who is able to destroy both body and soul in hell. Matt 10:28. I'm not a tough guy but am frail and easy-going. The deeply ingrained knowledge of the Word and Love of God sustain me through adversity. With enemy attempts to bend me I say, "Thank You, Jesus!!!", for showing me how desperate, evil and disturbed the enemy is at our strength and Peace in Jesus. I usually smile with the Peace that passes their understanding which may make them contemplate their wrongs. John 14:27 (verse # from memory).

God is Spirit. John 4:24. God is Love. I John 4:8. With His Knowledge, we have already overcome the world. Luke 10:17-20.
