I received your letter. I

man is to help others. So I  
do compliment, salute, and  
applause you both on your  
genuine efforts to help the

less fortunate in prison. Your  
both are in my prayers.

I would like to cover 5 topics  
briefly, then move on to your  
questions. I am willing to  
response to any. My life is  
an open book. I seek to be  
transparent, any discrepancy  
you may have, or the Godly  
of Christ, and yes even the  
Court and legal system, I am  
gair to help clear up best as  
I can.

My main objective, focus  
in my appealing to you for  
help, in advocating this injustice  
not going on in my life. 3  
fold, One I do seek to bring  
God Almighty — My Heavenly Father  
and my Lord and Savior Jesus

Christ, Both honor and glorify them.  
Second, that I am 100% innocent  
of the manufacture fabricated lies  
that Lt. Andrew Pick of the Mobile  
Sheriff cook up. From his bias,  
prejudice, his misguided blindness,  
hatred, greed and selfishness, he  
abused his position of protection and  
service. Once he was put in charge  
of the case. Sept. 2011. He begin  
his under tactic and corrupt method to  
frame me. He rig it so others on  
the police force would believe his lies  
in solving a cruel killing. Due to my  
being out on parole from a 1979  
killing. In which I step up and admitted  
that my step nephew and I was attacked  
and assaulted by 2 men. In which

I could not fought the case and gotten  
a manslaughter charge, D. d 4, 5 yrs.  
got parole. But I confess up to my  
shooting both men. Regardless if you  
decided it was justify or not. I  
was given 2 life sentences. For 25 $\frac{1}{2}$   
I went into training and earn over  
a hundred awards, diploma, certificates  
of Bible and educational advancement  
after 7 appearance before the MS.

Dept. of parole, having a excellence  
prison record, (not w/out a few  
bump in that stretch of time period  
in that environment). Still, I was  
granted a miracle of God's gracious  
love, forgiveness, mercy while out doing  
good. Being a productive asset to  
both God's church and society at  
large. My mother Mrs. Marie Hicks  
can summon me back home to be

her full time care giver. She was married to Dad 28 yrs, and after about 10, 12 yrs. married my step dad who after 30 yrs. departed to heaven in April 2005. Mother and I ask God to grant me favor to transferred my parole over to Als. This was approved into what is known as a dual double parole status. I was the 10th child, and my sibling fought for mother to be placed in a rest home. Some did not like mother choosing me as her protector, provider, helper in her golden yrs. She was 82 when I change job, sold my small place, Moved back home with her. For 1 1/2 yrs. I had the honor and privilege to love, comfort, serve my mother in any capacities she desire. I was

given legal P.O.A., estate administrator  
of her will, appointed her life will  
admin. She enjoys love, comfort,  
peace, for her remaining days.

She departed Sept. 6, 2006 at  
83 and 9 months year young. To  
me, she was, is, and always shall  
be a saint of God Almighty.

Five yrs. later, after parole  
recommendation for a pardon, all  
sorts of support from individuals  
God placed in my life. I had  
former Gov. W. Mark Winter leading  
a clemency petition for a conditional  
pardon. For Jan. 2012 from then  
Gov. Haley Barber.

The short of it is. I help  
a 23, 24 yr. old man name  
Joshua Duncan. He was sleeping in

his grandmother front yard ditch.  
He stated this truth to the only  
county official involved in the whole  
case. His appointed food stamp  
counselor. He applied for end of Aug, or  
first of Sept. 2011. Since I offer  
to help aid, ass't him. The counselor  
call me back into the interview, I  
affirmed he could rent a room from  
me, and wrote a statement and sign  
my signature to that. She placed it  
in his file. He too signed and read  
the policy contract and application.  
In front of her and me!

Well, about a week later. He  
leaves my house. Which was Tuesday  
Sept. 6, 2011. Last time I personally  
saw him with my own 2 eyes.  
The day before he left too, went

to a store a few blocks from my house. I call his mother grand mother to see if he was over there picking up t.v. fishing poles, more of his personal belongings. Which when I first pick him up and agreed to help him. He only had room in my vehicle for clothes, I had tools and material for a job assignment.

Lt. Andrew Peak, call me on wed. 2011, Sept 7, first time I ever talk to him. Due to a family tragedy of my own, my bro-n-law having a heart attack and died that 9-4-11. And the fact that Joshua was not gone over 48 hrs. I help with the clothes and such when I last seen him, his grandmother had file a false report. Both about Josh leaving

her house, And warrants for both him  
and me, on the u-haul - utility trailer  
I purchased from Josh. In front  
of a half dozen people. Witnesses  
to the signature on the bill of sell.  
That he and I both signed.

Well, Lt. Peak found out I  
was on a double life sentence. That  
I had been living in mobile for  
6 yrs. He began by threatening to  
put me back in prison if I did  
not tell him where Josh was. I  
did not know where he was. Well,  
~~he came to my~~ the police surrounded  
my car on the way to my bro-  
wnton funeral. About 5, 6 vehicles.  
Several had drawn guns by then.  
He and after I agree, to let

They put me down, and do a search of my car. Ask if I'll agree to come to the police station. Of course I was willing then, as well as now, to help. So I did. I was arrested for a 3<sup>rd</sup> degree theft, charge. My parole officer heard the facts, and release me. So the judge granted me bond. The Lt. came to my hearing in Sept. told my parole that he was a homicide detective. That he was investigating me for the murder of Joshua Duncan and not to let me be re-instated. On record, on the recorder, they agreed to pay fine and Lt. Peak, jack up the 3<sup>rd</sup> degree to first degree from a few hundred dollar piece of junk trailer that was over 20

yrs. old, rotten, flat tires, no wiring,  
no fail lights he put a price  
value of 2,800<sup>00</sup> on his car, and  
tryed to get her to revoce me.  
She refused. She had talk to the  
people who witness the sell I  
had produce the bill of sell. and

truth. I did not steal the trailer  
well, Lt. Peck went around lying on  
me, telling citizens of people I  
murder my bro-n-law, I murder  
Josh and that it was his job  
to put me back in prison. my  
bro-n-law was not murder, he died  
of a natural heart failure attack  
Josh was not found until Oct  
24<sup>th</sup> 2011, his dead body on a

secure justice piece of real estate  
properly. There was plenty of

his body. For instant, 7 human  
hairs on his body, was not his own.  
pieces of clothing, Lt. got over a  
100 hairs off my head from a court  
order. DNA test 4 times 2 by  
AI. One by MD. Then FBI. all  
4 result was 100% was not my  
hair. No link what so ever was  
attached to me. So, what does Lt. Park  
do. He totally disregarded all the  
factual evidence, all the other prime  
suspects, and ~~the~~ fabricate a story  
that the movie people couldn't think  
up. In 2009 Jason & Tiffany Norris  
was sent to prison for drugs. His  
mother, Regina Norris was awarded  
legal custody of their 3 kids. In

with all 3. So, June of 2011.  
She ride a bus now. Pick up  
Chance Morris, who is 3. Carry  
him back up to Chicago, Ill. The  
neighbor has a b view security  
surveillance video camera. 2 views  
catch part of Regena Morris  
drive way and front porch. So,  
the proof is available to support  
this truth. When his mother -  
Tiffany McCannon Morris get out  
of prison. She call for her son in  
late Nov. 2011. He is brought to  
her. She knew he was there by  
talking with him and them by phone  
in prison. She testify that on April  
2011 24. Peak come knocking on  
her door. That he wanted to talk

I should be back in prison for the 1979 case. The means to them, did not matter. Does not matter today. They celebrated their victory with drinks, and got their promotion, pay raise, awards and such.

I am asking your viewers to both pray for them, for me, to help collaborate the supporting truth. That Phonce Norris was not in the state of A/D. That the Lt. made up the story. and visit in the air condition room.  
 Allow 2 visit a month. Coming on  
 2 1/2 yrs. here. Letters be great too.  
 Love to hear from Christian people  
 from all over. Can't write folks over  
 sea, only have so many food meal  
 trays to sell for stamps to write  
 the courts, and even though 90 to 95%  
 of my own family believe the lies and  
 don't write me. I still write them.  
 Some I've sent ~~over~~ <sup>dozens and dozens of</sup> ~~100~~ letters  
 in the past 7 yrs. almost no reply.  
 Still I love them all. I under  
 stand the horrible ~~disgraced~~ disgraceful  
 shame Lt. Peck burn on me to get  
 cheap in life. Still I am totally 100%  
 innocent. Told the judge I was, told  
 family, hometown, everybody who'll  
 listen. I am wrongfully convicted. I  
 am innocent!! Please help where & how you  
 can, ~~speak~~, ask me the questions you  
 think I should response to. We'll get  
 back to my appeal later on in our  
 relationship. God bless. I hope to  
 cover all this on air tomorrow. If  
 not, I'll mail it to you for you to
