

Dear brother Will,

the rattle snakes. Having grown up in Iowa and never lived in areas where rattle snakes are common, I have had little experience with them. In NE Iowa, where we used to go hunting in timber often, there were timber rattlers, but I only ever saw one. He was a large thow compared to those in your country short. He was stretched out on the road as he had been hit by a car and killed earlier. They are very shy and hardly ever seen.

Your Tia's run in with the rattle snake was certainly a painful experience for both of you. Your application of the "ozone" to the wound was certainly a good idea. The extra oxygen definately promotes healing. Dana and I have long been strong advocates for hydrogen poroxide. The 3% one apples to wounds and the 35% food grade that one takes as a dietary supplement, 10 - 12 drops each day in 12 oz of water, juice, etc. I recommend tomatoe juice with a pnch of cayenne pepper and a squeeze of lemon juice to eliminate any unpleasant taste. 
