

AFFIRMED DECLARATION OF PF LAZOR

I, PF Lazor, declare and affirm that the following is true and correct, as factual evidence personally known to me:

1. On **November** 6 or 7, 1984, a prison guard at CMC prison named R.P. Petersen (or Peterson), without cause or provocation, lunged upon me and severely brutalized me, almost breaking my neck. There is or was a medical chrono and other documentation in my prison medical and/or C-files concerning this, though much downplayed as to the severity. I learned shortly thereafter that Petersen had a history and a "jacket" well-known to CDC staff, especially in the upper supervisory levels, of unprovoked, very violent brutal assaults on prisoners, as a sort of addiction or actual addiction. I learned Petersen had been repeatedly denied promotion to sergeant level for this reason.


2. Hours after the above-said battery incident, Petersen was informed by RVR staff that I was a prolific litigator against CDC staff for acts of severe misconduct. Various guards threatened me with murder if I were to file a lawsuit or otherwise attempt to expose the battery by Petersen, telling me that these threats came from Petersen via them.

3. Petersen himself, and many other guards in his clique, came to me and personally told me repeatedly for ongoing days, weeks and months, that for every "602" (staff complaint or CDC complaint) and legal action that I would file in prison, they would see to it that they would have an equal amount of rule violation reports (CDC-115s and other negative conduct chronos) filed against me, **and specifically cause me to be denied parole for the rest of my life** by these false reports. They acknowledged they would cause this among a vast spectrum of prison employees at any institution I might be in within CDC for as many years or decades as I would be alive. I'd been told the same thing and similar things by other CDC employees, mainly guards, over the ensuing years, who I believe were not connected with Petersen and his clique. Shortly after this incident and these staff promises, I began getting many false and fabricated Rule Violation Reports (RVRs) and other negative chrono reports written against me. (Up to this time, I had no RVR guilty findings that I'm aware of). This has continued to be the norm for my life in prison for the past 22 years, while I have not been breaking any rules nor acting with misconduct whatsoever, while being the highest and best model prisoner that is possible for any man in CDC. This campaign has lulls, especially after I transfer to a different prison, until staff there receive phone calls that I'm personally aware of, passing the baton to the new staff, to carry on the same retaliation campaign, which they do (and also, when certain staff from the past who were involved in this campaign, come to the next prison I'm at -- that or the phone calls re-generate the campaign, and it escalates until I am transferred again, almost always).

4. As evidence that the above statements are not merely self-serving, I am attaching as part of this declaration, as exhibits of a sort, starting with the next page, a "mistaken" negative chrono, followed by eleven sworn declarations from independent, impartial prisoner eyewitnesses who have no reason to lie for me, attesting to the retaliation campaign in all its uniqueness.

I declare, subject to penalties for perjury, that the foregoing is true and correct, and is personally known by me to be true.
