## CITIZEN GRAND JURIES

(goes with Klayman article sent snail mail on 08 AUG.)
Dear Brother Rudy,
Recently, Patriot Attorney Larry Klayman put out a flyer on the right of normal citizens to impanel a Grand Jury separate from the PUBLIC OFFICE MAFIA, similar to the procedure described in one of Pat Shannon's books. Klayman cited U.S. v WILLIAMS, 504 US 36 (1992), written by the Late and Great Justice of the U.S. Supreme Court, Anton Scalia. Relevant Supreme Court text to explain Klayman's article is as follows:
"The Grand Jury is a constitutional fixture in its own right. The whole theory of its function is that it belongs to no branch of government, serving as a kind of buffer or referee between the government and the People. Although the Grand Jury normally operates, of course, in the courthouse and under judicial auspices, its institutional relationship with the Judicial Branch has traditionally been, so to speak, at arm's length. Judge's direct involvement in the functioning of the Grand Jury has generally been confined to the constitutive one of calling the grand jurors together and administering their oaths of office". U.S. v WILLIAMS, 504 US 36, 47 (1992).
"Unlike a court, whose jurisdiction is predicated upon a specific case or controversy, the Grand Jury can investigate merely on suspicion that the law is being violated, or even because it wants assurance that it is not. It need not identify the offender it suspects, or even the precise nature of the offense it is investigating. The Grand Jury requires no authorization from its constituting court to seek a Grand Jury Indictment. And in its day-to-day functioning, the Grand Jury generally operates without interference of a presiding judge. It swears its own witnesses, FED. R. CRIM. P., 6(c), and deliberates in total secrecy". WILLIAMS, 504 US at 48.
"The Grand Jury cannot compel the appearance of witnesses and the production of evidence, and must appeal to the court when such compulsion is required. And the court will refuse to lend its assistance when the compulsion the Grand Jury seeks would override rights accorded by the Constitution or even testimonial privileges recognized by the Common Law. Even in this setting, however, the court insists that the Grand Jury remain free to pursue its investigations unhindered by external influence of supervision so long as it does not trench upon the legitimate rights of any witnesses called before it". WILLIAMS, 504 US at 48.
"The Fifth Amendment's constitutional guarantee presupposes an investigative body acting independently of either prosecuting attorney or judge". WILLIAMS, 504 US at 49.
"Any power federal courts may have to fashion, on their own initiative, rules of Grand Jury
procedure is a very limited one, not remotely comparable to the power they maintain over their own proceedings". WILLIAMS, 504 US at 50.
"The Common Law of the Grand Jury is not violated if the Grand Jury itself chooses to hear no more evidence than that which suffices to convince it an indictment is proper". WILLIAMS, 504 US at 53.

Justice Scalia took the Grand Jury status back to ORIGINAL INTENT of the founding Patriots. Generations of Communist Judges had unlawfully legislated to weaken the ORIGINAL INTENT of Grand Juries. The Communist's unlawful Judicial Legislation is contrary to Article I of the U.S. Constitution which says:
"All legislative Powers herein granted shall be vested in Congress of the United States which shall consist of a Senate and House of Representatives." U.S. CONST., ARTICLE I.
Any law or judicial ruling contrary to Legislative Intent of the Founding Fathers is invalid upon inception. MARBURY v MADISON, 5 US 137, 180 (1803). THEREFORE, Justice Scalia corrected decades of left-wing judicial abuses.

The raises question if alleged "accidental" death of the Honorable Justice Scalia was in truth an accident when considering the ongoing intended COUP D'ETAT by RADICAL LEFTISTS since November 2016.
