Re: Letter of Appointment of Honourable Chilcotin Plenipotentiary to the United States of America and the United Nations for the State of the Chilcotin, for the limited purpose of freeing Chilcotin Ambassador Michael W. Parsons and his wife Patricia Parsons, in view of furthering recognition of Chilcotin sovereignty and Chilcotin National Congress authority.

By the power invested in me by the Creator, I Grand Chief Stanley Stump Sr., of the Chilcotin National Congress and hereditary heir of the T'silhqot'in Territory, in accordance with and under the *Constitution of the T'silhquot'in Nation* section 3(2), do hereby appoint you and delegate to you the powers and duties of Honourable Chilcotin Plenipotentiary in the United States of America, commencing immediately this day, under the guidance and direction of the Honourable Grand Chief Stanley Stump Sr., and/or the Honourable Ambassador and ACJ Michael W. Parsons. You are to report progress of your duties at least once a week to the Grand Chief and Ambassador Parsons.

PLEASE BE ADVISED that the State of the Chilcotin has filed an Application with the International Court of Justice against you, against the State of Nebraska, against the Nebraska judges, against all law officers and against the Nebraska correctional facilities involved with the kidnapping and detaining of Chilcotin Ambassador and ACJ Michael W. Parsons in contempt of the attached Universal Supreme Court orders, attached hereto. Relief sought will include jail time for those who participated in the kidnapping, prosecution and detainment of Ambassador Parsons as well as for any future judges who continue to deny Ambassador Parsons's release.
