Dear Secretary-General Guterres:

Re: Chilcotin State's Application to the International Court of Justice; Chilcotin's Preliminary Brief to the UN Security Council; Letters to President Soliz and to Former UN Secretary-General Ban Ki-moon & the General Assembly

Please find attached State of the Chilcotin's letter dated June 20th, 2016 to Former United Nations Secretary-General Ban Ki-moon regarding, "Declaration of a New Country Called the 'Chilcotin' Upon Sovereign Tsilhqot'in Territory" which was excepted by your predecessor and the General Assembly in 2016 without objection.

Also, please find attached "Preliminary Brief to the UN Security Council" dated October 4, 2018 and corresponding letter to President Soliz dated October 20, 2018.

We write to inform you that the requests outlined in letter dated October 20, 2018 to President Soliz did not receive response to the contrary therefore the terms outlined in items #1-6 of the same are deemed to be the recommendations from the UN Security Council to you and the General Assembly pursuant to Article 35(2) of the *Statute of the Court*, Article 93(2) of the *UN Charter* and Article 3 of the *Montevideo Convention on the Rights and Duties of State*.

We trust that the following 6 recommendations from the UN Security Council will be circulated throughout the General Assembly under your direction:

1. The United Nations General Assembly recognizes the sovereignty and independence of the State of the Chilcotin;
2. The Honourable Chilcotin Head of State Grand Chief Stanley Stump Sr., is to be given a seat at the UN General Assembly and be permitted to address the UN General Assembly along with his Honourable Chilcotin Ambassador to the USA, and the Honourable Chilcotin Minister of Justice in person;
3. The Chilcotin Application filed at the International Court of Justice is to be placed on the list to be heard by an ad hoc judge chosen by the State of the Chilcotin and all named Chilcotin representatives party to the Chilcotin Application are to be provided save, paid travel to the Hague;

4. The State of Canada is to be sanctioned as the UN General Assembly sees fit until the State of Canada withdraws all its armed forces and law enforcement, government and judicial entities as well as all its representatives from the State of the Chilcotin;
5. The State of the United States of America is to be sanctioned as the UN General Assembly sees fit until diplomats Chilcotin Ambassador to the USA and his wife are released from custody and returned to the Chilcotin Embassy to the USA in Tennessee with all their belongings;
6. UN peace keepers are to be deployed to the State of the Chilcotin to take orders from Grand Chief Stanley Stump Sr;

We thank-you for your prompt attention to these matters and should we not hear back from you to the contrary by January 21, 2019, it will be deemed that the United Nations General Assembly has voted to uphold the recommendations of the UN Security Council as per the above 6 terms which will be noticed to the International Court of Justice and the public.

We kindly request all further communications be done via diplomatic channels as is appropriate.
