20 Questions For Maria

Dear Rudy,

I hate infighting. I hate saying negative things about people. I can't afford to be sucked into a mud fight. Not with how many haters are already gunning for me. There are positive, constructive, worthy endeavors that urgently need my attention. It's those things that I want to focus on. Not Maria, Richard, and The Board. But there are two reasons I can't just let this slide: First, I put my name on the line and asked donors to donate to me. So now I feel responsible if any of that money gets lost, wasted, or stolen. Second, I need those funds for their intended purpose - my legal battle - so I can get out and be a father to my children.

I know you like Maria. I tend to like her too. She's likeable! But she needs to answer the following questions:

1. Did Direct Mail send out fundraising letters from Maria Rensel, with her picture, written by her, asking donors to donate to her and her organization, and pledging to do her very best to help Schaeffer Cox get out of prison?

2. Were those letters from Maria a total flop that no one would donate to?

Rudy, I think a doxxing is cool. However, if you disagree, that's not mine. I'll respect what you

4. Were the letters from Schaeffer Cox a huge blockbuster success that got an avalanche of donations from the very same donors who had chosen NOT to give money to Maria and her organization?

5. Do you think it would be morally dubious for Schaeffer Cox to ask people to donate to him, then turn around and give that money to the very people the donors had refused to donate money to previously?

6. Can Maria and her organization produce any donors that say "It was my understanding that the money I donated to Schaeffer Cox would be held and controlled by a Board of Directors, whose identities are in secret even from Schaeffer, and who are 'fielectaries' who spend the money however they vote to, on whatever they want, and that none of the money would be used by Schaeffer Cox to hire attorneys or pay court costs?"

7. Can Schaeffer Cox produce banker boxes full of cards and letters from donors who believe they donated to Schaeffer Cox, and are assuming he got the money and can use it as he sees fit?

8. If the donors didn't give the money to Maria and her organization; and if Schaeffer didn't give the money to Maria and her organization; then what gives Maria and her organization the right to take the money and spend it however they vote to?

9. Isn't "taking someone else's money without their permission" the very definition of theft?

10. Is it true that taking someone's money, after they told you not to, so that you can put it in a trust that you control, that's supposedly for the benefit of the person you just robbed, is still just stealing money, even if you and your friends "vote" to do it?

11. Can Maria point to any law to back up her claim that if Schaeffer has control of the money donated to him, the government will be able to come in and seize it; leaving Schaeffer in the horrible predicament of having no money to fight his case with, and being stuck with a public defender, and not even having enough money for filing fees to fight pro se?

12. Can Maria and her organization see that they have created the very scenario they claim they are preventing the government from creating?

13. What right does Maria and her organization have to shut down the FreeSchaefferCox.com website that Angela Faire built and put up long before Maria and her organization came along?

14. What gives Maria and her organization the right to hold the donor list hostage, not let Schaeffer use it, and in fact demand that he rent it from Maria, when it's a list of donors who donate to Schaeffer and refuse to donate to Maria?

15. What's wrong with just transferring Schaeffer's money where he wants it transferred, leaving the website up, handing over the donor list, and respecting Schaeffer's right to decide for himself how to fight his case and who to trust?

16. How much money was donated to Schaeffer, all total, before mailing costs are taken out? What's the gross? How much money did Maria and her organization take? How much have they spent? What has it been spent on? Why would you try to keep this information from Schaeffer if everything's on the up-and-up? Is it because you took

the money without his permission and spent it on stuff he wouldn't approve of if he knew? Do you think that's moral? Do you think you'd like to be treated the way you are treating Schaeffer? Would you feel disrespected? Would you feel bad every time a donor asked you where their donation went?

Even if you believe your own B.S. about being statutorily and trustees and using the money for the benefit of the guy you just stole it from; wouldn't you still have a conflict of interest now that Schaeffer has said he's going to sue you to get the money back so he can be able to take 16,000 dollars in the eye again? As soon as he gets out of prison or has money to fight with, you're going to lose everything. So wouldn't that mean that the best thing for you right now is for Schaeffer to lose all his appeals, and stay in prison broke and helpless? Is that why you took down the website? Is that why you don't want people donating to his campaign account?

18. If you say you believe in liberty and letting people make their own choices, keep their own money, and not be robbed and coerced by city counsels and boards who vote on how to control people; then why wouldn't you respect Schaeffer's choices, let him keep his own money, and not be coerced by the votes of your little body politic? You feel violated when city council decides to help you against your will by voting to put flouride in your water; but how is that any different than Maria and her secret Board voting

to help Schaeffer against his will by shunning him while stealing his money and spending it on things he doesn't approve of?

Do you think man is God, and that by getting a board of several man-gods together and performing the ritual of voting, you can exempt yourselves from the moral constraints - like don't take other people's money without their permission - that would otherwise apply to all individuals? Do you really believe you can turn wrong into right by baptizing it with a vote? Do you think that the by-laws of your secret board that say you can rob Schaeffer, override Schaeffer's right to not be robbed?

20. Do you think Schaeffer has a legal and/or moral right to defend himself from Maria and her organization? If you've been asked nicely to stop, don't you think you should stop? Or do you feel pretty safe to step on a man's neck, so long as he's in a cage?

Rudy, you need to get Maria to talk to you and explain her answers to these 20 questions. If she won't do the right thing - the moral legal and ethical thing - then you need to read this letter and all my other letters openly to all my supporters. And you also need to DXX her, IMO. Weigh the ramifications of a well deserved DXXing against an undeserved 27 years in prison, or someone's \$25K check Maria stole from them. (true story)

I know you like maria. But she has a lot of explaining to do.

I've attached an IM thread between Judy Lee and Maria that sheds light on Maria's motives. Judy asks why Maria and The Board want give me my own money to fight my appeal. Maria says that they voted against it. Then she says "it would have been a whole lot less work to ask for the bill than to deal with the appeal." Judy asks "what bill?" Maria then says "maybe he (sorceror) can explain what a 'bill' is."

Let me explain. Maria really truly believes that if you refuse to "go into dishonor," and instead just accept the "charge" against you, that after the whole appeal is ruled no-contest, you can ask the judge for a "bill" and he "has to give it to you." At which point, you write "Accepted for value" on the face of the "bill," hand it back to the judge, and he then just lets you go free because you "paid the bill."

Maria tried to convince me to dismiss my one shot at appeal and try out this theory. I explained to her that I was in a prison full of "experts" who tried and failed with this kind of stuff. I went on to explain to her that these kinds of

theories are quite often the product of disinformation campaigns run by the FBI to get patriots to not fight phony charges they could otherwise beat, and to make patriots look silly and off-putting to the public. It's how the Joint Terrorism Task Force (which Trump just discontinued, thank God!) was destroying the patriots and keeping them from developing real solutions to tyranny.

I also explained that all four of the related Polar Pen cases had been thrown out on appeal for Brady violations identical to the ones in my case. I've never in my life met some one who has "paid the bill and walked out." So that's a 100% failure rate on Maria's "check please" approach, and a 100% success rate on Brady violations out of the Anchorage US Attorneys office.

I told Maria to test out her theories on seatbelt tickets, not on 27 year politically charged Federal conspiracies. I told her it was my choice to follow the well beaten path on Brady issues and get out that way. But Maria did not respect my right to make my own well informed decision. She wanted to test out her theories on me, with or without my consent.

I know the money Maria and her Board took from me isn't going to fight my winnable appeal. That much is for sure. But what I suspect, is that she's blowing the money she stole from me and the donors on research and development of these theories. She knows the donors and I would not approve of this. That's why she's trying to be all secret and "autonomous." And I'd bet my right hand that she is surrounded by FBI informants spoon feeding her feelgood silver-bullet legal theories that she WANTS to believe. She thinks she'll starve me out, then I'll try her ideas.

The behavior of Maria and her secret Board is gravely serious, extremely disrespectful to me, and woefully misguided. Because of the seriousness of the damage it is causing, almost anything short of physical violence would be justified to stop them. Certainly being flooded with calls, texts, emails and letters admonishing them to stop stealing and lying and hiding is appropriate. If a good cleaning is in order - so be it. They have no right to be comfortable while robbing a prisoner who can't fight back. What they are doing is morally wrong. And they need the world to shoot it in their face until they admit it and stop. Please stand up for my rights. For me, since I can't from in here.

The disrespect and betrayal by Richard, and Maria has been the 2nd most painful wound I've received over the course of this 7 year

nightmare! It hurts worse than being lied about in the press and called a terrorist. It hurts worse than sitting through a show trial then getting dumped in solitary for years. It hurts worse than losing all my homes and land and wealth. It hurts worse than having my home raided and trashed by secret police. It hurts worse than informants like Bill Fulton and Aaron Bennett continuing to spin a web of lies, and plant rumors, like Johnny Appleseed all over town. I expect that from them. It's Bennett's job. That's what the ATF pays him to do. So I don't like it, but it doesn't wound my heart. It's not personal.

What Richard and Maria are doing to me burns deep. I really loved them. I opened my heart up to them. And they cut me in a spot that can't be drawn back like a hurt hand. They are making me bleed in my core. In the pit of my chest, where there is no retreat.

Even being tortured by the most vacant hearted Nazi mad scientists in the world, in the most stark and dehumanizing horror movie political prisoner dungeon in Amerika; even that is less painful and less demoralizing than what Richard and Maria are doing to me right now.

When I lost my wife, it didn't hurt this

bad. And I worshipped that girl. She was so woven into my soul that we'd dream the same dreams at night, then talk about them over breakfast. But when I lost her, it wasn't an act of betrayal. It was just that she couldn't take the years of separation and the decades of uncertainty. It was like I died, then from a distance, watched her grieve the loss and then heal and move on. That was pain. But it was the pain of misfortune, not the pain of betrayal.

The way Richard and Maria are treating me hurts worse than all of that. The only thing I have left more peace over is watching my children cry and suffer because the Feds tore their happy home apart. Nothing will ever hurt me more than that. Nothing. That's why the Feds withhold contact with my children to punish me. They know it's my most tender spot. And nothing is sacred to the sleep-walkers who run this death factory. Nothing.

So that's where we're at. Richard and Maria won't even accept my calls or emails. Their hiding because they're guilty. They can't even hear my voice, much less look me in the eye. So I need all of you to plead my case to them directly.

The question isn't "will Maria pay the bill theory work?" or "what do the by-laws that

that Maria and her secret Board wrote for themselves say they should do?" or "did they mismanage money or not?" None of that matters, because there's only one real question:

"If the donors didn't give the money to you, and Schaeffer didn't give it to you, then what made you think you could just take it without permission?"

I've told them over and over that I don't want them involved in my affairs in any way. I've told them to transfer all money, the rights to the donor list, the website, and everything else to Angela Clemons. I trust her and I don't trust them. That's my decision based on how people have acted. I get to decide who I trust. It's not up for a vote. My life is not a democracy. It's wrong for Richard and Maria to mistreat me just because I'm in prison and they think I can't stop them. I need all of you to stay on top of those two, and not let up until they turn me loose and transfer everything to Angela Clemons like I've asked.
