

IMMEDIATE EMERGENCY ORDER TO STAY WRIT OF EJECTMENT



The court stated in its recent Order Denying Second Motion For Stay that, defendant did not demonstrate that a motion for stay was filed in the circuit court and denied by the circuit court. However, defendant did if fact, demonstrate that a motion for stay was filed and denied by the circuit court in the "Motion To Reconsider Order Denying Motion For Stay," that defendants filed on December 19, 2018. In that Motion, defendant submitted 14 exhibits which demonstrated that defendant filed the motion for stay and was denied by the circuit court and defendant subsequently appealed to this court from the orders and judgments of the lower court. In that motion defendant specifically outlined the judgments and orders that defendant was appealing to eradicate any misunderstanding as to what the defendant was appealing. This has caused immeasurable harm to the defendant, because the sheriff has showed up to the defendant's home stating they will evict the defendant in a week, if defendant do not show an order from the appeals court regarding the appeal and that the ejectment is stayed pending appeal.

WHEREFORE, defendant is requesting an immediate emergency order staying the ejectment so that defendant will not be removed from her home under force of guns by the sheriff's office.
