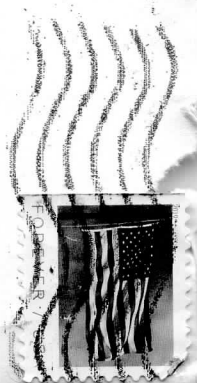

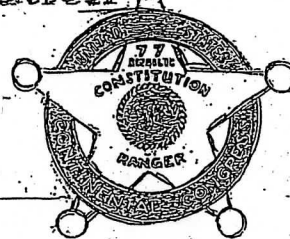

Dear Rudy and Erich

We give you our blessings with love because you both have given me the knowledge of knowing that there are two people of my brethren who have kept the faith.

We have grown with the gifts of God the guidance of our Brother in Christ. We are stronger than ever as we gain in humility and wisdom as our knowledge grows. I just woke this morning to the author of the book "Silence of The Shield" (Unconscious Bias) which adds another chapter in my Book of Life. I understand the works of all Bullies and one of the main tools of the Deep State is Unconscious Bias with Deliberate Indifference. Which is an easy release for most people that have a champion on the street or getting my material to someone in government that cares. I have not had that luck to date, but I will keep trying as I am able.

It appears that most people are afraid to try. I get it. That's why I have shut down all my contacts over 700 hundred of them in the eighteen years of Administrative Abuse. I was out of exhausting all remedies by 2019 when I had a major stroke. I have continued

my studies into the DEEP STATE as I grow in comprehension of my works but find few who "get it." I keep studying - writing - and mailing as I can but it appears no one gets my mail. I never get replies.

You mentioned in your last letter that Erin could read some of my work on your site. If that offer is still open I have enclosed a couple of samples of my work. One of my main problems is I am nearly totally blind. About 40% left in my left eye. My right eye has been gone since June 20, 2022. I fear that if I don't get them fixed this year, I'm done.

The more I learn the more I see it working. That's why I was sent to this Kentucky "Punishment Facility." They convinced me to take a drug called Flowmax and after two pills I had a mini stroke and another one, each week for five weeks. Plus when Kings Medical Emergency Hospital gave me an injection of something for a cat scan. When the injection fluid hit my kidneys, my testicles and bladder simultaneously exploded in painful impact like a bullet exploding. My pain was so excruciating that I was on the floor for the next 32 hours until I finally got a catheter - urin Bag. It is still my prostate and is still not fixed. The Flowmax pills was their prostate treatment and I almost died with 5 strokes. Remember! I am also an ex E.M.T. and Holistic Healer, but denied my own healthcare. They are going to kill me if I don't get help.

There is **NO ONE** within the Federal Private B.O.R. that are qualified or intend to CORRECTLY assist a TRUE informed Private Sovereign Citizen.. Also added to this one incident was my left testicle swelled to the size of a baseball and when I went to medical I was given a disciplinary punishment and put into the SHU. For one week — placed in the R-unit for daily Administrative abuse and loss of commissary for (combined) over a year. (I have no funds anyway). and this unit is a drug and smokers punishment unit. with no air conditioning, which they ^{dis}allow with plausible deniability. All B.O.P. Prisons have no oversight **NONE!** and each facility runs their own in House Schemes. Depositions need to be done: Pamela Bondi ^{U.S.} A.G.

I have asked on-the-record to speak to DOJ./BOP. Internal Affairs and Inspector General from the Team and every resource available to the warden — to BOP Region — To BOP Central, the Chaplin — The psychology and I ever contact The Sex Offender (P.R.E.M.) program. to the men and women. with sneering indifference while I am silently screaming on the floor, For 32 hours There is **ABSOLUTLY NO ONE**. When I ask, in agony why (over eighteen years) They won't help They just reply "you're in prison or you shouldn't have come to prison Followed by other jeering remarks.

these incidents of abuse are daily but they are not the most damaging Malnutrition is. I am tired and hungry most of the time. Very few of us speak out about anything because they are afraid to be noticed.

Too much estrogen in the water and plastics.

It is Monday March 21st 2025 8:am. I will put with this letter something Erin could do 2 1/2 hr. Show with and put this in the mail tonight.

I should be on the street working as a Ranger.

49.) That governments are instituted amongst men bearing the sole purpose to secure man's individual, private, natural, sovereign rights...

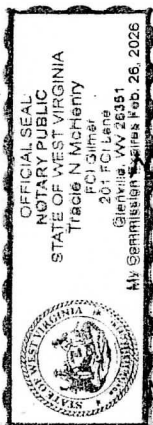
50.) That the Affiant accepts nunc pro tunc, ab initio the oath or affirmation of all fiduciary oath-bearers under the penalties of perjury and treason...
