Dear Secretary,

This letter is in regards to an appeal from two disciplinary write ups that I mailed to you on 6-28-21 which I have not received confirmation that you received my appeal with the attached exhibits to prove my innocence. Another inmate by the name of David Sceal mailed his appeal out on the same day as mine from confinement. The reason for my follow up is because you have a mail clerk named C. Tharp that is illegally throwing my legal mails away or returning some of them back to sender for bogus reasons. In order to ensure that you receive this letter, I emailed a copy to a friend to print it out on her end to mail to you because the mailroom clerk (C. Tharp), continues to violate the law by not sending out or delivering my mails to me. For the month of June, C. Tharp denied the delivery of 20 plus envelopes (9x12 inches white envelopes) of my legal and regular mails, in which the sender had only received two of them to date. The sender has made copies of what C. Tharp had done to my mails before sending it back to the sender, which clearly showed that C. Tharp opened all my legal mails outside of my presence, which is against federal law.

I sent two legal mails to my appeal attorney, Ms. D. Dotson on 7-6-21 and 7-9-21. I spoke with Ms. Dotson on July 15th, and she confirmed that she did not received any of these letters. These two legal mails were of utmost importance for my appeal process, as they are to be added to my court documents. Since Ms. Dotson did not receive these two very important legal mails, my appeal case may have been greatly compromised.

I am in the process of filing a federal law suit against C. Tharp. I am seeking federal criminal charges to file against her for mail tampering, deprivation of rights, conspiracy against my rights and racial discrimination.

I will be sending all future letters through Common Law Office of America, to ensure safe and certainty of delivery and receipt of all my mails, until I am transferred from this facility, and/or when C. Tharp is fired and felony charges filed against her. I have already written to the FBI headquarters in Washington, D. C. and a copy of this letter to the Governor of Florida, which I am waiting for their response.

Thank you in advance for your cooperation and consideration in this most exigent matter.
