## Administrative and Public Notice

KNOW ALL MEN BY THESE PRESENTS this notice is to inform you of the existence, authority and purpose of the United States Constitution Rangers (hereafter "Rangers").

The founders of our states, commonwealths, republics and freeholds and the authors of our state and federal Constitutions (hereafter, "Constitutions") wrote that all rights are unalienable and came from our Creator (God) to each of God's children; we, the Sovereign Citizens. The unanimous Declaration of the thirteen united States of America (hereafter, the "Declaration of Independence", or "Declaration") clearly states the following concepts. People create governments. Since the created owe their existence to the creator, governments must be accountable to, and serve at the pleasure of the Sovereign Citizens. Should governments become tyrannical, should they unduly burden and enslave, the Declaration clearly explains that it is the duty of the citizens to see that such government is altered or abolished. The Declaration states that this is not just an option; but that it is a prerogative and solemn duty of the Sovereign Citizen. In delivering the lead opinion of the Supreme Court in *Yick Wo v. Hopkins* 118 U.S. 356, 370 (1886); Justice Mathews wrote, "Sovereignty itself is, of course, not subject to law, for it is the author and source of law; but, in our system, while sovereign powers are delegated to the agencies of government, sovereignty itself remains with the people, by whom and for whom all government exists and acts." We the people are the Sovereigns and we receive our rights from God, The Creator, and then we created Constitutions to form our limited governments. With that same authority and responsibility from our Creator, we the Sovereigns have created the United States Constitution Rangers to watch over our creations (governments).

The Rangers protect and defend the Constitution Republic of the United States of America (hereafter, the "Republic") and ensure that government servants comply with the Constitution for the United States of America (hereafter, the "Constitution"), the highest law of the land (Art. VI, Sec. 2). Sovereign Citizen Lawrence Robertson re-organized the Rangers to defend the Republic and the Citizens of the United States of America (hereafter, "Citizens"). With the aid of Congressman Eldon Rudd the charter of the Rangers was recorded in the Library of Congress in 1980, Copyright-Registration # TXu 42-453, establishing the Rangers as an organization created by Sovereigns to police the offices of public trust.

Rangers are sworn to protect and serve the Constitutional Republics of the Several States, the Constitutional Republic of the United States of America and the Citizens thereof. The jurisdiction of the Rangers includes all 50 states of the union. Rangers pledge to defend our republican form of government provided by the Constitutions and to protect the rights of the Citizens as granted by God, The Creator, and as enumerated in the original Bill of Rights. When called upon by the Citizens, the Rangers aid in the defense of their rights as "Officers of Peace" (Isaiah 60:17).

The purpose of the Rangers is to remind all Citizens that the Constitution for the United States of America is the supreme law of the land, and to investigate and expose that which is repugnant to our Constitutions. Rangers promote the original meaning and intent of the original Bill of Rights, and work to restore public awareness that the Constitutions limit the size, power and scope of governments. Rangers seek to hold government servants accountable to their oaths of office. The Rangers office is an "Office of Honor" with the inherent power and authority of policing the created governments, and must be respected as a legitimate and lawful investigatory body. Rangers are not law enforcement agents, per se. Supreme authority is Ecclesiastic by Exodus; Chapter 18:21, 22, 23.

When corruption is found, when an unalienable constitutional right is violated, or when an oath of office is ignored or violated, the Rangers will inform the public and other bodies including but not limited to, District Attorneys, U.S. Attorneys, Sheriffs, and other government servants, responsible for investigating and/or correcting such matters. If these agencies fail to act swiftly and appropriately, or are themselves in violation of their prescribed charter, the Rangers will act within our powers to lawfully correct the problem.

Our governments only exist to serve its creator The People, not to prey upon its creator or to serve themselves. Government servants must act lawfully. They may not unduly enrich themselves or their offices to the detriment of Citizens. They may not unlawfully act to expand the powers of their administrative, executive, legislative or judicial roles. Since unlawful acts by government servants are rampant, the Rangers are needed now, more than ever, to expose threats to life, liberty and property. The God given unalienable rights of life, liberty and property are the birthright and inheritance of Citizens from our Creator and are guaranteed to Citizens by our Constitutions. These rights precede and are superior to government. These rights are not subservient to any actions by any government agent, servant or functionary. These concepts are all clearly defined in law, and supported by Supreme Court rulings too numerous to mention here.

The Rangers are not supported by any government budget, and this allows complete independence from financial conflicts of interests and corruption. Reported violations will be investigated with the highest standards of fairness, impartiality, credibility and integrity. Every Ranger has been commissioned by the Rangers and taken an oath to uphold and defend the Constitution from all enemies both foreign and domestic. Rangers may be recognized by their uniforms, badges and/or identification cards, all of which bear the logo and name of the United States Constitution Rangers.

This three page document satisfies our legal requirement to notify you, our servants.

It is necessary that you inform us in writing if you have any questions or concerns relating to this Administrative and Public Notice. If we do not receive a written response from you within 30 days, we shall presume your recognition and acceptance of this notice, and dissemination of it's contents to your subordinates, and any other interested parties over which you may have influence. We recommended that this notice be posted on bulletin boards and wherever your policy requires. The Rangers welcome the opportunity to speak with public or governmental agencies for training purposes.

# A tense 8 months, a quiet ending

**Tax protesters: Federal agents infiltrated Ed and Elaine Brown's hilltop compound and won their trust.**

PLAINFIELD

**B**ECAUSE IT ENDED so peacefully, it's easy to forget how tense the eight-month standoff was leading up to the October 2007 arrest of Edward and Elaine Brown at their large compound in Plainfield.

On the internet, Ed Brown, now 76, was a hero to the "tax deniers," those who maintained in a convoluted argument the federal Constitution did not require payment of federal income tax. Elaine Brown, now 78, was a respected dentist with a thriving practice and office in a West Lebanon shopping plaza the couple owned.

Steve Morier, the U.S. marshal at the time, knew better because while he grew to actually like and respect the Browns, they were attracting some very dangerous, potentially violent followers.

The acting secretary of the VA visits Manchester today, but it's unlikely that he will address the recommended restructuring of the Manchester VA Medical Center, and with it veteran health care in the state.

Longtime VA insider Peter O'Rourke, who took over the role of acting secretary last week, should soon receive the recommendations written by the VA New Hampshire Vision 2025 Task Force, a VA spokesman said.

The recommendations say that specialty care needs to be beefed up at the Manchester center, but a full-service VA hospital is not needed in New Hampshire. The recommendations place emphasis on partnerships with existing New Hampshire hospitals and VA hospitals in Boston, Vermont and Maine.

The recommendations have drawn criticism from Sens. Jeanne Shaheen and Maggie Hassan, who have long called for a full-service hospital in the state. But they won the backing of the VA's Special Medical Advisory Group, a panel of outside experts that reviews VA recommendations.

They are now under internal VA review, according to Maureen
