

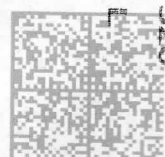

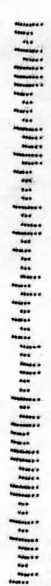

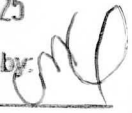

I know its been a while since I have written to you. I have been transferred twice since the last time we spoke. I'm currently in confinement for an officer lying and saying I disobeyed a lawful order to face the wall when he was unlawfully searching my legal mail without me being able to observe which is my right according to the law. My 2255 motion was denied by Kobayashi but I have appealed to the Ninth Circuit to show how many of my constitutional rights were violated which included Kobayashi striking all of my witnesses from the mainland from testifying in the middle of trial, continuing my trial over my objection 8 times and denying exculpatory evidence to be presented to the jury. I have enclosed a copy of the letter I sent to that child of the devil unit manager Shenesi Beard for writing me a bogus D.R. in 2023 (which was dismissed because I proved she was a liar) and subsequently she got fired and walked off the compound.

I really believe that I'm at the end of my unlawful incarceration and will soon be free. I want to help the others like me who are innocent to help free them. I believe I have discovered a way to finally free all of them.

Rosy wrote me and said you asked about putting money on my account but you can't do that because they have a bogus lien on my account for the tablet someone stole from me and they gave me a D.R. and charged my account \$129.99. I have since filed a lawsuit against the Florida Dept.

of corrections for the pier and other violations such as inhumane conditions, cruel and unusual punishment, deprivation of mail, withholding the tablets, unsanitary food and feeding practices just to name a few. I have been able to hold bible studies and have been able to bring a few souls to the light of Yahshua.

This facility in Suwannee is drug infested and the officers do nothing about it. Stabbings are a regular occurrence and the officers who see it happening turn their backs until it's over. The gangs are very prevalent and almost everyone carries a knife except me. I told them I refuse to carry a knife because my protection comes from Yahweh and not a weapon.

There are a few guys here that I have looked at their case and they are innocent. Can you send me a few of those cards that have the innocent people on there so I can hand them out to a few people.

Thank you for the work that you and Erin continue to do. We need more people in the world like you two. Take care my brother and hopefully I will be seeing you in bodily presence.

I have sat back and observed your behavior, deportment and demeanor towards the inmates and it is appalling to say the least. You black females especially, displays attitude that are egregious, ignorant and downright disrespectful for no justifiable reasons, except when you feel you can and can get away with it. I try to give you black people the benefit of the doubt because, you of all people, should know and understand that this system is disproportionately incarcerating black males at a much higher percentage than whites, and we already have the system of slavery that was implemented and carried on through the prison systems, to continue to enslave and oppress us. Just as in slavery that they delegated black women to keep the black men in line, and this is the same principle these racist prison officials have employed in the prison systems. It baffles me that you all don't see that you are being used as a tool of oppression, just like the house niggas in slavery, who did everything the oppressor told them to do to their own people.

The way you all carry yourselves is unprofessional, reckless and dangerous because it is apparent that you all are not cognizant that at any day can be your last day at work, if one of these inmates decides to take your life. With the alarming rate that these inmates are doped up on K2, does it ever occurred to anyone of you all that it only takes one inmate to assault you and your colleagues would not be able to respond in enough time to assist you and save your life. Just recently you had this idiot they call Swole who was high on K2 and assaulted a female officer. She was fortunate that other inmates came to her assistance or the situation could have been fatal.

You all expected that you will be respected, but respect is earned and not given. Every day, you all come in with these nefarious dispositions and seem to not be happy unless you are cursing at an inmate or just harassing inmates for things that are not in Chapter 33. You want inmates to follow rules and regulations, yet you all violate the rules daily. You females seem to think that its OK to punish the whole dorm because you are upset at a few inmates for not locking down quick enough or because someone's bed isn't made up.

I personally have never used any profane language or reveling remarks when addressing any of the prison guards. Neither have I violated any rules or regulations and yet, I am incessantly being locked down, being deprived of canteen and being prohibited to contact my family on a consistent basis because of the actions of others that you are making me pay for.

For those of you who just enjoy doing ignorant and asinine things such as:

1. Locking our doors to feed us and further delaying the delivery of the trays while they get colder
2. After 5 pm still trying to make inmates be in Class A's, which is contrary to chapter 33
3. Intentionally messing up count, to keep us caged in like animals, for 2 or 3 hours.
4. Cursing at inmates daily, in violation of Chapter 33.208.002(8)
5. Not running Canteen weekly, as required by Chapter 33.203.101(2)
6. Being grossly out of shape, in violation of Chapter 33. 208.002(3)(a), when you are supposed to be PHYSICALLY FIT.
