#### INTRODUCTION

This is the Court's decision regarding a Petition for Custody filed on January 3, 2006 by David Matusiewicz ("Father"), represented by Alfred Tarrrant, Esquire. Christine Belford ("Mother"), represented by Timothy Hitchings, Esquire, filed an Answer and Counterclaim on January 19, 2006. The matter is in regards to the parties' three minor children: Laura (DOB 5/31/02); Leigh (DOB 9/5/03); and Karen (DOB 7/13/05). At the hearing on February 6, 2007, the Court received documentary evidence and heard testimony from both parties, as well as from the following witnesses: Dr. Michael Bruno, Father's friend; David Wayne Phillips, a private investigator hired by Father, Lenore Matusiewicz ("Paternal Grandmother"), Dr. Samuel Romirowsky, who conducted a custody evaluation of both parties and the three minor children; and Dr. John Thomas Dewey, who is employed by the Brennan School, where Leigh formerly attended.

#### PROCEDURAL HISTORY

Prior to the hearing, the parties had been operating under an Interim Consent Order entered by this Court on February 13, 2006. Under that Order, the parties agreed that Father would have sole and residential custody of the three children and that Mother would have visitation every other weekend from Friday at 7 pm to Sunday at 6 pm pending a hearing. Subsequently, Mother filed a Petition for Divorce and this Court granted the divorce by final decree on November 30, 2006.

#### DISCUSSION

For the sake of judicial economy, the Court will not restate the testimony given at trial, as it can be more fully seen on the record, but rather will note any relevant issues throughout the

discussion. In deciding the legal custody of a child, consideration must be given to all relevant factors, including those set forth in 13 Del.C. §722(a).

1) The wishes of the child's parent or parents as to his or her custody and residential arrangements;

Father requested in his Petition that the Court grant him sole and residential custody of the three children, as he alleged that Mother was suffering from post-partum depression and discontinued taking her medication. During the hearing, Father testified that he and Mother do not agree on important decisions regarding their children and that if the Court should find that a joint custodial arrangement would be in the children's best interest, then he would like the Court to grant him the final say when it comes to medical decisions. He also requested that Mother not be permitted overnight visitations with the children, as he does not believe Mother has appropriate residential arrangements. During her testimony, Mother admitted that she lives with her grandmother, who suffers from dementia, and agreed with Father that she could not have all

three children with her there. Father further testified that Mother has not fully exercised her visitations with the children, and that she does not devote equal attention to all three children.

In her Answer, Mother denied Father's allegation that she still suffers from post-partum depression and claimed that she discontinued taking her medication under the supervision of her physician. She testified that she had an excellent relationship with all three children prior to her separation from Father, but since the children have been residing with Father, she has had difficulty maintaining that same relationship. Mother also testified that the reason she yielded interim sole custody to Father was because he was in possession of the marital residence and she did not want to create more distress and confusion for the children.

During the hearing, Mother submitted a requested custodial arrangement, including both a short-term and long-term schedule. The proposed short-term schedule would be in effect until Mother obtains suitable housing for the children and entails Father maintaining residential custody with Mother having the following visitation schedule: Wednesday evening visitations with Laura and Karen; atternate weekend visits with Laura from Saturday evening until Sunday evening; alternating Sunday visits with all three children from 9 AM until 6 PM; holidays and vacations pursuant to the Standard Visitation Guidelines. Mother's proposed long-term schedule is a shared residential arrangement (week on/week-off) where the parties would exchange the children on Sunday evenings.

The wishes of the child as to his or her custodian(s) and residential arrangements;

Due to the children's young age, the Court did not interview them.

The interaction and interrelationship of the child with his or her parents, grandparents, blings, persons cohabitating in the relationship of husband and wife with a parent of the child,

Father currently lives with Paternal Grandmother in a 4 bedroom house on two acres of land. He testified that this is the only home in which all three children have ever lived, it is located in a family-friendly neighborhood, and that the children have friends who live close by. Father and Paternal Grandmother testified as to Father's close relationship with all three children, especially his dedication to Leigh, who suffers from autism. Both he and Paternal Grandmother testified that Paternal Grandmother has a great relationship with the children and that she assists Father in caring for the children while he is working, including picking up the older two children from school each day. Paternal Grandmother testified that she used to assist Father in his office until she recently decided to stay home and help care for the children full-time. Father also testified that his father, sister, aunts, uncles, cousins, and grandparents live close by and that the children see them regularly.

As discussed above, Mother currently lives in a two bedroom apartment with her grandmother, who suffers from dementia. She testified that she could not have all three children at her current residence due to her grandmother's condition; however, she has had Laura spend the night on several occasions. Mother also has an 11 year-old daughter, Katie, from a previous relationship who is currently living with Mother's ex-husband's sister due to the grandmother's dementia and the unfortunate situation between Mother and Father and their three children. According to Mother, Katie gets along very well with her other three children. Mother's father, other, and grandmother also live nearby, but Mother stated that she does not want her parents ound the children because they are both alcoholics.

The child's adjustment to his or her home, school and community:

The oldest child, Laura, is currently enrolled in Newark Montessori School and is doing well there, despite needing some extra assistance with her phonics. Leigh has been diagnosed with autism and is currently enrolled in the early learning program at the University of Delaware. She was previously enrolled at the Brennan School, which, unlike the early learning program, specializes in autistic children. Father removed Leigh from the Brennan school after she came home on several occasions with cuts and bruises. Dr. John Thomas Dewey, who is employed by the Brennan school and has been working with autistic children since 1991, testified that Leigh's injuries were the result of her own tantrums and that she would benefit if she were to re-enroll at the Brennan school. The youngest child, Karen, is not currently in school due to her young age.

5) The mental and physical health of all individuals involved;

As noted above, Father had concerns that Mother was mentally unstable. Mother also had concerns regarding Father's mental health and even filed a Motion for a Psychological Evaluation of Father, which was granted by this Court on March 3, 2006. Dr. Romirowsky, who performed an evaluation of both parties, testified that each party has the requisite mental health to take care of the children and make important decisions on their behalf. Despite having received information regarding the observations of the private investigator hired by Father (see discussion below), Dr. Romirowsky testified that there were no indications that Mother is a physical risk to the children and he sees no problem with Mother spending significantly more

Father, on the other hand, had a tendency for perceivery, according to Dr. Romirowsky's estimony, which means that he insists on taking the same approach even after getting feedback hat his approach is not working. Dr. Romirowsky testified that this was an unhealthy sign and hat he does not see it in cases where the parties are willing to make adjustments. Dr.

Romirowsky also determined that Father was suffering from stress, anxiety, depression, and was at risk for losing touch with reality. Notwithstanding these findings, Dr. Romirowsky believes that both parents should be equally responsible for all decision-making and that they should try to achieve residential arrangement wherein Mother would have significantly more time with the children. Dr. Romirowsky also stated that due to the developmental stages of the children, it is better to have frequent contact with the non-custodial parent.

Regarding the physical health of the three children, both Laura and Karen suffer from malabsorbtion syndrome, according to Father, where the body doesn't absorb all the nutrients it needs. Karen's vaccinations have been halted because Father is afraid they may cause her to develop autism, which Leigh suffers from.

6) Past and present compliance by both parents with their rights and responsibilities to their child under §701 of this title;

As noted above, Father hired Mr. Phillips, a private investigator who observed Mother with the children on several occasions. Mr. Phillips testified that he observed Mother driving in excess of 70 mph with the children in the car. He also testified that he observed Leigh run into the street 6 or 7 times while Mother was outside with the children and that she left the youngest child, Karen, alone inside the house for as long as 10 minutes. Mother did not outright deny any of these allegations; however, she stated that while she wouldn't be surprised if Leigh went into the street, she claimed that Leigh was never in the middle of the street while under her care. Father alleges that Mother does not spend equal time with the children and devotes nearly all of the time to Laura, the oldest child. He also claims that Mother did not exercise her Christmas Bye visitation with the children, nor her 5 weeks of visitation over the summer.

Mother testified that Father has unilaterally made decisions on the children's behalf, such as taking them to another doctor besides the agree-upon family doctor, refusing to give Karen all of her vaccinations, and treating Leigh's autism in a way that is contradictory to Mother's wishes.

7) Evidence of domestic violence as provided for in Chapter 7A of this title, and

Both parties have filed Petitions for Protection from Abuse. Mother filed hers on January 3, 2006, alleging that Father had threatened to kill her and dispose of her body where no one would find it on several occasions and that he stated that he was hearing voices in his head. A Temporary Ex Parte Order was granted by this Court the same day it was filed and was later denied on January 13, 2006 after a full hearing on the merits. During the hearing on February 6, 2007, Mother testified that she does not believe Father is a risk to her or the children and she should not have taken his threats literally.

Father filed his Petition for Protection from Abuse on January 5, 2006, alleging that

Mother had stopped taking her medication for post-partum depression, that she left the children

unattended or attended by strangers at various places and times, and that she threatened to have

Father jailed with the intention to harass, intimidate, and annoy Father. His Petition was also

denied on January 13, 2006.

8) The criminal history of any party or adult member of a household and shall take into consideration whether a party or adult member of a household has pled guilty or no contest to or was convicted of a criminal offense.

No evidence was provided regarding either party's criminal history.

#### CONCLUSION

In addition to the above referenced best interests factors, the Court must also consider any other relevant information that impacts its decision regarding residential and custodial care of the children.

The Court agrees with Dr. Romirowsky and finds that it is in the children's best interest for both parents to be involved in making decisions on behalf of the children and for Mother to spend significantly more time with the children. Thus, the Court awards joint custody of the children with the residential arrangement pursuant to Mother's proposed schedule, with a couple minor adjustments. The interim arrangement while Mother resides with grandmother is to be as follows: every Tuesday and Thursday from 6:00 pm to 8:00 pm with Laura and Karen; every other Saturday overnight with Laura; and every other Sunday from 9:00 am to 6:00 pm with all three children. Once Mother obtains suitable housing, she shall enjoy visitation with all three children on alternate weekends from Friday at 6:00 pm with a return to school, daycare, or Father's on Monday morning, as well as Wednesday overnight at 6:00 pm on weeks she has the upcoming visitation, and Wednesday and Thursday overnights on weeks she does not have the upcoming weekend visitation. The visitations do not need to occur at Father's; Mother may take the children out to dinner or wherever she pleases if she feels comfortable. The parties shall continue to follow the Standard Visitation Guidelines for holidays and special occasions.

Each parent is entitled by statute to have reasonable access to the children by telephone, mail and other means of communication and to receive all material information concerning them, regardless of the joint or sole legal custodial status of the children. The parties shall exert every reasonable effort to maintain free access and unhampered contact with their children. Moreover,

each party shall foster a feeling of affection and respect between the children and the other parent. Neither party shall do anything that may estrange them from the other party, injure their opinion of the other party, or hamper the free and natural development of their love and respect for each party.

The rights of children set forth in 13 Del.C. §1507(g) with respect to divorcing parents are as follows:

- 1. The right to a continuing relationship with both parents.
- 2. The right to be treated as an important human being, with unique feelings, ideas and desires.
- 3. The right to continuing care and guidance from both parents.
- 4. The right to know and appreciate what is good in each parent without one parent degrading the other.
- 5. The right to express love, affection and respect for each parent without having to stifle that love because of fear of disapproval by the other parent.
- 6. The right to know that the parents' decision to divorce was not the responsibility of the child.
- 7. The right not to be a source of argument between the parents.
- 8. The right to honest answers to questions about the changing family relationships.
- 9. The right to be able to experience regular and consistent contact with both parents and the right to know the reason for any cancellation of time or change of plans.

10. The right to have a relaxed, secure relationship with both parents without being placed in a position to manipulate one parent against the other.<sup>2</sup>

Since this Order was entered after a full hearing on the merits, any modifications thereof shall be pursuant to 13 <u>Del.C.</u> §729(c).<sup>3</sup>

IT IS SO ORDERED.

<sup>(2)</sup> If the application for modification is filed more than 2 years after the Court's most recent order concerning these matters, the Court may modify its prior order after considering:
