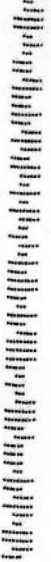

Ms. Terada,

Thank you from the bottom of my heart for your interest in exposing the truth about our case! It brought tears to my eyes reading the article, word for word, exactly as I have expressed them. Our trial was nothing like that since the prosecutors took an email and instead of writing the entire email, pulled out just the middle instead of the entire story - beginning middle and end - the way a story is supposed to be told - so I. Thank you for that! I can't even write this letter without crying because your generosity has truly touched my heart.

I never in a million years would have predicted this tragedy happening or my family being incarcerated EVER. Through this incarceration, I have learned that there really is nothing JUST about our JUSTICE system. The percentage of guilty vs innocent is ridiculous because you are guilty until proven innocent instead of innocent until proven guilty in this country. I have since learned that it is the exact opposite of how it is supposed to work - all to obtain a conviction.

I was guilty before I even plead NOT GUILTY and took my case to trial - the

prosecutors and the media made sure of that. Then when I plead NOT GUILTY and said, "Hey, I didn't do what they are trying to say I did," they gave me this draconian trial penalty - a LIFE sentence for fighting against the government. My family was just the "guinea pigs" for more convictions to be secured since the government just received more funding to convict more people of "cyber crimes" in 2013 ironically the year we were indicted.

The prosecutors even made sure that they sent my indictment to the Texas Board of Nursing. I had plead NOT GUILTY and was waiting to go to trial. These charges had nothing to do with my Nursing license and I had never had any complaints against my Nursing license in Texas or NJ, where I lived & practiced previously. I had to appear before the Texas Board of Nursing committee, but because I was incarcerated already awaiting trial, I tried to postpone the committee meeting several times. My Court Appointed Attorney tried to get the Judge to postpone it or to intervene, but since it was a state issue and he was a Federal Judge, he said that he could not do anything - so they revoked my

Nursing license because I could not appear before the Nursing Board to defend my license. That absolutely crushed my soul because Nursing is my passion and I became a Nurse in 1992 to honor my 18 year old brother Michael, that passed away from Acute Lymphocytic Leukemia.

I have written to the Nursing Board asking about reinstating my license upon release from prison. They have responded that I would need to complete my Continuing Education hours, letters from Doctors/previous employers, etc. in order to get my license back. I pray that this information is correct because I will do whatever is necessary to be a RN again. I LOVED taking care of my patients and I miss it very much.

It devastates me being away from my daughter, son and husband. It breaks my heart to know that my brother is NOT where he belongs either - with HIS children. There are days that I feel like I can't even breathe being without them all because they are the air that I breathe. If David, Mom, or I planned or are guilty of any of this tragedy then we belong behind bars deservedly but I promise you that is NOT

the case. I will fight with my LAST breath if that is what it takes to prove that we are NOT guilty and don't belong behind bars, but home with our family that so desperately need us.

My husband has been diagnosed with PTSD, panic attacks, anxiety and depression due to this tragedy and our incarceration.

He is barely keeping his head above water emotionally, physically or financially and is also caring for our 16 year old daughter.

Who is reaching out to help her who is also suffering without her <sup>mother's</sup> family and a father that is broken since 2013?

We have been told that she is NOT a victim in this case - that there are no resources for her... so who

cares about MY SUFFERING CHILD

that needs her mother, <sup>her</sup> uncle, her father "healed" and her family together

again. She doesn't want to talk to a psychologist because the government has taught her that "anything you say can and will be used against you" -

so who will peel through these layers that she has shielded herself with to protect herself?

I have enclosed this plea for help for my family in the form of a GOFUNNME site ONLY to show you how my

middle class family has now succumbed into poverty due to my incarceration. The site is not up and running yet because I just mailed it this past week to my beautiful friend and Guardian Angel that is helping me even though she has her own health issues as well as her family. It is disgusting how I have to literally fight for my life and the lives of my family in the free world.

My mother fought for her life just by asking the BOP, through all filed grievances, to perform the CT scan of the head with and without contrast the way it was ordered to evaluate the reason for her headaches. She lost the fight for her life on Mother's Day weekend 2016, due to the deliberate indifference of the BOP medical staff since they didn't check her kidney function studies to see if her kidneys could tolerate the CT scan dye. The CT scan was done without contrast not showing the 3 brain tumors that she died from 3 years later when I almost had to resuscitate her in the cell when she had a Grand Mal seizure, requiring oxygen, near intubation and immediate transfer to Thomas Jefferson university hospital for brain surgery.

I want to make it home alive with my brother to tell our side of this story.
