Re: Appeal of blocked email communication And blocked phone communication with Anthony T. Williams #: 05963-122

Dear Warden McGrew,

This letter is to appeal the email notice I received on December 16, 2020 via Corrlinks stating, that my email communication with Mr. Anthony T. Williams was blocked. The notice is attached (Exhibit 1). The reason they stated was: "The Bureau has determined that such communication is detrimental to the security, good order or discipline of the facility or might facilitate criminal activity." These accusations are preposterous, unfounded, downright ridiculous, malicious, intentionally demeaning and discriminatory. The fact that I live 4,751 miles away from this facility and to accuse me of such ludicrous statements are utterly laughable and incomprehensible. However, very empowering, actually ironic and very flattering that a simple lay woman like me, and a facility like this... is threatened by me? WOW...Incredible!

On November 23rd, 2020, this facility also blocked my phone conversations with Mr. Williams, reason? I have no clue. Warden McGrew, I am also appealing this phone blocked as well, because I am NOT a threat nor have I anything against this facility or to anyone in this facility, to prevent me from my rights to communicate with Mr. Williams.

I am a trusted family friend of Mr. Williams' parents and his siblings for number of years. For this facility to accuse me of such ludicrous, unfounded, damaging and discriminatory accusations, constitute: 1). Violated both of my Civil and Human Rights' First Ammendment of Free Speech and 2). Discriminations in such manner as: a). Age discrimination, b). Gender discrimination, and c). Race discrimination.

Attached are copies of my Corrlinks email correspondence with Mr. Williams (Exhibit 2), since he arrived in this facility on Dec. 6th. Exhibits #2 are proofs that the contents of these email communications were NOT in any way, formed or shape, a "detrimental to the security, good order or discipline of the facility or might facilitate criminal activity."

AM humbly asking you, Warden McGrew, to re-instate both my email and phone communication privileges with Mr. Anthony T. Williams, in good Faith.

You may appeal this block within 15 days of the date of this message by submitting a written request to the Warden of the prison where the prisoner is located. You should include a copy of this notice, an explanation of your appeal request, and any additional documents or information you wish to be considered.
