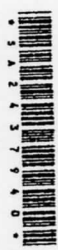

COMES NOW, MICHAEL J. SATZ, State Attorney of the Seventeenth Judicial Circuit of Florida, by and through the undersigned Assistant State Attorney, and moves this Honorable Court for an Order in Limine instructing the Defendant to refrain from making any direct or indirect mention whatsoever at trial before the jury of the matters hereinafter set forth, without first obtaining permission from the Court outside the presence of the jury, on the grounds that the said matters are incompetent, irrelevant, or immaterial to the issues involved herein, and will serve only to unfairly prejudice the jurors against the State. The subject matter in question is:


1. That there shall be no reference in this trial by a witness, by a party, or by an attorney to the fact that other states chose not to prosecute Defendant for unauthorized practice of law.
2. That there shall be no discussion in front of the jury by a witness, by a party, or by an attorney of any case law or authority including, but not limited to, the U. S. Constitution, the Uniform Commercial Code, Corpus Juris Secundum, Black's Law Dictionary, or Common Law.
3. That there shall be no discussion in front of the jury by a witness, by a party, or by an attorney of the Holy Bible, or Scriptures.

4. That there shall be no discussion in front of the jury by a witness, by a party, or by an attorney of the concept of "Next Friend."
5. That there shall be no discussion in front of the jury by a witness, by a party, or by an attorney of Yahweh Elohim, biblical law, the Religious Freedom Restoration Act of 1993, and Yahshua the Messiah.
6. That there shall be no discussion in front of the jury by a witness, by a party, or by an attorney that this is a re-trial or that the first trial was declared a mistrial.
