COURT ACTION: EO: COURT ORDER REGARDING MOTIONS FILED ON NOVEMBER 22, 2019

On November 22, 2019, pro se Defendant Anthony T. Williams (“Defendant”) filed his: “Ex Parte Request for Transport of Incarcerated Party” (“Transportation Request”); motion demanding that the Department of Justice change its name to either “the Department of Injustice” or “the Department of Unlawful Prosecutions” (“DOJ Motion”); and “First Motion in Limine” (“MIL1”). [Dkt. nos. 651, 652, 653.] The Court FINDS all of these matters suitable for disposition without a hearing, pursuant to Local Rule 7.1(c). Further, the Court FINDS that it is not necessary for any party to file a response to either the DOJ Motion or MIL. The DOJ Motion and MIL1 are HEREBY TAKEN UNDER ADVISEMENT.

Pursuant to the deadlines issued at the August 27, 2019 status conference, any response to the Transportation Request must be filed by **December 6, 2019**, and Defendant will not be permitted to file a reply. See Minutes, filed 8/27/19 (dkt. no. 566), at 1. The Transportation Request will be taken under advisement after the response deadline.

Greetings Brother Rudy,

November 26, 2019

I was finally able to get some stamps in order to write you and thank you for the \$20 you put on my account. It was greatly appreciated. I don't know if Rosy has told you yet, but the Fourth District Court of Appeals in Florida upheld my unlawful conviction in Florida but did not give a reason. I sent a copy of the letter to Rosy to send you a copy to upload. I didn't think that the appeals court would be in complicity with the lower court to keep me unlawfully incarcerated but I see I was wrong. I know that I will eventually win but now I don't know how long this process is going to take. My appeal was sabotaged from the beginning because I had filed my initial brief on my own outlining all of the errors and violations committed by the trial judge Andrew Siegel. Then a year later I was notified that my brief was incorrectly filed by the clerk and therefore my brief was not properly filed and a year was wasted. However, I sent my brief to the Attorney General's office according to the rules and they had sixty (60) days to answer my brief. They never answered and thus my appeal was supposed to be granted. Now they are using the fact that the clerk didn't file my brief properly that my initial brief was not considered. I then had the appeal attorney re-file my brief but he left out most of the grounds that I had outlined in my brief. Although I feel he did a decent job with the brief, he left out vital grounds that the appeal court would have had to consider and would have made it almost impossible to deny. Now I have to request a re-hearing and if they deny it,

then I can appeal to the Florida Supreme Court and that is, if they will accept it for review. I have you listed as a witness to testify at my trial regarding how the government has illegally incarcerated many political prisoners such as myself who has done nothing wrong but were exposing the corruption in the government. My trial now has been reset to start on February 3, 2019 but you will not need to be there at that time. The government will pay for your round trip ticket, hotel accommodations and food for the day or two that you will be here to testify. You can let me know what dates are more convenient for you and I will put you down for that date to testify. If it will not be feasible for you to be able to take off a couple of days to testify, please let me know and I can have you removed from the witness list. If you would like to stay longer to view more of the trial let me know also and I can have provisions made to have the government pay for your extended stay. If you can't make it then its ok because I do have about 50 witnesses that will be testifying on my behalf. I was deprived of the right to have witnesses testify at my last Florida Trial and so I'm confident that with all the witnesses that I have who were clients or people that know me, that I will be able to win my case unless they have this jury rigged also.

The webpage that you and Erin created for me has gotten a lot of attention and several people have written to me based upon the information you and Erin posted on the webpage. My gratitude to you both can not be expressed to you sufficiently in words because you both did what the Holy Spirit guided you to do when you had no obligation to do anything for me. I truly appreciate

the mantel that you both have taken up to help innocent prisoners with moral support, books, interest in our cases and the integrity to actively do something to expose what is going on and ultimately helping us obtain justice. What you and Erin do is not an easy task and not many people could do what you are doing for total strangers that you have no ties or relationship to which would compel you to want to expend your time, money and resources to be of assistance to so many of us. I try not to bother you with requests because you have far more men and women who are in worse shape than I am in my situation and I want to make sure that you have the time to focus on helping them. I know that one day soon Yahshua will exonerate me and deliver me out of the belly of this satanic beast but until then I am continuing to fight and I am stronger than ever and even more determined to effectuate change in this unjust wicked system. I no longer feel that these people are just racist because if they were just racist there would be hope for them to be able to see how ridiculous being racist really is. But these people are far more malevolent, far more sadistic and far more egregious than racists. At least racists have a disposition to care for their own, but these people committ atrocities upon their own people. These people are what psychologists term psychopaths or sociopaths. They are reprobate and have no sense of human compassion or empathy and this is why they can committ some of the most heinous acts against people and feel no remorse and actually get a certain level of satisfaction from inflicting pain on innocent people. This is what I have observed in these last few years of my incarceration and the American people are being lied

to and need to wake up to what's going on because if they don't do something to stop it, they will find themselves in a worse situation than some of us are now. People think that those who are in prison are criminals and there are some people who deserve incarceration for their crimes. However, my experience with this unjust system reveals a different story that most who are incarcerated are innocent or haven't done anything to harm no one but a lot are mentally ill, alcoholics, drug addicts, prescription pill addicts, homeless or destitute. Most of these people need help medically and mentally and spiritually not incarceration which compounds whatever they were suffering from. I feel that Yahshua allowed me to experience this so that I will have first hand knowledge of just how corrupt and satanic this system is so that I will be able to effectuate change once I'm released. Once you see and experience what I have seen and experienced, you can never turn a blind eye and not say or do something about it. This experience is truly life changing because it has eradicated even some of the misconceptions and stereotypes that I had about prisoners and people in prison. I used to be one of those people who would adamantly defend that we have the greatest criminal justice system in the world until I became a victim of it. Our concepts about our criminal justice system is one that is based in slogans and sayings like "Everyone is presumed innocent until proven guilty" but is not comparable in application. Anyone that has ever been to jail can tell you that you are presumed guilty until you can prove your innocence and if you are poor or indigent, even if you are innocent, you will not have the money and resources to prove it to obtain justice. This is the state and condition of the American Criminal justice system. It

would shock the average American if they knew what goes on behind these walls. Guards murder inmates with impunity. Male guards rape female inmates with no consequences or repercussions for their actions. Confining men and women in solitary confinement for months on end depriving them of proper food, water, hygiene, exercise, contact with family, attorneys or clergy, withholding medication and then antagonizing the inmates with it. In my experience from the facilities I have been housed in, 90% of prisons need to be shut down and destroyed and the prison employees should all be thrown in jail for what they have subjected inmates to or allowed it to happen without speaking out about it. The Stanford and Milgram experiment says it all about people who work in this system and I have seen it up close and first hand and can concur and confirm that what those experiments revealed is true.

I truly thank Yahshua for people like you and Erin that gives hope to those prisoners who have been down trodden, abused, violated and forgotten. My prayer is that Yahshua continues to give you both strength to endure and continue the good fight. May peace and joy rule your hearts.
