## DEEP STATE COUP D'ETAT #15; THE DC MILITARY JUNTA:

### A. FOLLOW-UP ON COUP D'ETAT #13:

\*\*\* When Tony Bobulinski was requested to run a Chinese-funded shell corporation for the BIDEN Crime Family: Joe Biden showed his tax returns to Bobulinski and said, "You see my tax returns and there's no money from them". ### D. 04 JANUARY 2021 WARNING GIVEN OF 06 JAN 2021 RIOT ON CAPITOL HILL:
