*** It was bad enough that the bribe-taking prosecutor pushed a false conspiracy trial and conviction on me. Years ago, a prisoner made an affidavit for about the prosecutor coming to the Jackson Prison and telling the prisoner to say, "Tell Northington, 'I love him'." Records indicate the prosecutor likely paid a bribe to MDOC employees Melody A.Pauley WALLACE and Nancy KLAVON to enter a false 1st Degree Murder conviction in my record on that day. At least 3 different times MDOC STAFF told me they had removed this false 1st Degree Murder conviction but they apparently lied to me.

*** In DECEMBER 2021, the Parole Board let me know the false 1st Degree Murder conviction was still in my records. Every conviction requires a trial and JUDGMENT OF SENTENCE to be imprisoned for a conviction so, on 13 APRIL 2022, I filed abovewritten DEMAND #1 for a copy of such JUDGMENT OF SENTENCE to aforesaid persons. No one gave me a copy of such JUDGMENT since none exists. On 14 APRIL 2022, I filed abovewritten DEMAND FOR PAYMENT but no one answered. Finally, I told them, "Any or

all of you may be imprisoned for up to life for FALSE IMPRISONMENT and MISPRISON OF FELONY". A feeble response finally came from the MDOC Central Records Administration, C CEKANDER, that said I can get the JUDGMENT "from the court" when there was no court involved, and that prisoners cannot use the Michigan Freedom of Information Act when it was NOT AN FOIA REQUEST but was a COMMON LAW DEMAND.					
*** I await further results after my letter stating MDOC STAFF BEING IN DANGER OF IMPRISONMENT. Effectively, everyone named in above DEMANDS has, for years, been criminally covering-up for Melody WALLACE and Nancy KLAVON falsifying my record to keep me imprisoned 25-years past my early release date.
