## **B. OTHER PRISONS**

\*\*\* In 2018 and 2019, at other prisons, I received "Miracle in Atlanta" and "One in a Million" from Pat Shannan because the Property OFFICERs there ARE CIVILIZED PERSONs not stumbling through life in ignorance. They knew policy and took a minute to check Oceana Publishing on their computer.

### C. JCF PROPERTY NAZIS

\*\*\* On 16 MARCH 2020 at JCF in Jackson, I received a copy of "Born Again Republic" which Property NAZI Linda S. GRAHAM ((517) 780-5207) refused to give to me by saying, "Oceana Publishing Co., is not an approved MDOC publications or religious vendor. Attachment A & B".
