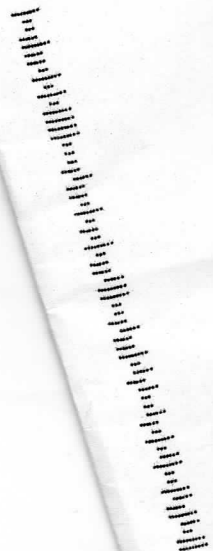





25 JUN 2021: I don't know if you got my 23 JUNE 2021 email so the following is its text (I hope you got this email):

Hi Rudy and Erin:

I need a note from Pat Shannan saying he is the publisher of "One in a Million", if possible. If he sends it to you, then you to me, that will help.

A. MDOC POLICY

MDOC Policy says: "Prisoners also MAY RECEIVE PUBLICATIONS ordered by members of the public FROM A PUBLISHER". PD 05.03.118, Attachment A; also Attachment B.

B. OTHER PRISONS

In 2018 and 2019, at other prisons, I received "Miracle in Atlanta" and "One in a Million" from Pat Shannan because the Property Officers there are CIVILIZED PERSONS.

C. JCF PROPERTY NAZIS

On 16 MARCH 2020 at JCF in Jackson, ^{JCF} I received a copy of "Born Again Republic" which Property NAZI Linda S. GRAHAM ((517) 780-5207) refused to give me by saying, "Oceans Publishing Co., is not an approved MDOC publications or religious vendor. Attachment A & B". As aforesaid in MDOC Policy, there is no MDOC approval required for publishers, so GRAHAM thinks she can do anything she wants (like Lon Horuchi who murdered Elizabeth and Sammy Weaver).

On 26 MARCH 2020, Hearing Officer John COOLEY said I could not have "Born Again Republic" because it was from "Freedom Church". The return address on the mailing envelope must be the same as the address inside the book; usually it's on the ISBN page.

On 01 JUNE 2021, JCF in Jackson received a 2nd copy of "One in a Million" which Property NAZI Brenda A. SCHMELTZ ((517) 780-5207) refused to give me based on her lie that: (1) It was a "used book" because Pat Shannan autographed it; and (2) a fraudulent claim "it was not from an authorized vendor" when we are allowed to receive books from any publishers who are not "authorized vendors". SCHMELTZ deliberately ignored fact and policy about publishers (like Janet RENO who murdered women and children at WACO).

Above is not all, but is most, of my 23 JUNE 2021 email to you. Our phones are inoperative. God Bless! Gary M.
