RE: SYSTEMIC RACISM OF WHITE HOUSE

Dear MARXIST:

## A. RACISM OF THE WHITE HOUSE

You MARXISTS do not support your plethora of false RACISM accusations about others with facts. You FEIGN HELPING MINORITIES WHILE DEPRIVING minorities of RIGHTS as said in enclosed "DEMONRAT SINS". For example:

- (1) YOU LIE that requiring ID Cards to vote denies minority right to vote which is your Office Suppressing Minority Right to voice that 72% of Blacks want ID Cards required to vote, You treat Blacks as if You ARE SLAVE-MASTERS TELLING BLACKS WHAT TO THINK. Your RACISM OFFENDS by you inferring Black persons are an ignorant MONOLITH not capable of getting or using ID Cards (State ID Cards also are free to indigents);
- (2) You incite facism of using Coca Cola, Delta Air, the MLB, etcetera to bully, bankrupt, coerce and intimidate those who do not bow to you; as when
- (3) You incited the 94% White management of MLB INC to make a RACIST move of its JULY 2021 All Star Game FROM the 51% BLACK Atlanta to the 9.2% BLACK Denver to DEPRIVE BLACK businesses in Atlanta of a \$100-million income from the Game.

After Georgia enacted law SB202, facts are:

- (1) "President" Joe CROW insisted the MLB move their JULY 2021 All Star Game from Atlanta, based on Joe's RACIST LIE of the SB202 law being "Jim CROW 2.0";
- (2) Joe CROW and you LIED that SB202 added undue restrictions to voting law when it actually made voting MORE LIBERAL than before (see following);
- (3) Joe CROW and you LIED that SB202 is RACIST because it requires a State ID Card to vote; and
- (4) You doing aforesaid is deep-seated HATRED. (One who hates another is a MURDERER. HOLY BIBLE, I John 3:15. One who lies speaks his/her native language, is hateful and a MURDERER. BIBLE, John 8:42-47.)

GEORGIA enacted its SB202 law!

- (1) to EXTEND EARLY VOTING to 17 days, at 0700 hours to 1900 hours on those days, with 0900 hours to 1700 hours minimum for rural areas (MI, MN, NJ, NY and WI have no early voting);
  - (2) to allow no-excuse mail-in voting which Stacey ABRAMS wanted;
- (3) to require State-accepted identification (which can be a utility bill) to ensure system integrity; and
- (4) for the first time ever, to lawfully allow BALLOT DROP BOXES used and kept in secure areas so We the People can trust our elections.

Compared to GEORGIA, "President" Joe CROW's home State, DELAWARE, has less voter rights:
