Dear Governor Whitmer,

**A. MDOC PRISONS; LIFE IN COVID-19 PARADISE:**

I have been quarantined almost 6-weeks in a prison cell designed for single person occupancy that has 2 prisoners living about 3-feet apart. When the outside temperature is 90 to 95°, then the cell temperature is often 100 to 110° (MDOC STAFF measured temperature). The first quarantine began on 01 JULY 2020 because 5 prisoners in the upper level had COVID-19, then on 14 JULY 2020 because 2 more prisoners had COVID-19 but now for unknown reason. Prisoners in hotter cells are most of the COVID-19 positive.

Extreme heat weakens the human immune system. I have been on the verge of heatstroke a few times under aforesaid abusive conditions. I'm nauseated at this writing. I'm in terrible pain because the severe heat aggravates my untreated Chronic Mastoiditis/Eustachian Tube Dysfunction with years of serous otis media infection (enclosed Declaration, #8).

I'm a 71-year-old medically-challenged person with: (1) Daily ATRIAL FIBRILLATION; (2) Daily ANGINA; (3) Congestive and Ischemic HEART FAILURE; (4) Cataracts and degenerative retinopathy; (5) RENAL failure; (6) all caused by years of untreated HYPERLIPIDEMIA; (7) a PARALYZED LEFT LEG caused by months of untreated MRSA infection; (8) etcetera. See Declaration.

**B. NO TREATMENT FOR ATRIAL FIBRILLATION:**

\*\*\* On 02 AUGUST 2020, from 2222 to 2400 hours at JCF, Nurses told me when I went into Atrial Fibrillation, "Send a kite" which means no care for weeks and "There is no treatment

because of COVID" 19. The A Fib caused me: (1) a cold sweat; (2) a pulse near 30 beats per minute; (3) to get nauseated; (4) to vomit and defecate on myself; (5) spikes of pain in my right temple; (6) to lose use of my left leg during the spikes of pain; and (7) to sometimes black-out during the spikes of pain. The Atrial Fibrillation caused a blood clot in or near my right carotid artery which has a 75% stenosis. Such LIFE-THREATENING event is in my 01 to 04 JULY 2019 MDOC and McLaren Hospital records. I chugged 5-glasses of water, chewed a few Aspirins and Plavix blood-thinner to minimize the blood clot and took 3 Nitroglycerine because of chest tightness and pain. Health Unit Manager Sirena Katlyn Landfair ordered this policy of denial of treatment. \*\*\* On 07 AUGUST 2020 at 2000 hours, this still is not treated so I mitigate the sharp head pain spikes with Nitroglycerine.

PLEASE PUT A CAP ON LIFE SENTENCES; especially for those falsely imprisoned, thought crimes like conspiracy and the MEDICALLY FRAIL.

When I came back to JCF in NOVEMBER 2019, he took 3 of my jockey shorts, my athletic shorts with a matching tank top, and sweatpants. As he played with my running shorts and put them up to his face he turned to me and mumbled, then said, "... have a personal thing for you". On 31 JULY 2020, ARUS Theresa Kik finally gave a hearing on what Sims took because no one else wanted to hold the hearing for 9-months. I filed a grievance on the hearing result and Sims' apparent homosexual conduct toward me related thereto. Sims retaliated by filing a false Class 1 Misconduct Report on me labeled as "Sexual Misconduct" because I grieved his "homosexual fetish" of taking intimate clothing of a mine. I always felt uncomfortable about his inappropriate bending over and speaking to me in the chow hall but his actions with my clothing is particularly telling. It

appears he is attempting to put me in "The Hole" because I won't give in to his homosexual ways.
