RE: STATE RIGHTS

Dear Governor ABBOTT:

A. THE BIDEN MENTALITY

*** On 06 AUGUST 2021, and 07, 09 and 15 SEPTEMBER 2021, despite the Afghan War being ended, Uncle Joe BIDEN filed Notices of "Continuation of the National Emergency" under Title 50 United States Code, Sections 1622(d) and 1701. This continuation has been ongoing since 1913 except for a few months in 1977 after the Vietnam War ended. F.D.R. had Congress change the relevant statute from "in times of War" to "in times of INCREASED INTERNATIONAL TENSION OR FINANCIAL CRISIS" so he could institute Martial Law to confiscate Gold from We the People. Right now, BIDEN'S \$3.9-trillion bill in Congress is attempting to bankrupt the United States and We the People into a permanent "FINANCIAL CRISIS" to forever maintain that Martial Law with the D.N.C. in control, like Maduro did in Venezuela. B. THE LAW ON STATE RIGHTS

*** The United States Constitution states: "We the People of the United States, in Order TO ...

INSURE domestic TRANQUILLITY ... promote the general WELFARE, and secure the Blessings of Liberty TO OURSELVES ... do ordain and establish this Constitution for the United States of America". USCA, PREAMBLE. We the People, by this, are the Government, not a Public Serpent in D.C. who, by the Legislative Record, has given up his/her Rights to do our bidding and maintain our TRANQUILLITY (which We the People are not getting via the OPEN BORDER).

*** The Constitution mandates, "No State shall, without the consent of Congress": ** (1) "... make any Thing but GOLD and SILVER Coin a Tender in Payment of Debts..." (USCA, ARTICLE, I, § 10, clause 1);

** (2) "lay any Imposts or Duties on Imports or Exports, EXCEPT WHAT MAY BE ABSOLUTELY NECESSARY FOR EXECUTING ITS INSPECTION LAWS; and the NET PRODUCE of all Duties and Imposts, laid by any State on Imports or Exports, SHALL BE FOR Use of the Treasury of THE UNITED STATES; and all such Laws shall be subject to the Revision and Controul of the Congress" (USCA, ARTICLE, I, Sec. 10, clause 2); ** (3) "lay any Duty of Tonnage, keep Troops, or Ships of War in time of Peace, enter into any Agreement or Compact with another State, or with a foreign Power, or engage in War, UNLESS actually INVADED, OR IN such IMMINENT DANGER as will not admit of Delay"

(USCA, ARTICLE, I, § 10, clause 3);

** (4) "The United States shall guarantee to every State in this Union a Republican form of Government, and shall protect each of them against Invasion" (USCA, ARTICLE IV, § 4); and ** (5) "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are RESERVED to the States respectively, or to the People. USCA, AMENDMENT X.

C. SUPPRESSING THE INVASION

*** Aforesaid Constitution gives you authority to:

** (1) Establish Texas' own economy in GOLD AND SILVER COIN to protect it from the coming Federal economic collapse that may be worse than The Great Depression (Art. I, § 10, clause 1);

** (2) IMPOSE DUTIES on illegals entering Texas from Mexico to offset your costs of guarding the Southern Border which could be thousands of dollars per person if done with NO NET GAIN (Art. I, § 10, clause 2); and

** (3) Defend Texas against the ongoing BORDER INVASION (Art. I, § 10, clause 3), which in part you are doing because Uncle JOE (as Soviets called STALIN) has abusively refused to protect Texas from the ongoing hostile invasion (Art. IV, § 4).

*** Possibly relevant here, Title 26 USC, § 2035 defines transfer of estate funds "within three years of a decedent's death as IMMINENT DEATH", and "may be 'in contemplation of death' ... even though not induced by fear of IMMINENT DEATH". CLEVELAND TRUST CO. v U.S., 421 F 2d 475, 478 (6th Cir. 1970). This "IMMINENT DEATH" timing may be applied to the "IMMINENT DANGER" of Article I, Section 10, clause 3. We the People are in fear of losing their lives, property and civilization within 3-years which may invoke that IMMINENT DANGER criteria for any jurisdiction you need.

*** Most of We the People expect Civil War 2 as BIDEN (HOLY BIBLE, Rev. 13:17) clamps down by incrementally increasing his present TOTALITARIAN BULLYING across the country like slowly boiling a frog in water. BIDEN wants to slowly bankrupt and exhaust his opposition before he makes the kill. We the People need to keep ahead of the DEMONRATS' MARXIST plan and be prepared for any contingency as noted in my enclosed writings. There are more of us than there are of them.
