## B. WHITE HOUSE SEDITION & TREASON

\*\*\* We know most of Joe BIDEN's EXECUTIVE ORDERS and communications to We the People are not his words but are those of corrupt UNELECTED WHITE HOUSE STAFF who decide and have Joe BIDEN sign or say. ## C. SPIRALING INFLATION & SHORTAGES CAUSED BY DEMONRAT HATRED

\*\*\* A combination of Joe BIDEN issuing EXECUTIVE ORDER 13990 (20 JAN 2021) TO SHUTDOWN the KEYSTONE Pipeline, and EXECUTIVE ORDER 14008 (27 JAN 2021) TO SHUTDOWN 60-percent of the FOSSIL FUEL production, caused home heating and transportation fuel costs to increase by 47 to 53 percent. These increased fuel costs caused:

\*\* (1) 40 percent of truckers to retire and/or quit trucking;

\*\* (2) Food costs to increase by 7 to 47 percent, depending on which food; and

\*\* (3) The present SUPPLY CHAIN SHORTAGE with empty shelves in stores and lack of parts for manufactured goods (like vehicles & electronic equipment).

Aforesaid BIDEN actions and his STIMULUS BILL caused 6.2% INFLATION by OCTOBER 2021. The fake INFRASTRUCTURE BILL (only 5% infrastructure & 90% slush funds) will cause 10% to 11% INFLATION. The BUILD BACK BETTER (slush fund) BILL will cause out-of-control INFLATION in excess of 17%.
