Dear Brother Rudy & Sister Erin,

Thank You very much for the \$100 deposited into my account on 19 NOVEMBER 2019. I greatly appreciate your help. It takes 3 days to show up on our screen after deposited.

Our kiosk seems to have become slower since A T & T allegedly took over JPay access. They say 5 Jackson prisons were all put onto the same server rather than having two servers. Our kiosk now goes down for 2 to 10 minutes after each user logs off. On 25 NOVEMBER 2019, it said "NETWORK ERROR" when I tried to get on, then later said all my periods were used for the day.

I have NOT yet RECEIVED ANY BOOKS sent to me. Property Officer James Sims may be holding them up or even illegally disposing of them. I'll let you right away know when they come.

Sims has been keeping my guitar from me since MDOC STAFF damaged and took it in JANUARY 2017. On 29 OCTOBER 2019, when I arrived here SIMS took my NIKE jacket, running shorts, sweatpants, medical sunglasses that MDOC provided to keep me from going blind. This 2019 taking is because I filed an AUGUST 2019 lawsuit against SIMS on the 2017 taking of my guitar and typewriter.

Dear Mr. Manville,

Your name appeared on my JPay, last week. I assume its about the dental lawsuit. In 2014 and 2015, I attempted to get dental care.

On 22 SEPTEMBER 2014, because there was a painful swelling and abcess under a lower left molar tooth, I sent a medical kite requesting dental care then filed a grievance because nothing was done. Dentists Bobby Schools and Charles Allen called me out to Health Service about my grievance but refused to do anything about the pain, swelling, abscess or my teeth. Echols said he would not do anything unless I first paid \$5. Thereafter, my lower left molar began to deteriorate and broke up. After this, my jaw was thrown off balance by the broken molar and eventually caused my other molars to break up. I am, now, chewing my food mostly with my gums.

On 24 AUGUST 2015, I filed another grievance and was again called to Health Service by Dentists Bobby Schools and Charles Allen. Allen watched as ECHOLS told me that he would do nothing for my teeth and denied the grievance. ECHOLS falsely said I had not requested dental care in 2014.

The parties of a grievance are not supposed to do the grievance interviews but NURSING SUPERVISOR RN ERIN PARR-MIRZA gave the grievances to Dentists ECHOLS and ALLEN to answer.

After the multiple attempts to get dental care without results, I gave up on trying because they would do nothing and threatened to write a misconduct on me for requesting dental care. ECHOLS said the misconduct would be because I said I had requested dental care in 2014.

I also have not requested further dental care because they would pull what is left

of my teeth and give me dentures. I pass-out a lot from Postprandial Hypotension triggered ATRIAL FIBRILLATION. I would die of asphyxiation from airways blocked by dentures if I had them during such syncope.

The U.S. District Court severed my dental claim from the rest of the case in NORTHINGTON v ABDELLATIF #1, No. 2:16-cv-12931, and I could not file it separately because of physical and cognitive disability caused by multiple heart attacks and strokes in MAY through JUNE of 2016. I am medically frail and not capable of doing much.

When I filed ABDELLATIF #1, MDOC transferred me a number of times: (1) On 03 AUGUST 2016, to Carson City (DRF) where they did not have my required low sodium diet. The 12-hour bus ride caused me to be hospitalized for Deep Vein Thrombosis (DVT) and Pulmonary Emboli (PE). (2) On 25 AUGUST 2016, to MUSKEGON (MCF) where the 12-hour bus ride caused me to go to the hospital for pleural effusion. (3) On 17 JANUARY 2017, I was transferred to COTTON (JCF) where they damaged my guitar and typewriter, then took them by refusing to allow them repaired. (4) On 28 JUNE 2018, to LAKELAND (LCF) because I filed medical grievances. (5) On 27 AUGUST 2019, to CHIPPEWA (URF-W) because I filed grievance about them taking manufacturer-provided carry bags off my WALKER which forced me to use one hand on the WALKER and fall a number of times while carrying things. (6) Back to COTTON (JCF) where they took my NIKE jacket, running shorts, sweatpants that had been legally repaired, protective prescription sunglasses used to keep me from going blind when brought sunlight causes retinopathy and Ever-increasing retinopathy due to occlusive carotid disease and "optical migraines". The REPROBATES ARE ATTEMPTING TO MURDER ME BY DEFAULT.

I filed a 2nd lawsuit on this harassment, intimidation and punishment but Judge Paul D. Borman dismissed it and said to pay \$360 and refile it which would be past limitations, NORTHINGTON v ABDELLATIF #2, No. 2:19-cv-12329. I am not physically nor cognitively capable of doing all this because I'm struggling to barely keep alive.

Let me know if you want any info for the dental case and if you can help me get replacement teeth so I don't choke to death on dentures when I pass-out.
