RE: GENOCIDE BY FORCED LOCKDOWNS

Dear Governor Whitmer,

A. LOCKDOWNS CAUSING COVID-19 SPIKES:

*** Near 40 COVID-19 prisoner INFECTIONS occurred per month in the Summer of 2020 then SPIKED to 2,456 INFECTIONS in the 3rd week of NOVEMBER 2020. The only difference in prison conditions between the Summer and NOVEMBER of 2020 COVID-19 SPIKES is that open cell windows of Summer were closed in NOVEMBER to trap us in dirty air. In the first week of DECEMBER 2020, MDOC SPIKED to ABOUT 2000 COVID-19 INFECTIONS of prisoners. By the end of FEBRUARY 2021, every prisoner will have had COVID-19 and 170 or more will have DIED.

*** Dr. Anthony FAUCI of the Nat'l Institute of Allergies and Infectious Diseases and ADMIRAL BRETT GIROR of the CDC say "LOCKDOWNS don't work" but CAUSE WORSE PROBLEMS than the pandemic. MRV13 or HEPA filters on HVAC systems eliminate pathogens from a Housing Unit. Filters may lessen COVID-19 SPIKES do NOT CURE OVERCROWDED HOUSING where prisoners live 3-feet apart. It's the same COVID-19 OVERCROWDING risk when persons LOCKED DOWN IN THEIR HOMES CANNOT GO TO NORMAL OUTSIDE FUNCTIONS LIKE to a MRV13 or HEPA FILTERED restaurant or barbershop. BEING FORCED TO LOCKDOWN in HOMES IS A DEATH SENTENCE as it is IN MICHIGAN PRISONS, especially when people cannot get needed medical care like I have been denied since MARCH.

B. CHRONIC FUNGAL MASTOIDITIS BECOMING MENINGITIS & RESPIRATORY INFECTION (exhibits in 30 NOV 2020 letter):

*** Around 02 AUGUST 2020, during COVID-19 lockdown, my Chronic Fungal

MASTOIDITIS (since 2008) became PAINFUL MENINGITIS. SEVERE PAIN spikes IN my RIGHT TEMPLE COLLAPSED my LEFT LEG and caused blacked-outs. JCF HEALTH SERVICE ((517) 780-5202) refused to treat me for this MENINGITIS due to the COVID-19 LOCKDOWN, so I endured MDOC's AUGUST OF TORTURE. I increased my blood thinners and nitroglycerin to PREVENT A STROKE AND/OR my DEATH (for which nurses ridiculed me).

*** Around 01 NOVEMBER 2020, that SAME Chronic Fungal MASTOIDITIS spread into my throat, right sinuses, right bronchus and right lung. I was often near asphyxiation with my swollen throat blocked by thick pus and blood from my RIGHT EUSTACHIAN TUBE and bronchi as I choked in spasms. I often cough up pus, blood, blood clots and likely respiratory flesh. On 10 NOVEMBER 2020, I told CORIZON HEALTH NURSE PRACTITIONER ERIN GRIFFITH of this but she gave me a blank stare and sent me out of her office saying, "I'll see you in 2 weeks". SEE my FOLLOWING NOTE ON HER LIES. Four weeks later, I've not received care because CORIZON and MDOC are MURDER INC.

"SUBJECTIVE: GERD is chronic and ongoing, but appears to be controlled. IM denies any nausea or abdominal pain associated with this".

This issue was NEVER DISCUSSED NOR MENTIONED. I have nausea and abdominal pain, always.

COMPLAINT 5: "SKIN PROBLEM"

"SUBJECTIVE: IM complained of bedsores on his right hip. States it slightly improved but was worse. Right hip has a small abrasion that appears to be a scratch. There is no redness in the surrounding area".

It was originally cellulitis-like with pus. These keep occurring.
