LOCKDOWN-CAUSED COVID-19 SPIKES: \*\*\* In California, during the 07 to 25 DECEMBER 2020 LOCKDOWN: (a) COVID-19 INFECTIONS increased to more than 1.97-million (per CNN), during which (b) COVID-19 INFECTIONS began GROSSLY SPIKING to the highest level ever around 20 DECEMBER 2020 (per CBS). An increase of COVID-19 INFECTIONS began about 5-days after start of the present California LOCKDOWN from people being stuck inside their homes and, now, appears to be going EXPONENTIAL after 13 days. \*\*\* MRV13 and HEPA air filters do NOT CURE OVERCROWDED HOUSING where prisoners live 3-feet apart, nor in middle-class homes with 3-foot hallways where persons pass within 6-inches of each other and often cannot be 6-feet apart. It's a high COVID-19 risk when persons LOCKED DOWN CANNOT GO TO NORMAL OUTSIDE FUNCTIONS such as a HEPA-FILTERED barbershop, gym, library, restaurant, school, etc. FACTS ARE: Seventy percent (70%) of COVID-19 infections occur in LOCKED DOWN homes (Harvard Univ), and COVID-19 INFECTIONS of Michigan prisoners average about 1,000 PER WEEK since windows were closed for cold weather when it had averaged 20 PER MONTH with open windows (MDOC). B. LOCKDOWNS ARE PHYSICAL ABUSE, MENTAL ABUSE & PREMATURE DEATH: \*\*\* Dr. Jay BATTACHARAYA of Stanford University says "LOCKDOWNS DON'T WORK and CAUSE more HARM than good". LOCKDOWNS are causing DEATH, PTSD-injury, AND OTHER serious HARM that can never be repaired, especially to the: (a) children deprived of interactions with peers and losing critical skills because they cannot go to in-person school (Social Psych 201); (b) one [1] in four [4] children seriously CONTEMPLATING SUICIDE due to ABUSES of forced mental and physical isolation (CBS This Morning); (c) elderly who are seriously injured, dying or dead from the ABUSES of forced mental and physical isolation (FNC); (d) poor who are dying from ABUSES of forced malnourishment and violence (USDOJ); (e) 100-million presently FORCED out of work BY EDICT (mostly in Blue States) who will soon be homeless and permanently impoverished (AP); (f) millions who died and will soon die from drug overdoses because they cannot handle the mental and physical ABUSE of forced isolation (CDC & NIH); (g) persons forcibly denied care for serious medical needs (such as no heart surgery, no care for otitis media, and no care for 30-days of meningitis with black-outs and left leg collapsing) (AMA); and (h) because of so many other INJURIES caused by the ABUSE of LOCKDOWNS. \*\*\* Therefore, both children and adults are dying at a grossly increasing rate from physical and mental abuse, drug overdoses, suicide, and for other reasons because of LOCKDOWNS. FORCED LOCKDOWNS in HOMES and PRISONS are A DEATH SENTENCE. C. DEHUMANIZATION BY LOCKDOWNS PROMOTES MURDER/GENOCIDE: \*\*\* LOCKDOWNS PROMOTE DEHUMANIZATION OF THOSE LOCKED DOWN AND THOSE DOING the LOCKDOWNS who all become mere objects of the "opposition". LOCKDOWNS DEHUMANIZED both YOU to the WOLVERINE WATCHMAN and THEM to YOU. I daily see, hear and observe that the WATCHMAN are ONLY the "TIP OF THE ICEBERG". People on ALL SIDES of the political spectrum ARE FED-UP with someone other than God and the Constitution abridging their rights and telling them how to live.
