

I Am over 80 yrs old and was saved in 1955. Married over 60 yrs to same wonderful woman. I and my wife have been involved in Children's Ministry for years. We are K.J. Verson Only - Independent Baptist Churches. Ministry was Junior Churches Set up and Training - I Have no prior Criminal Record and Joined The Pipefitters in 1963 and Retired From There. Local Union 208 Denver Colorado. I Have put my Life on the Line for Colorado ~~Number~~ of Times in my Occupation. My wife and I have Three Sons - The youngest died of Cancer. The Oldest Lives in Brighton Colo. The Middle Son Married a Divorced Woman with a Teenage Daughter - Big Mistake - Even though there were Heavenly Involved in Longmont Baptist Church and Christian School - Problems still made it's way up. Monty my son and Brandy His wife had a Son. By the Age of Three, Serious Child Abuse from Mother and Step Sister started with them too Luke. The Church stood with Brandy until they found out Her Lies on Facebook and asked Her to Leave - But it was not soon enough to Help Repair the Damage they did to Monty. He Left the Membership of the Church and Walked away from a High Paying Job to Take His Son away and protect Him - This is what Really caused the Judicial System to Go after Monty.

He was able to stay away for over Eight Months and by that time the SDN Luke was able to talk very well. 1. Menacing
2. Weapon
3. Assault.

Along with Violation of Element (5) Unless there is  
a F1 or F2 it's to be a F4 also Colorado Supreme  
Court Made a Ruling that the Information used in Charge was  
Defective - See Cooper v. People.

Then 2nd Degree Kidnapping F4 6 yrs

But IT was placed on Monty Not Me -

I was Tried, Convicted, Sentenced Without a  
Valid Charge of Kidnapping for Trial

Finally Accessory to Crime FS 3yrs  
But The problem is The Other Alleged Crimes  
are all 5-25-2013

The Accessory to Crime is 7-2-2012 to 3-21-2013.

Note - What you have is Accessory to a period

Then a period of Alleged Crimes on Me with No  
Accessory to Crime to Go with it.

Then The Sentencing The Subject of Prior or  
Subsequent Convictions.

The Longmont DA Timothy Johnson Stated to  
Sentencing Judge Andrew R. McDonald That He Needed  
to Sentence me Consecutive not Concurrently.

I had no Prior Conviction and Doing it Consecutive  
makes it a LIFE Sentence at my AGE.  
I will Probably be Dead by PED.

But Corrected I would already be up for Parole.

I Believe GOD wanted me to see what our

Number of Men He wanted me to Deal with over  
Salvation - Many Have Received Christ along with a  
Number of Other Special Things.

With my wife and I working in Children's Ministry I did not see the need to be licensed into the Ministry - However in 1980 at Adam's City Baptist Church The Pastor a Retired Missionary Durbin Thorpe Had me get Ready to Be Licensed by The Church - I was - Along with Many Responsibilities - Adam's City is a North Denver Sub Division by Commerce City Colo.

A Couple of Things about My Case.

When My Sister (Now Deceased) and Brother in Law along with my Son Ronald Turner Jr were called to testify in Trial - In Lobby before Door unlocked - An Attorney asked my Attorney J. Scott McComas - "How is The Turner Trial Going?" McComas said "Very Well" We know the Turners are Christians and we are going to Concede Them."

Also I Discussion with Judge Andrew R. McDonald He knew I was Licensed in the Ministry and was called upon to Counsel both Brandy and Monty about putting The Home Back Together Properly - The Judge then said Mr Turner I will see to it that it Never Happens - you hear me - Bang Bang with His Gavel -

The DA Timothy Johnson That had a Confiskited - Letter I had Tried to send out - Had Titus Scripture Quoted that a woman Blasphemes The Word of GOD if She is not Obedient to Her Husband.  
"when He is Right with GOD" -
