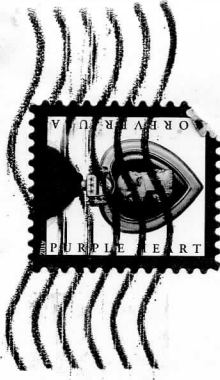

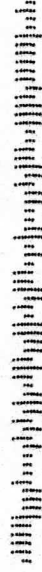

Dear Brother Rudy  
From Ronald E. Turner sr.

It's Wed 2-2-2022 I am for now back in my Pod  
Unit #33 B 2 I want to Let you know that I  
Believe I am doing OK. However I was assaulted at Noon  
on the previous Sat. I try to stay out of my ~~cell~~ as much  
as possible when ever my Cell Mate is in The Cell. At Noon  
I was returning my Algebra Book to get ready to Leave for Chow.  
My Cellie was on Top Bunk and Does spend a Lot of Time there -  
He Had another Cellie in the Cell and as I entered to put my  
Book's away, He was yelling and Talking Filthy and I  
Told Him He needed to Leave the Cell. I Did not know that  
The Claim is He was Drunk, Any way He Moved Towards me and  
I Threwed my Arm's around Him and Asked Him to Cool Down  
and Leave the Room - When I Released my Arm's He Grabbed  
my Wheel Chair and Dumped me and the Chair Over - I Hit my  
Head on The Floor and He Came on Top of me and Started  
Severely Beating me in the Face, Eyes, Jaw, Neck - On Scale of 1-100  
Some of The Pain I Received was about 1000 - Any way  
I Thought my Jaw was Broken but it was Not - My Eye  
Sight Seems OK - I along with The Offender was put  
in The Hole for about 4 Day's - However I was checked  
out by Medical Before The Whole - I was given a Small  
Blanket in a Very Cold Cell - I Had a Hard Time  
Trying to keep Warm - Spent a Lot of Time Running the Hot  
Over

Water and pouring it into Toilet, Rapped up in what I could with the Blanket - The Second Day I was Taken to Two Different Offices in The Prison - The Person in The I Something Department, Was Friendly and Told me Their Investigation had Cleared me but for my Safety I would be kept in The Whole for a while - That was a Big Relief off my mind, Praise GOD, Then Taken to another Office with an Investigator out of The Sterling From the Investigating General's Office - He Took many Pictures and Then Gave me a Victim Pamphlet with a Case# They were Going to See if Sterling DA would approve - As Far as I know This Guy was also placed in The Whole and I was Told They would Probably Move Him to another Prison. Any way The Investigator asked if I Thought I could Go back to pod 33 and Cell B 2 - I said I think so - But after getting Back I Found The Cellie Spred some Lies about the Assault - I did not Assault the Guy and What I heard from a Couple Guards is that Because I am an AT Risk Adult and The Jail is To Maintain Our Safety - As you know Now I've Contracted the Virus Twice and Now the Assault - As you and I Both know - Our LORD JESUS CHRIST could have Stopped Them from The Beating He Took - He did not - I Ask GOD, Please GOD Show me your will In The Whole I asked for Him To Send a Bird or Birds Into The Window - Guess what - I only Got to see The

The Sun Shine - So whatever - I am getting ready  
To send the Information to Both The Attorney General's  
Office and The Appeal Court's Office - I only want  
them to Be aware of the At Risk Adults - Problem -

Also Last Fri my Son's Re-consideration was  
to have been Done - No Answer yet of what ever -  
Also I am waiting for The Extension the Attorney  
General asked for - 120 Day - up Feb 17th 2022  
Then after His Answer, I get to Make "Reply"  
I am waiting to see when My stuff is returned  
and IF It's all OK - -

Last week my Wife's Brother in Wichita  
Passed away - Some Family went to Wichita and  
Took out the Valuables - Heat and Electric still on -  
They had to Have His Body Cremated - Sent to  
Alma OK for Funeral on Feb 29th - Not a Casket  
only a Container - Military Salute and Speaker for His  
Funeral - The House is Mortgaged by The Bank - My wife  
Thinks it's only worth what He owes - Pray  
That it can be Turned over without a Loss -

Vernon Does have Some Money in Account - The  
Girl's are Told to Split it up - I Also every  
Day Pray for Allan the Prayer Card - Also your  
Ministry - I Received your 3pg Letter -  
You have permission to Post This if needed -
