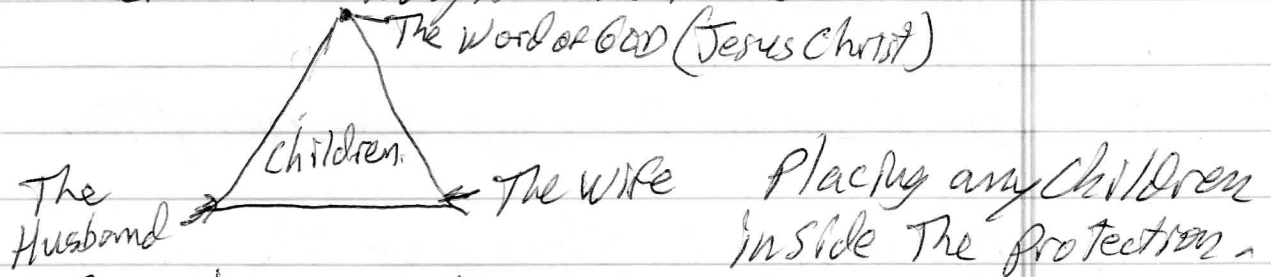

In the city of Boulder, Colorado on a very nice day in January, a young man was riding his bicycle on one of Boulder's bike paths. While riding, he met a young woman named Erikamai and they became friends. This young man, about 29 years of age, was Aaron Tuneberg.

On the day of January 18, 2013, he was riding down a bike path and for some reason did not see a prominent Boulderite crossing the bike path and had a little accident. Not serious at all; however, the Boulderite pressed charges against the person in control of the bicycle. The bicycle person should have filed charges against the Boulderite for assault on the bike, however, the next day Mr. Tuneberg was tossed into the Boulder County Jail with this big bunch of hardened criminals, you know - outcasts of society. If only the truth were known...! They put Mr. Tuneberg in an upper cell (207) where inmates are given a third blanket to try to keep warm. It was very cold during the night.

After being in his room for a while, Mr. Tuneberg came down into the Pod Room where about forty-eight men were gathered around tables with bibles, cards, games and so on. At 8:30PM a group of men pulled a couple tables together for a prayer and praise meeting before the 9:00PM lock down.

Mr. Tuneberg walked up to the group and said to the speaker, "Mr. Preacher, could I talk with you for a minute." The man, who was called "Preacher" by hundreds of inmates in several locations, went to talk with him. He proceeded to tell him that he had been involved in an accident with a Boulderite and got tossed into jail.

But, he said, my grandfather told me, "Grandson, someday you are going to get arrested and put in jail and you will be in a very warm cell". The preacher questioned that repeating to him "warm cell?" And Aaron told him to come and see. They both went up to the cell and for some unknown reason, The Holy Spirit had that room very warm.

After spending some time talking to Aaron with the Word of God, Aaron knelt down that evening, January 19, 2013 and asked the Lord Jesus Christ into his heart. He placed his name, address, email address, phone number and name of his girlfriend in the preacher's address book. The next morning Aaron's grandfather bonded him out of jail.

End of story – NO!

About three weeks later, it ^{WAS} on the news that Aaron Tuneberg had been murdered in his bed. Two men came into his room with baseball bat and golf club. The police said they wanted to steal his computer games but it was because the girlfriend had switched from the baseball-bat-wielding Boulderite and the golf club was just along to help. The Boulderite could not stand being stood up by Erikami.

The preacher tried to send a letter to the family to let them know that Aaron had accepted Jesus and was now in heaven. The Boulder Judge got the letter and was very angry at the preacher for trying to send the letter, however, the preacher is not afraid of Satan himself, much less the Judge.

End of story – NO! Not yet!

After the trial, and the man had confessed to "bashing out Aaron's brains while he was on his bed", was placed in the same jail cell that Aaron had said was very warm. Again not knowing who he was, the prayer group was seated at their tables at 8:30PM.

The man walked up to the group and asked if he could talk to the Preacher. The two of them went over to a separate area and the man asked the preacher if he knew a man named Aaron Tuneberg. The preacher told him he did. He then told the preacher that he was the one that had murdered him. He asked the preacher if he thinks there is any way God could forgive him and also Aaron's family forgive

him. The preacher told him we are all guilty of the death of God's Son on the cross and I know if you really repent, confess, and ask in faith believing, God will forgive you of all your sins. As for Aaron's family forgiving you, that remains to be seen.

So the two of them went to the same room, to the same bunk where Aaron accepted the Lord and this evil Boulderite with tears flowing down his face, confessed his sins to God and was forgiven and saved. You could see his dead eyes come to life.

Shortly after, he was moved to another prison where we heard that the prisoners almost beat him to death. The law of sowing and reaping is still in effect even if a person gets saved.

End of story – NO, Not yet!

The preacher who was arrested on the day of Pentecost in Missouri had his trial start on the 14th day of April which was Passover and he was put in the "bubble" during trial. The bubble is a confined space that holds about ten men or so. The door of the bubble opened and a man walked into the cell. Then the doors opened to allow inmates to go out for a short break. The new inmate walked over and asked the preacher if he could talk. He asked him if he knew a man named Aaron Tuneberg. The preacher told him he did. He told the preacher that he was the other person who was in the room that night. He said, "I did not kill him but I beat his body with the golf club. Do you think God could forgive me?"

Again, the preacher, with his bible went through the scriptures and that man knelt down and repented of his sins, putting his faith and trust in the Lord. He also asked if he thought the family would forgive him. Another letter was taken to the judge and again the preacher was in hot water. Looks like the preacher likes hot water. Maybe he should brush his teeth with shoe polish since he's always putting his foot in his mouth.

Anyway, the preacher did not get the name of the two Boulderites as it would not be proper. God is the one who will receive the glory over this. In heaven, Aaron and these two men will be very good friends. All we can pray for are the rest of the people involved in this situation. Even the Judge and District Attorney might come to know the lord if they are not saved.

Please pray for the preacher. He has an appeal coming up with his case. He was convicted of kidnapping. His son was taking his young boy away from an abusive situation and they both were given in excess of 30 years prison. God knows what will take place. My desire is to be where God can use me and bring glory to Him in these last days.
