GREETINGS! God bless you and yours! These are interesting times. It has been since 3 April 2019, that I received the EX PARTE ORDER of THE UNIVERSAL SUPREME COURT OF THE TSILHQOT'IN; International Aboriginal Court and the Letter of Delegation from the Chilcotin National Congress. You may not be familiar with the sum and substance thereof, but none-the-less suffice to say that after I received them it is foregone conclusin that the BOP and DOJ are willfully in dishonor and they have moved me next door to the compound a move that has some benefits and several negatives. Could this be due to the fact that I immediately reached out to NOTICE the judges in chambers and the US Secret Service for intervention, as these agencies holding me is a violation of the "diplomatic immunity" due me as Chilcotin Nation's Ambassador to Scotland.

Now I know that this may not mean much to you at this time, but suffice say that in terms of Administration of Law they are on NOTICE of the Order and my standing and HONOR is past-due and owing with prejudice, which means that a full settlement of the terms and conditions of the EX PARTE ORDER and of the Honor due under diplomatic terms of the Treaties that bind the U.S. and the Honorable Court and the Chilcotin National Congress.

I realize that page 1 is probably way beyond meaningful at this time but I just had to tell someone what is going on in these parts. Copies of the Order and the Letter of Delegation have been provided for Sen. Charles Grassley of Iowa; Sen. Joni Earnst of Iowa and other officials who have expressed an interest in the injustice that I have been suffering for 22+ years now.

My appeal to the International Aboriginal Court is on authority of the treaties that U.S is bound to with the Chilcotin Nation and the United Nations. It is of greater authority than the bankrupt UNITED STATES and its US DISTRICT COURTS, and otherwise that have falsely imprisoned me all these yrs as the Int'l Court recognized on appellate review, I am due, past-due and owing my liberty long ago. May the LORD move this mountain!!!

You most likely have no idea but I have friends in Texas and in Kansas who cannot write me nor can I write or call them for evil censorship reasons and otherwise undefined. I hold up all in my prayers day and night and know that our Lord Jesus Christ hears our prayers and knows all and surely knows of the generous support and prayers that these dear ones share, as well. I hope and pray that our prayer warriors are held up in highest esteem with the best that the LORD has called. Our prayers are the most powerful thing that we do for the sake of the Kingdom and for each and all of us.

My story is before President Trump's effort for justice, "Marshal's Project" and in the Senate Judiciary Committee seeking reform of the Judicial and Criminal Justice system. Family is engaged in seeking reform that is meaningful and will lead to liberating many who have been so abused.
