<p>* BRIEFLY DESCRIBE THE BASIS OF YOUR APPEAL: "A prisoner shall be afforded ... at a fact finding hearing: (a) To ... speak on his or her own behalf." R 791.3310 (in relevant part). PD 03.03.105 on Class II misconducts mandates that, a rehearing SHALL be ordered if any of the following are found to have occurred: (1) The hearing was not conducted pursuant to Department policies and procedures and the departure from policy and procedures resulted in material prejudice to the prisoner; (2) The prisoner's due process was denied; and (3) The decision of the Hearing Officer is not supported by the evidence on the record." PD 05.03.105, Sec. _____.</p> <p>* At the 21 SEPTEMBER 2025 Misconduct Hearing, I attempted to explain to Lt. Hudson that during the missed KOP Callout, I was rendered unconscious by an event of POSTPRANDIAL HYPOTENSION TRIGGERED ATRIAL FIBRILLATION (Acute Heart Failure) like the one described on page 4 of the EXHIBITS where I went into syncope, and became                      (continued on pages 2-4)</p>

MISCONDUCT (10 SEP 2025) #2; OUT OF PLACE:

[1/2] cyanotic (blue) and diaphoretic (heavy sweating) (EXHIBIT HFAH Medical Record, p. 4). Lt. Hudson cut me off every time I tried to speak and would not take the 4 pages I attempted to hand her as evidence of POSTPRANDIAL HYPOTENSION TRIGGERED ATRIAL FIBRILLATION (PHTAF) (EXHIBIT, pp. 4, 14, 20-24) (Check Body Cam). I cannot recall anything other than Hudson obstructing me speaking and her refusing to take my presented documents, which was very confusing. Hudson's refusal to let me "speak on [my] own behalf" violated Administrative Rule 791.3310. It also denied procedural due process, MATHEWS v ELDRIDGE, 424 US 319, 335 (1976). Such denial of Due Process requires that a "rehearing shall be ordered.". MCL 792.254; PD 03.03.105.

\* Hudson was also unduly biased, and committing age, ethnic, and gender discrimination. A hearing officer making a decision on another person at a hearing is held to the same standard as a judge, as follows:

\* Due process requires a neutral and detached judge in the first instance. That officers acting in a judicial capacity or quasi-judicial capacity are disqualified by their interest in the controversy to be decided is, of course, the general rule. Before anyone may be deprived of a protected interest, whether in a criminal or civil setting, one is entitled as a matter of due process of law to an adjudicator who is not in a situation which would offer a possible temptation to the average [person] as a judge . . . which might lead him/her not to hold the balance nice, clear and true..... Even appeal and trial de novo will not cure a failure to provide a neutral and detached adjudicator. CONCRETE PIPE v CONST. LABORERS, 508 US 602, 618-619 (1993) (citations omitted).

Hudson was not the required neutral and detached decisionmaker. [2/3] This, therefore, denies Due Process, and "a rehearing shall be ordered." MCL 791.254; PD 03.03.105.

\* EXHIBITS at pages 4, 5 to 25 prove that Northington has a long history of PHTAF from around 1970 to the present from exposure to Agent Orange in his 2.5 years with a Vietnam Supports Group. It's not like he dreamed something up. The PHTAF events listed on page 14 were aggravated by Warden Brian MORRISON'S DRUG ADDICTS spraying Northington in the face with a Fentanyl loaded perfume atomizer. It was MORRISON-TRIGGERED PHTAF (Acute Heart Failure). As EXHIBIT page 14 says, Northington was in Acute Heart Failure during the the alleged Misconduct Event. It's MORRISON'S failure to keep his Administration from bringing drugs into JCF. Putting Northington into a situation that he would not voluntarily be in such as described is "entrapment.". PEOPLE v TURNER, 390 Mich 7, hn. 1 (1973). Entrapment is a denial of Due Process, TURNER, at 7, under which courts refuse to allow convictions." This, therefore, denies Due Process and "a rehearing shall be ordered." MCL 791.254; PD 03.03.105.

\* Northington is Hearing Impaired (EXHIBIT, pp. 20-24, 26). Wearing Hearing Aids in a Housing Unit which has an 80 to 100 decibel Noise Level destroyed his Hearing Aids and they had to be repaired, and returned a month later on 22 FEBRUARY 2023 (EXHIBIT, p. 24). If the Housing Unit Noise [3/4] Level is 80 decibels, then putting on a Hearing

Aid will raise the Noise Level in the Human Ear to 100 decibels. Normal conversation is 50 decibels, a lawn mower is 90 decibels. Any noise level of 85 decibels damages hearing with prolonged exposure (ESSENTIALS OF PSYCHOLOGY, Jeffrey S. Nevid, pp. 99-100). Lt. Hudson knows absolutely nothing about Noise Levels or Medicine; I do because it's my career field. Hudson ordered me to have my Hearing Aides in while in the 80 to 100 decibel Noise of H-Unit. I said, "That will injure my Hearing." HUDSON angrily snapped, "I don't care (emphasis added)." HUDSON violated WORK RULE 1 and PD 03.03.130 on Humane Treatment requiring her discharge. WORK RULE 27. HUDSON denied Due Process and "a rehearing shall be ordered;" the PA System in H-Unit cannot be heard over the Excessive Noise. USCA 14; PD 03.03.105.

\* HUDSON'S aforesaid actions are disability discrimination in violation of 42 USC, Secs. 12101 et seq., and MCL 37.1101. "A rehearing shall be ordered" for Due Process violation. USCA 14; PD 03.03.130. Northington's HEARING IMPAIRMENT and PHTAF (Acute Heart Failure) are disabilities.

\* THEREFORE, you should dismiss or grant rehearing of the 21 SEPTEMBER 2025. OUT OF PLACE MISCONDUCT.

MISCONDUCT (10 SEP 2025) #3; OUT OF PLACE:

From: Gary M. Northington 193035 H44 11 SEP 2025  
TO: Hearing Officer, JCF (Lt. Hudson)

\* H-Unit is so noisy in the P.M., with Super Radios blasting and prisoners yelling (Gr JCF-24-03-0420-03F) (#471) (06 MAR 2025), that we cannot hold voice level conversations. I cannot wear my Hearing Aids in such noise; it's painful, nor hear the P.A.

\* On 10 SEPTEMBER 2025 from 1420 to 1530 hours, I sat in H-Unit waiting for KOP LINES. I asked one of 4 officers, have KOP LINES been called?" I heard, "No." I was going into Atrial Fibrillation which JCF Medical has refused to treat (Gr JCF-24-02-0411-281) (#437) (13 FEB 2024) (Gr JCF-09-1813-12D1) (#487) (29 AUG 2025), caused by eating lunch. I kept trying to get up from my seat to tell someone, but I could not see to relate to things around me; sounds were distant. I never heard KOP LINES called, no officer brought the KOP SIGN around, and NO KOP CAME OVER MY PAGER (check your system). You are punishing me for disabilities JCF Medical refuses to treat, and JCF STAFF NOT DOING THEIR JOBS; a denial of Due Process (#487 above).

\* I have daily POSTPRANDIAL HYPOTENSION TRIGGERED ATRIAL FIBRILLATION causing syncope (loss of blood flow to brain) (#s 437 & 487 above). McLAREN HOSPITAL said I need a PACEMAKER but MDOC said, "No" (04 JUL 2019).

\* It is abusive to sanction me for disabilities MDOC caused and refused to treat; a denial of Due Process. At ticket review, I told Sgt. Payne, "I cannot understand a word you are saying. You have to speak louder!". I believe he did not read the ticket to me but I'm not sure. The only word I heard was, "hearing," and I said, "Yes." I took 2 Nitroglycerin tablets on the walk to see Payne because of severe Angina and SOB.

\* On 21 SEPTEMBER 2025, I told Lt. HUDSON, "I cannot hear well in H-Unit with or without Hearing Aids because the Noise Level is dangerously high (80-100 decibels) and injures my hearing." The "Aids cause severe pain in my ears in such noise. Such noise damaged my Hearing Aids. HUDSON said, "Turn them down." I answered, "They are as low as they can go." Somewhere around this point, HUDSON left the Control Center window and switched her Body Cam. I repeated, "Wearing Hearing Aids in the excessive noise of H-Unit is painful and damages my hearing." HUDSON shouted angrily, "I don't care" (see requested Body Cam."

\* A Hearing Aid merely amplifies 80 decibel noise to an extremely injurious 100 decibels (my career field). Lt. Hudson is not qualified to make such medical/disability decision; I am with a 4.0 GPA.

\* Normal conversation is 50 decibels. Every P.M., the noise level in H-Unit is 80 to 100 decibels with 3-foot hurricane fans going full speed, Boom Boxes at about 110 decibels, and prisoners yelling, which reverberates into a mush of noise because the acoustic ceiling tile was deliberately removed. Prolonged noise level above 80 decibels is injurious to human hearing (Essentials of Psychology, pp. 99-100, Jeffrey S. Nevid, 2017). The Unit noise level previously blew out my Hearing Aids at 100 decibels (Special Accommodation). HUDSON'S hatred effectively said I should destroy my Hearing and Hearing Aids.
