Its been this way all my life. I at least knew what to do: ice in a plastic bag, sitting in an upright position, stay relaxed calm, breath slowly/deeply, go in deep relaxed prayer with God/Jesus /both, after taking a glass of water. you will slip into a drowsy deep sleep under a warm blanket as you slowly pass the plastic bottle or bag of ice over your vages nerve cluster at the base of your skull and moving it over the hot areas of your neck-ears-Face-and skull, mostly on the left side of your head. I have been learning first hand after more than 14 stroke incidents. I am fine this morning of the 12th of Nov. but will go to Sick Call and have my increasing skipping heartbeats checked out by untrained Nurses assistants. Page Four

What's really unique about my health will is that I am really very healthy my heavy duty work habits are almost daily except for the Sabbath, which belongs to God and after a year of near death experiences caused by staff, I have returned to good health, with the exception of malnutrition caused by B.O.P. agenda with deliberate indifference in assisting me to die. I have had lower bunk and lower tier status by law since I came into the B.O.P. by law. and with the stroke I had last night and medical gaslighting me trying to convince me that I am denying them from doing their job to help me, I told him that the Healthcare P.A.s and N.A. are not qualified to assist me correctly and they aren't. I need an internist and there are none here. So I am sitting like a homeless man with all his possessions in bags on the floor waiting for a bunk and where I won't get seriously hurt.
