- c. Please describe, including the title, if you can recall it, the last movie you watched anywhere and your response to it.
- d. Please recount the first time you ever rode or saw somebody riding a bike.
- e. In your history or present day, is there a body of water that you have a relationship to (i.e. lake, sea, ocean, river, stream, pond, gulf, wash, bay)? Please describe it.
