CHAPTER 3, SECTION 4A OF THE AKC'S RULES APPLYING TO REGISTRATION AND DISCIPLINE STATES THE FOLLOWING: "MAY BE REQUESTED FOR A DOG WHEN APPLICATION FOR INDIVIDUAL REGISTRATION OF THE DOG IS SUBMITTED, PROVIDED THE APPLICATION, TOGETHER WITH A REQUEST FOR SUCH LIMITATION, IS FILED BY THE OWNER(S) OF THE LITTER AT BIRTH.

NO OFFSPRING OF A DOG FOR WHICH HAS BEEN GRANTED IS ELIGIBLE FOR REGISTRATION. EACH REGISTRATION CERTIFICATE FOR SUCH DOG SHALL CARRY NOTICE OF THE LIMITATION, AND THE LIMITATION SHALL CONTINUE, REGARDLESS OF ANY CHANGE OF OWNERSHIP, UNLESS AND UNTIL THE OWNER(S) OF THE LITTER AT BIRTH SHALL APPLY TO AKC FOR REMOVAL OF THE LIMITATION." A DOG REGISTERED WITH AN AKC LIMITED REGISTRATION SHALL BE INELIGIBLE TO BE ENTERED IN A BREED COMPETITION IN A LICENSED OR MEMBER DOG SHOW. IT IS ELIGIBLE, HOWEVER, TO BE ENTERED IN ANY OTHER LICENSED OR MEMBER EVENT. THESE EVENTS INCLUDE: OBEDIENCE, RALLY, AGILITY, TRACKING, FIELD TRIALS, HUNTING TESTS, HERDING, LURE COURSING, EARTHDOG, FAST CAT, CAT, SCENTWORK, JUNIOR SHOWMANSHIP, TRICK DOG AND CGC.

LIMITED REGISTRATION IS DETERMINED BY THE LITTER OWNER(S). THE LITTER OWNER(S) CHECK THE LIMITED BOX ON THE AKC DOG REGISTRATION APPLICATION.

LIMITED REGISTRATION CERTIFICATES ARE WHITE WITH AN ORANGE BORDER; THE FULL REGISTRATION CERTIFICATE IS WHITE WITH A PURPLE BORDER.

LIMITED REGISTRATION CAN BE CHANGED TO FULL REGISTRATION ONLY BY THE LITTER OWNER(S). THE LITTER OWNER(S) WILL NEED TO OBTAIN THE APPLICATION TO REVOKE LIMITED STATUS. THAT FORM WILL THEN NEED TO BE COMPLETED AND SENT TO OUR RALEIGH ADDRESS WITH THE PROCESSING FEE. AFTER PROCESSING, WE WILL SEND A FULL REGISTRATION CERTIFICATE TO THE DOG'S OWNER. LIMITED REGISTRATION HELPS BREEDERS PROTECT THEIR BREEDING PROGRAMS. IF BREEDERS DO NOT WANT PUPPIES USED FOR BREEDING PURPOSES, THEY CAN REQUEST THE OPTION FOR THOSE PUPPIES.

THE AMERICAN KENNEL CLUB DOES NOT LICENSE OR ENDORSE ANYONE ENGAGED IN THE COMMERCE OF SELLING PUREBRED DOGS AND, THEREFORE, HAS NO CONTROL OVER THE BUSINESS PRACTICES OF THOSE INVOLVED IN SUCH TRANSACTIONS. MEMBERSHIP IN THE AMERICAN KENNEL CLUB IS COMPRISED OF INDEPENDENT DOG CLUBS LOCATED THROUGHOUT THE UNITED STATES. NO INDIVIDUAL PERSONS ARE MEMBERS OF THE AKC.

THE AKC WILL NOT BECOME INVOLVED IN DISPUTES CONCERNING 'FULL' OR 'LIMITED' REGISTRATION OF A DOG. THESE DISPUTES MUST BE RESOLVED BY THE PARTIES INVOLVED IN THE SALE OF THE DOG.

PICKING ORDER FOR FUTURE LITTERS:

THE WAY THE PICKING WILL GO IS IN THE ORDER OF DEPOSITS RECEIVED.

1ST PLACE WILL BE ABLE TO CHOOSE A PUPPY WHEN THE PUPPIES ARE 7 DAYS OLD. THEY WILL HAVE 1 FULL DAY (MIDNIGHT TO MIDNIGHT) TO CHOOSE.

2ND PLACE AND SO ON WILL HAVE AT LEAST 1 FULL DAY. THIS MEANS FOR EXAMPLE SELLERS TELL THE BUYER(S) IT IS BUYER(S) TURN TO CHOOSE AT 5 PM ON WEDNESDAY BUYER(S) WILL HAVE UNTIL MIDNIGHT THE FOLLOWING DAY TO CHOOSE.

AFTER EVERYONE IN FRONT OF BUYER(S) NUMBER HAS CHOSEN, SELLERS WILL LET BUYER(S) KNOW IT IS BUYER(S) TURN. DON'T WORRY SELLERS WILL LET BUYER(S) KNOW SO BUYER(S) DON'T HAVE TO WORRY ABOUT MISSING BUYER(S) TURN.

- BUYER(S) CAN CHOOSE BASED ON THE PHOTOS/VIDEOS ON INSTAGRAM OR BUYER(S) CAN COME AND CHOOSE IN PERSON. BUYER(S) CHOICE.

- IF BUYER(S) DO NOT CHOOSE IN BUYER(S) TIME SLOT, IT DOES NOT MEAN BUYER(S) DON'T GET A PUPPY IT JUST MEANS THE NEXT FAMILY/FAMILIES GET TO CHOOSE AT THE SAME TIME AS BUYER(S). THIS DOES MEAN THEY MAY PICK THE 1 BUYER(S) WANT. IF BUYER(S) DO NOT CHOOSE, SELLER'S WILL SAVE BUYER(S) THE LAST ONE.

- IF BUYER(S) HAVE PLACED BUYER(S) DEPOSIT AFTER THIS HAS ALREADY HAPPENED IGNORE MOST FROM ABOVE. BUYER(S) ARE MOST LIKELY PLACING BUYER(S) DEPOSIT ON A SPECIFIC PUPPY ALREADY WHOM BUYER(S) HAVE ALREADY FALLEN IN LOVE WITH. IF BUYER(S) ARE NOT AND BUYER(S) DON'T KNOW WHAT PUPPY BUYER(S) WOULD LIKE SELLER'S WILL RESERVE UNTIL MIDNIGHT THE FOLLOWING DAY FOR BUYER(S) TO PICK. THIS WAY BUYER(S) HAVE TIME TO COME AND SEE IN PERSON IF BUYER(S) SO CHOOSE.

- BUYER(S) INITIALS BELOW CERTIFY THAT BUYER(S) HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENT.
