# CALL FOR NOMINATIONS

## National Student Officers 2017-2019

Are you interested in running for the position of National Student Officer for the 2017-2019 term?  
Herewith the guidelines to apply.

### PRESIDENTIAL SLATE

The President, Secretary, Treasurer & Advisor run as a slate and must be from the SAME College/University.

#### Requirements / Guidelines

- ◆ Letter of Intent from the Chapter running for Presidential Slate (President, Secretary and Treasurer) must be submitted to the Alpha Phi Sigma Headquarters [no later than January 27th, 2017](#).
- ◆ The Letter of Intent shall bear the signatures of the Chapter Advisor, the Chief Administrator of the Department, and the Chapter President. These signatures are necessary and will indicate that support will be given to the nominated National Student Officers.
- ◆ A Letter of Willingness from the Chapter Advisor to run for the National Advisor for a 2-year term, along with the nominated slate.
- ◆ Chapter submitting a letter of intent to run for national officers must be in *good standing*. Headquarters must have the Chapter's Bylaws, Financial Report, and Activity Report on file. Also, Chapter dues must be current.

### VICE PRESIDENT SLATE

The Vice President & Advisor run as a slate and must be from the SAME College/University.

#### Requirements / Guidelines

- ◆ Letter of Intent from the Chapter running for Vice President must be submitted to the Alpha Phi Sigma Headquarters [no later than January 27th, 2017](#).
- ◆ The Letter of Intent shall bear the signatures of the Chapter Advisor, the Chief Administrator of the Department, and the Chapter President. These signatures are necessary and will indicate that support will be given to the nominated National Student Officer.
- ◆ A Letter of Willingness from the Chapter Advisor to run for the National Advisor for a 2-year term, along with the nominated Vice-President.
- ◆ Chapter submitting a letter of intent to run for national officers must be in *good standing*. Headquarters must have the Chapter's Bylaws, Financial Report, and Activity Report on file. Also, Chapter dues must be current.

⇒ Presidential Slate and Vice-President Slate must be from DIFFERENT Colleges/Universities.

⇒ Nominations shall be announced on the Alpha Phi Sigma website and if time permits in [The Docket](#).

CAMPAIGNS may begin after acceptance, but no sooner than [October 1, 2016](#).

### Elections will be held at the 2017 National Conference in Kansas City, Missouri

The 2017 Annual Chapter Dues, Financial Reports and Activity Reports must be received prior to March 1st, 2017 in order for chapters to vote in the March 2017 National Student Officers elections.

## NSU's Online Criminal Justice Program Named one of the Nation's Best for Veterans

Once again, **Nova Southeastern University (NSU)** has been recognized for providing students with one of the nation's top online academic programs. *U.S. News & World Report* has released its rankings of top online graduate programs for veterans, and NSU's Criminal Justice program was ranked in a tie for 21<sup>st</sup>.

"For more than 50 years, NSU has worked hard to create programs that provide academic opportunities for students that meet their varied needs," said George Hanbury, Ph.D., President and CEO of NSU. "One segment of our student population that's growing is our veterans, and we want to ensure we provide them with educational opportunities that best suit their needs as they transition back to civilian life."

Dr. Hanbury said that this latest honor is in keeping with NSU's Vision 2020, where the university will be recognized by accrediting agencies, the academic community and the general public as a "premier, private, not-for-profit university of quality and distinction." This is the second time NSU's criminal justice program has been recognized by *U.S. News & World Report* – earlier this year the online program for all students was ranked 22<sup>nd</sup> in the country.

This is the third year that *U.S. News & World Report* has issued these rankings, which identify programs that provide veterans with high-quality, flexible online educational options. According to the report, to be eligible, programs had to be part of an institution of higher learning that is certified for the GI Bill, be participating in the Yellow Ribbon Program or be a public institution that charges in-state tuition for out-of-state veterans. In addition, to be ranked, a school had to be part of the top 75% of schools in the overall 2015 Best Online Programs rankings by the publication (NSU was in the top 22 programs overall.)

"We've worked hard to position our criminal justice program as one of the premiere programs online and I'm very proud of this recognition," said Kimberly Durham, Psy.D., dean of NSU's Institute for the Study of Human Service, Health and Justice. "It's a reflection of the program's faculty – they are truly at the heart of what distinguishes our program from others."

NSU's criminal justice graduate program is unique as it's offered entirely online. This format allows students to participate in courses from anywhere in the world and provides flexibility in completing a master's degree while providing time for students to continue their current career if need be. NSU's master's program in criminal justice is designed for those interested in careers in several areas, including, but not limited to: police officer; detective; FBI special agent; DEA agent; Secret Service special agent; Immigration and Customs Enforcement (ICE) special agent; and Federal Air Marshall.

Putting the spotlight on wrongful convictions



Justice may be blind, but it isn't perfect. In the Canadian legal system, it's not asked that someone be found absolutely and undeniably guilty, only that their guilt is proven beyond a reasonable doubt. It's a standard that allows for some uncertainty, and it means that sometimes innocent people are held responsible for crimes they didn't commit. As the justice professionals of the future, the University of Guelph-Humber's Alpha Phi Sigma chapter, the Justice Studies honour society, drew attention to this problem with Wrongful Conviction Day on October 3<sup>rd</sup>.

In UofGH's atrium, they presented the stories of famous miscarriages of justice like Steven Truscott and David Milgaard, and encouraged UofGH students to rethink the stigma that comes from being a suspect or arrested.

The day is Alpha Phi Sigma's second annual Wrongful Conviction Day, which last year brought John Artis to campus, who was found guilty of murder alongside boxer Rubin "The Hurricane" Carter in the 1960s and later exonerated.

"We learn that our justice system is nearly perfect, but of course it has its flaws," says Sandy Labib, President of Alpha Phi Sigma. "Somebody can be found guilty based on incorrect facts or bias, and we want to raise awareness about that."

The most stunning recent example of this comes from Maria Shepherd, who was Wrongful Conviction Day's keynote speaker this year at UofGH. For 25 years, Ms. Shepherd was considered guilty of manslaughter, but in a subsequent appeal, her name was cleared in just a few minutes. She spoke to the UofGH audience about how it happened.

In April of 1991, Ms. Shepherd's three-year-old step-daughter began vomiting, gasping for air and fell into a coma. She was rushed to the hospital but nonetheless died two days later. A subsequent autopsy by pediatric pathologist Dr. Charles Smith claimed that she had died as a result of abuse, and so Ms. Shepherd was charged with manslaughter and held responsible for her step-daughter's death.

Though she was innocent, Ms. Shepherd was up against the expert testimony of Dr. Smith, which was described as the "linchpin" of the crown's case. She was worried about the threat of a long sentence and that the Children's Aid Society would take away her three other children. These factors led her to plead guilty to the crime, and she was subsequently sentenced to two years in prison. For the 25 years since, she's been considered guilty of killing her child.

It wasn't until 2007 that Dr. Smith's work was placed under scrutiny. His methods were reviewed by other professionals who concluded that Dr. Smith's findings were wrong and that his opinions were "unreliable in the extreme" and "inappropriate and misleading". He was stripped of his medical license, and the incident led to a reconsideration of the credibility of expert testimony. When Ms. Shepherd had her appeal this February, with new evidence after the revelations about Dr. Smith, her conviction was overturned.

"We're hoping that hearing Ms. Shepherd's story gives everyone a different perspective on our legal system and its process," says Miss Labib. "People need to understand these problems and how they can happen. Just because someone is labelled as a criminal doesn't always mean it's true.

Ms. Shepherd spoke along with her son, Jason, about the experience of her conviction and the fallout it had on her life, her family, and what's changed since her appeal.


