COVID-19 UPDATE

ATTENTION ADVISORS & STUDENT MEMBERS Membership Processing & Honor Regalia Orders

Due to the uncertainty of colleges and universities reopening their campuses, Alpha Phi Sigma will continue to work with each chapter advisor to determine the best course of action for membership applications and honor regalia orders this coming fall.

Alpha Phi Sigma remains committed to customer service. We will make sure students continue to receive their membership packets and honor regalia orders in a timely fashion.

For those advisors who will be working remotely, we will continue to receive applications and orders via email. We will invoice the student directly and ship to their home. For advisors at schools that reopen, we will continue the standard method of shipping to the advisor at the school. Knowing that things may change at any time, we ask that you keep HQ informed of closings and shipping alternatives.

The current application for “online students” stipulates that we will ship directly to the member for a \$10 shipping and handling fee. We will use the same method for students who will not attend campus due to closures. Although we wish we could ship for free, APS is one of many non-profit organizations being financially impacted by the pandemic with furloughs and loss of revenue. We count on membership and regalia orders for sustainability through the steadfast support of each and every advisor and member.

Honor Regalia orders will also be received via email from the advisor. We will invoice the member and ship directly to their home. Each student must complete an order form and include S&H listed on the form.

For students completing an application and ordering Honor Regalia at the same time, we will waive the S&H for the regalia. The shipping charge for the membership materials and regalia (regardless of pieces ordered) will remain at \$10.

Induction ceremonies, chapter meetings, and even community service projects are being conducted via zoom by many of our chapters. If your chapter has had success with one or more zoom meetings, please share the details with us so that we can share them with all our chapters.

Scholarships, Awards, and Grants will be accepted until the January 2021 deadline.

We are here to help you in any way we can and hope that we will continue to sustain our organization post this pandemic and for the next 80 years.

Navigating a World Pandemic: A Message from Your Executive Council

We will remember Jennifer as she was, full of love and dedication to her friends, family, and community.







ALPHA PHI SIGMA NAY-LATOCKI MILITARY VETERAN SCHOLARSHIP


Golden Alumni, Bill Nay, a Marine Corps Veteran, is very much involved with veteran affairs and other well-known groups and societies that benefit military veterans and their families. A historian in his own right, Bill traced his genealogy all the way back to the Revolutionary War. His latest project, much to the gratitude of the Alpha Phi Sigma National Capital Region Alumni Circle, is the creation and funding of a new Alpha Phi Sigma Scholarship. The Nay-Latocki Military Veteran Scholarship is an annual scholarship bearing the name of the Nay and Latocki families, both deep rooted in American Military history.

Bill wishes for the scholarship to continue the support of military veterans and he is working diligently to secure the funding necessary to award the scholarship perpetually. Alpha Phi Sigma has many members who are veterans and may become recipients of the scholarship.

What Else is Golden Alumni Bill Nay Up To??

Alpha Phi Sigma Golden Lifetime Alumni, Bill Nay, continues his great work with the California Society of the Sons of the American Revolution. Bill Nay was presented with the SAR Patriot Medal by President Robert Taylor. President Taylor bestowed this honor on Bill for all the work he has done in partnering with Scouts BSA and with the Sea Cadet (NSCC/NLCC) Programs. The Patriot Medal is the highest award presented to a Compatriot by a State Society and recognizes long, faithful, outstanding, and distinguished service at the state and/or chapter level. The Patriot Medal is awarded only by a State Society and may be presented only to an individual.



Description: The medal has a silver finish and bears the portrait of Compatriot General of the Army Douglas MacArthur on the obverse within the inscription, "The National Society of the Sons of the American Revolution." Compatriot MacArthur selected the design for the medal just prior to his death. He received the first medal, presented posthumously at his tomb in Norfolk, Virginia, on October 19, 1964, where it is on permanent display."

For Bill, this award has special meaning due to the connection to his father, William O Nay, who served in the US Navy in World War II as part of the 7th Fleet. There is a great book about the Theater in which his father served, "The Seventh Fleet and the Battle for the Philippines: MacArthur's Navy". Bill's Father assisted General MacArthur in the Liberation of the Philippines. It was indeed a privilege for Bill to receive this Medal named in his Honor. Bill Nay is thankful for all the Veteran Service Organizations that have been a part of the partnership with the American Legion, Sons of the American Legion, the American Legion Riders, VFW, AMVETS, and the Marine Corps League.

Fairmont State Professor and Alpha Phi Sigma Alumnus, Dr. John McLaughlin, funds scholarship for police officers to attend college



Fairmont State University professor Dr. John McLaughlin is working to help police officers looking to attend college by creating the Dr. John E. McLaughlin Police Scholarship.

McLaughlin, a criminal justice professor, grew up in Miami-Dade County, Florida, where he started his career in law enforcement after receiving his bachelor's degree. After 26 years, earning his master's and doctorate degrees, he retired as a lieutenant in the economic crime bureau heading up the Mortgage Fraud Task Force.

Inspired by the program in Miami-Dade County that allowed him to earn his degree, McLaughlin decided it was time to create a similar program at Fairmont State University. The scholarship will provide funding starting in fall 2020 for students who have worked at least two years as a city, county or state police officer to attend Fairmont State either part-time or full-time.

"I decided to donate to the Fairmont State Foundation after seeing a need in the policing community. This allows officers to get their education and become better officers," McLaughlin said. "Many of the local departments do not offer tuition reimbursement.

Fairmont State Foundation President Julie R. Cryser said law enforcement is such a noble profession. Having a scholarship that will allow those in the profession to further their education is a great resource. "We are so appreciative for the support that Dr. McLaughlin is providing for local police officers to ensure they are able to continue their education," she said. "We hope that others will join in this worthy effort to help our city, county and state police become even better educated."

Fairmont State University President Dr. Mirta Martin said a chance to help others continue their education is an incredible gift. "Our nation's police officers are professionals who selflessly protect our communities each and every day," Martin said. "They deserve the best our communities can offer in return, and via the Dr. John E. McLaughlin Police Scholarship, worthy law enforcement professionals will have the chance to further their education at Fairmont State – a school that truly appreciates their service."

McLaughlin completed his master's at Florida International University, where he began teaching part-time after he finished, and doctorate at Lynn University.


"Miami-Dade had a program where they provided tuition reimbursement for all employees. After you completed each course, they would reimburse you 50 percent of your tuition," he said. "For that reason, I started taking graduate classes and got into a routine and did not stop until I got my master's and doctorate. I was working two jobs while earning my doctorate. I used the money that I received from teaching and the reimbursements to pay for my education, so I did not have to take out loans."

In 2013, he came to Fairmont State University as a professor in the Criminal Justice Program, teaching police operations, criminal investigations, crime scene investigations, Spanish for law enforcement, terrorism, advanced criminal law and homeland security.

He also serves, for the past two years, at the Rivesville Police Department and is currently the police chief. "Being a police officer is an enormously rewarding career when you get to help people stay on track and not let them go down the wrong path in life," he said. "I also really like chasing and recovering stolen cars."

McLaughlin said that he would encourage others who can to give to support scholarships for law enforcement.

Dr. John McLaughlin is also the Editor of El Puente, the National Latino Police Officers Association Newsletter.




