IMPORTANT ATTENTION ADVISORS

Dear Advisors, we'd like to share some very important information with you.
Please review the following documentation attached and mentioned in this cover letter:

NEW GPA REQUIREMENT

Alpha Phi Sigma is a nationally accredited honor society. The accrediting body, *The Association of College Honor Societies*, recently amended the undergraduate grade point average for all accredited honor societies. The new GPA is reflected in their bylaws and therefore in ours. Alpha Phi Sigma must comply with the following changes to maintain compliance.

"A certified member society in the specialized classification may receive into membership students who rank no lower than the highest 35 percent of their class or, if class rank is unavailable, a cumulative grade point of at least 3.3."

In the case of Alpha Phi Sigma, the cumulative GPA of a 3.2 **MUST** be accompanied by class ranking of no lower than the top 35%.

If your student does NOT rank in the top 35%, the student MUST have a cumulative GPA of 3.3 or higher.

At this time, Alpha Phi Sigma will continue to accept the Criminal Justice courses GPA of 3.2 until further notice.

PRESIDENTIAL SLATE

The President, Secretary, Treasurer & Advisor run as a slate and must be from the SAME College/University.

Requirements / Guidelines

- Letter of Intent from the Chapter running for Presidential Slate (President, Secretary, and Treasurer), must be submitted to the Alpha Phi Sigma Headquarters no later than January 31st, 2025.
- The Letter of Intent shall bear the signatures of the Chapter Advisor, the Chief Administrator of the Department and the Chapter President. These signatures are necessary and will indicate that support will be given to the nominated Executive Student Officers.
- A Letter of willingness from the Chapter Advisor to run for Executive Advisor for a 2-year term, along with the nominated slate.
- Chapter submitting a letter of intent to run for Executive Student Officers must be in *good standing*. Headquarters must have the Chapter Bylaws, Financial Report, and Activity Report on file. Also, Chapter dues must be current.

VICE PRESIDENT SLATE

The Vice President & Advisor run as a slate and must be from the SAME College/University.

Requirements / Guidelines

- Letter of Intent from the Chapter running for Vice President, must be submitted to the Alpha Phi Sigma Headquarters no later than January 31st, 2025.
- The Letter of Intent shall bear the signatures of the Chapter Advisor, the Chief Administrator of the Department and the Chapter President. These signatures are necessary and will indicate that support will be given to the nominated Executive Student Officer.
- A Letter of willingness from the Chapter Advisor to run for Executive Advisor for a 2-year term, along with the nominated Vice-President.
- Chapter submitting a letter of intent to run for Executive Student Officers must be in *good standing*. Headquarters must have the Chapter Bylaws, Financial Report, and Activity Report on file. Also, Chapter dues must be current.

- ⇒ Presidential Slate and Vice-President Slate must be from DIFFERENT College/University.
- ⇒ Nominations shall be announced on the Alpha Phi Sigma website and if time permits in The Docket.
- ⇒ CAMPAIGNS may begin after acceptance, but not before October 1, 2024.

Elections will be held at the 2025 Conference in Denver, CO.

The 2025 Annual Chapter Dues, and the Financial and Activity Reports for 2024 must be received prior to March 1st, 2025 for chapters to vote in the March 2025 Executive (National) Student Officers elections.

Alpha Phi Sigma Chapter Advocacy Grants \$250

There are many organizations that work within or with the Criminal Justice System to help individuals.

When a Chapter engages with an organization in their community that provides a service or services within the Criminal Justice System helping adults or juveniles, Alpha Phi Sigma will donate \$250 to the organization.

GUIDELINES

1. Locate an agency in your area that provides a service within the Criminal Justice System: Adult or Juvenile.
2. The Chapter must engage in an activity with the agency.
3. Visit our website and click on the link for the advocacy grant, located under the scholarships tab. You will be directed to the online application where you will submit a brief write-up about the organization, full name and address of the organization, name of a contact person, and a photograph of Chapter members engaging in an activity with the organization.
4. Once the information is approved, the Chapter Advisor will receive from Headquarters an Alpha Phi Sigma check for \$250 payable to the Advocacy Organization.
5. Alpha Phi Sigma members must return to the organization and present the check on behalf of Alpha Phi Sigma through their Chapter.
6. The original story and photographs of the activity along with the photograph of the funds presentation submitted to Headquarters will be featured in the Docket.
7. Only one check per Chapter will be issued per calendar year. Chapters petitioning for a second advocacy grant the following year must choose a different advocacy group from the previous year.

♦ The Advocacy Grant cannot be used as the Theme of the Year or a Chapter Goal.

2025 Chapter Annual Dues Notice

Mu Psi Chapter



The Alpha Phi Sigma MU PSI Chapter at Stevenson University has been very active this semester. These photos are from a department wide event, Code Blue-Beyond The Line. The E-Board members invited expected inductees and ambassadors, who played a significant role in the success of the event. These students served as organizers, poster presenters and/or student presenters during the event.



Code Blue-Beyond The Line is a student organized event designed to repair broken relationships with criminal justice professionals. This event fostered meaningful dialogue between Police Chiefs, Community Police Officers, a Sexual Assault Forensic and Human Trafficking Nurse Practitioner who implemented SAFE programs through the country, Defense and States Attorneys, Federal Level Investigators and a retired Shooting Police Sergeant who was paralyzed after being shot in the line of duty.

In November 2023, we hosted an internship readiness event where we invited students and experts to share advice and provide insight on how to obtain a criminal justice internship and how to excel in it. This event was successful as we received positive feedback where students felt they were better prepared for their future internships.



Throughout the year, we had informational booths and in-class visits across Stevenson University to make Alpha Phi Sigma's presence known on campus. These booths provided students, criminal justice or not, with information about the honor society, upcoming events, and opportunities for involvement.

Another initiative that we did this year was grow opportunities for involvement in the honor society. We created the role of ambassador, where students in this role are responsible for providing support at events, attending student government meetings, and representing APS at open houses. This initiative is geared towards younger students as it provides them with insight to APS and its fundamental principles of academic excellence, service, unity, and leadership.



On April 24, 2024, we held our induction ceremony where we inducted 14 new members into Alpha Phi Sigma. The induction ceremony was primarily led by the executive board, in which Anna, Malick, and myself collaborated to plan, organize, and lead the event. The induction ceremony earned high remarks and positive feedback from Stevenson's Criminal Justice Program Coordinator, Hillary Michaud, the inductees, and the guests. Above all, we are excited to have been able to induct 14 highly qualified students from Stevenson into APS. Georgia Gwinnett College

Georgia State Trooper Jimmy Cenescar

Jimmy Cenescar was in his last semester and was due to graduate last May from Georgia Gwinnett College. The college granted his degree posthumously at graduation (copies of his degree were given to his parents and his fiancée).

Deputy Cenescar qualified for membership and the Chapter Advisor, Dr. Marie A. Ratchford submitted the application. Alpha Phi Sigma awarded Jimmy Cenescar posthumous membership.

It is an honor to have Deputy Jimmy Cenescar as an Alpha Phi Sigma member. Our heartfelt condolences to his family and fiancée.

ATLANTA - Family and friends said their final goodbyes on Friday to a Georgia state trooper killed in a crash in the line of duty.

Georgia State Trooper Jimmy Cenescar died after a crash on Sunday, Jan. 28, while attempting to stop a motorcycle for a traffic violation on Interstate 85. Cenescar's vehicle left the road and struck an embankment. Emergency personnel responded and attempted life-saving measures before he was rushed to Northside Gwinnett Hospital where he passed away.

"Anything that he said he was going to do, he always did," his fiancé Natalia said. "And he followed through."

A procession of officers escorted his casket to Mount Paran Church in Buckhead, carried by horse and carriage and draped with an American flag.

"Even though he's not with us, we will always feel his love," his fiancé said. His brother told mourners that as a kid, he wanted to be an astronaut when he grew up.

But policing was his life's passion. "Jimmy passed doing what he loved," his brother said. "That's something that you guys need to understand, that's something he loved."

The trooper's remains were transported to Mableton where he was laid to rest Friday afternoon. Cenescar was born in Haiti and was inspired by his aunt to pursue his law enforcement career. In 2021, he was credited with risking his own safety to save a man's life who had driven a car off a cliff in northwest Atlanta. "I knew I had to take action quickly to get that driver out of the vehicle because I knew there were train tracks," said Cenescar, who worked with the Atlanta Police Department at the time.

Reaction to Cenescar's death came in from across the state from politicians and family and friends mourning the loss of the 28-year-old trooper.

"I would urge all Georgians to keep this family and his fiancée in your thoughts and prayers as they continue to deal with this horrific loss on behalf of our state," Georgia Gov. Brian Kemp said.

On Feb. 2, the GSP announced the arrest of Gerson Ayala Rodriguez in connection to Cenescar's death. He was arrested in Norcross and taken into custody by the GSP and Gwinnett County police. Rodriguez is facing 10 charges in connection with the trooper's death, including felony murder and first-degree homicide.

The Georgia Department of Public Safety is also warning people about a fake fundraiser page on social media that is asking for donations to support Cenescar's family.

Dubuque, IOWA – Loras College Criminal Justice professor and graphic novelist, Dr. Kenny Loui, was recognized in the 34th annual Midwest Book Awards. Gold winners were announced in person at the Midwest Book Awards gala held on June 22, 2024, at the Mall of America in Minneapolis, MN. *There is No Shrimp... And Other Lies My Mother Told Me* won the gold medal, selected as the best among three finalists in the Graphic Novels category. *There is No Shrimp* was also a finalist in the Family & Parenting and Total Book Design categories.

"I'm honored and humbled by this award from the Midwest Independent Publishers Association. This is a big win for me not only as an indie creator and author, but as an indie publisher in the graphic novel space," said Loui when accepting his award. "I hope that readers who pick up the book flashback to their precious childhood memories with their parents, guardians and other loved ones, and appreciate the people in their lives that have been there for them."



Loui's other graphic novel, *Life Lessons from a UFO Catcher: An Autobiographical Manga* was also selected as a finalist in the Graphic Novels and Total Book Design categories. Published by UFO Comics, *Life Lessons from a UFO Catcher* and *There is No Shrimp... And Other Lies My Mother Told Me* are Loui's debut graphic novels, written by Loui and illustrated by Yamawe. *There is No Shrimp... And Other Lies My Mother Told Me* is a manga memoir about the little white lies and alternative facts a loving mother told her naïve and gullible son and the mayhem that ensues because of those fantastical fibs. *There is No Shrimp* serves as a prequel and companion piece to *Life Lessons from a UFO Catcher*, the tale of a man drifting through life, capturing cute plushies and important life lessons along the way, akin to Aesop's Fables but with a modern-day twist and an awesome 80's soundtrack.

The Midwest Book Awards are presented by the Midwest Independent Publishers Association, a nonprofit organization dedicated to supporting independent publishers in the Midwest. The awards are open to all books published in the Midwest in the previous year.

MiPA founders organized the first Midwest Book Awards in 1989, and today the Midwest Book Awards is one of the longest running literary recognition programs in the country. Judges for the prestigious literary program are booksellers, university staff and librarians who are subject matter experts and collectively hail from each of MiPA's twelve states.

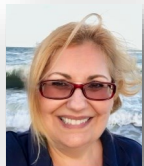
