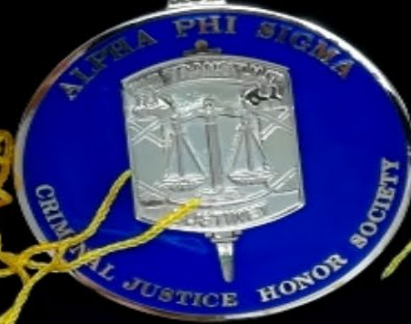

Chapter Charter Process

Before Chartering an APS Chapter

- College/university must be accredited and offer a baccalaureate degree or higher.
- Chapter must charter with a minimum of 10 members. (See Student Membership Application for eligibility requirements).
- Chapter shall have a Chapter Advisor, and may also have an Assistant Chapter Advisor. Proposed Chapter Advisor and Assistant Advisor's membership count toward the 10-member requirement. (See APS bylaws for Advisor eligibility).
- Chapter shall have Chapter Bylaws. A template is available on our website under the chapters tab for chapters to complete the information needed.
- Chapter will be assigned a Greek name by Headquarters.
- Chapter will receive non-profit status under the umbrella of Alpha Phi Sigma. Headquarters will apply for the chapter's EIN number with the IRS and file their annual 990-N form (Financial Report will be required annually) .

Alpha Phi Sigma Chapter Charter Application Instructions

Colleges or Universities offering a baccalaureate or higher degrees in the field of Criminal Justice or related fields* and that are accredited by one of the following regional accrediting associations listed below, may apply for a chapter.

- American Bar Association
- Higher Learning Commission (previously the North Central Association of Colleges)
- Middle State Association of Colleges and Schools
- New England Association of Schools and Colleges
- New England Commission of Higher Education
- Northwest Commission on Colleges and Universities
- Southern Association of Colleges and Schools
- Western Association of Schools and Colleges

*"Related Fields" refer to various disciplines related to the Criminal Justice field, such as, forensics, law, homeland security, human services, political sciences, sociology, justice studies, psychology, public administration, social sciences, government, and social work. Students in these programs must complete a minimum of four courses directly related to the criminal justice field such as juvenile delinquency, criminology, legal perspectives, abnormal behavior, service administration/management, etc., and have a minimum GPA of 3.2 and rank in the top 35% of their class, or if no class ranking is available, student must have a minimum GPA of 3.3.

Colleges or universities must have a minimum of ten (10) members to charter a chapter. The charter application must be accompanied by the by-laws of the chapter and a list of the chartering students identifying the following officers: President, Vice-President, Secretary, and Treasurer.

Chapter Employer Identification Number (EIN)

Chapters are assigned an EIN by Headquarters. Headquarters will file the chapter's annual Income Tax Return (990N form) showing that gross receipts are normally \$50,000 or less per calendar year. Chapters will be notified each year by Headquarters when it is time to complete the APS Chapter Financial Report (Google form) to remain in compliance with the IRS requirement. The required 990N form is filed according to the Chapter Financial Report.

Charter Application Information

Applicable Fees:

- One Time Charter Fee: \$100
- Annual Chapter Dues: \$85 (\$85 Annual Chapter dues are due every January 1st.)
- *If the chapter is chartered between July 1st and December 31st, the Annual Chapter dues will be prorated to \$42.50.
- Student Membership Application Fee: \$85 per student (\$95 for online only students)
- Faculty/Honorary Membership Application Fee: \$85 per Faculty or Honorary

Accepted forms of payment:

- Cashier's Check or Money Orders (please add name of student in the "memo" section of the money order.
- Chapter Check or University/College check
- Credit/Debit card (To submit a credit card payment, please e-mail all required documents to headquarters@alphaphisigma.org and request an invoice).

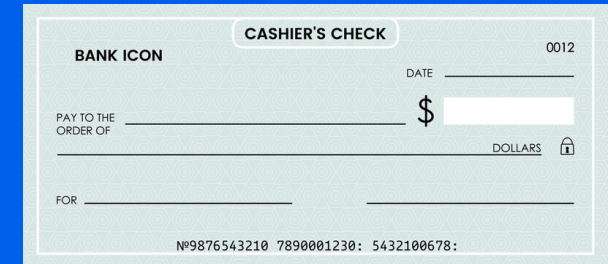

- Chapter Advisor, department chair and administrator, dean or above, must sign Petition for Chapter Charter section.

Checklist of items needed to be submitted with charter application:

- All student applications with corresponding fees
- Faculty or Honorary applications for Chapter Advisor and Assistant Chapter Advisor
 - Application fee for each Advisor/Assistant Advisor
 - Brief resume/CV for each Advisor/Assistant Advisor
 - Completed Signature Verification Form (available on our website under chapters tab)
- Chapter Bylaws. Please follow the template available on our website by completing all sections marked in red with new chapter's information. Bylaws will be reviewed by Headquarters and Advisor will be notified should changes need to be made or if bylaws have been accepted.
- One-time Charter fee
- Annual chapter dues

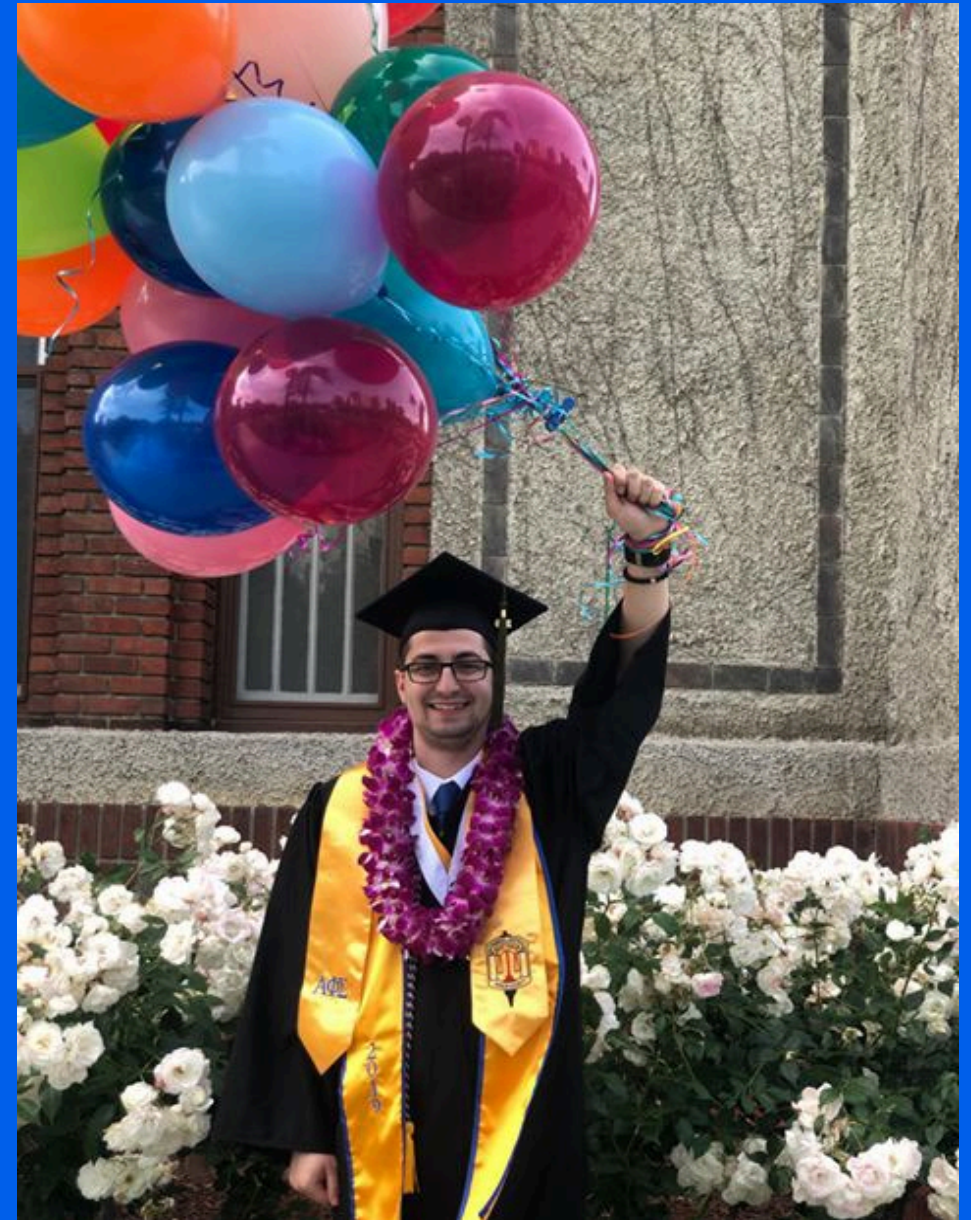
Chapter Charter Process
