- 2. Fundraising
 - a. As a reminder this is a leo year
 - b. Spoke w/ Hannah, we will run leo charges through sports Engine, so credits can be used
 - c. You can choose to pay by either cash, check, or Sports Engine CC or Credits, and the board will write 1 big check for leos to Midwest. You can also make payments to Sports Engine to have the funds available for whenever the payment is scheduled.
 - d. Thinking of doing a purse raffle fund raiser
 - i. Idea: Cost of purse divided by number of participating families, that will be the buy in amount, this will be used to get your tickets. The goal is for the profit made from selling tickets to stay with the families to help offset expenses

- 4. Cost of 2024-25 season- went over budget on print outs
 - a. Things ran over w/ coaches expense due to the number of girls attending meets and scheduling. Planned for 2 coaches, but he needed all 4 coaches
- 5. Sports engine fees- cuts back on hours of work for treasurer volunteer
 - a. Gives accountability for us as board, and parents
 - b. External audit
 - c. Helps to file taxes to give to accountant
 - d. Payments taken must be matched to gymnast- difficulty reading writing, matching different last names, etc. SE app removes this difficulty
- 6. SE- all kids are unregistered for now
 - a. Once we know levels and have a cost agreement you can go back in and register your kid and choose payment plan. We will go over this as the beginning of the year parent meeting and let you know when you can do this.
 - b. For meets- go in and choose I attend/ I do not attend
 - i. We will know more when it goes live, but we will most likely click "I Attend" for all girls
 - ii. Your responsibility to click "i do not attend" so we know when girls are not attending meets. Better chance to be reimbursed for meet fees for that meet
- 7. Xcel state meet
 - a. Huge success- \$55k in profit
 - b. One bill still have not received- but accounted for cost last year, so it will not affect anyone's payout

PQ- Can we use profits to pay back families? Done in the past

A- A couple years ago, when the accounts were turned over to the current board, they were negative. We are doing everything to make sure we stay in the positive, but yes we are exploring ideas on ways to give back to families. This year, profits were put it into the banquet to reduce family fees. I do want to repeat, that there are separate accounts, so the extra money that parents paid into fees for the season is what was able to be reimbursed towards their banquet fees.

A- We are hoping to get compulsory state which is hearsay and unconfirmed. May or may not happen, but keep your fingers crossed

PQ- When do you guys decide the fees?

A- Kevin does the meet schedule, then we book hotels and price flights so we can get an accurate cost of what will need to be divided amongst the families
