

ATASCOSA COUNTY EMERGENCY SERVICE DISTRICT NO. 1  
RESOLUTION FOR THE 2024 TAX RATE

WHEREAS, the Atascosa County Emergency Service District No. 1 desires to adopt a tax rate for the year 2024; and

IT IS THEREFORE RESOLVED, Atascosa County Emergency Service District No. 1 has adopted a tax rate of 0.10 for each \$100.00 of taxable value which is effectively 9.5842 percent increase in the tax rate.

FURTHER RESOLVED, THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE; AND

FURTHER RESOLVED, THE TAX RATE WILL EFFECTIVELY BE RAISED BY 9.5842 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000.00 HOME BY APPROXIMATELY \$8.75.

This total tax rate shall be levied as follows:

There shall be levied and collected upon all taxable property in Atascosa County Emergency Service District No. 1 for the year 2024, for the use of the Atascosa County Emergency Service District No. 1, an ad valorem tax for maintenance and operations of \$.10 on each \$100 of taxable property so assessed to be credited to the General Fund of Atascosa County Emergency Service District No. 1.

There shall be levied and collected upon all taxable property in Atascosa County Emergency Service District No. 1 for the year 2024, for the use of the Atascosa County Emergency Service District No. 1, an ad valorem interest and sinking of 0.000 on each \$100 of taxable property so assessed to be credited to the Debt Fund of Atascosa County Emergency Service District No. 1.
