

## PSCI 0319A: The Politics of Taxes [Fall 2020] Winslett, Gary

I learned so much from this course. I really didn't know very much about taxes heading into it, and Prof. Winslett did an excellent job of making all the topics accessible and enjoyable. There was very little heavy analytical reading but rather real-world examples applied to inclass concepts we discussed together, making every class very engrossing and enjoyable. I understand the topic of taxes SO much more thoroughly than when I began, and I can compare them across countries and analyze the different factors that lead to different systems' success or failure.

I do remember feeling similar wishful thoughts about a couple of concepts we covered later in the class that I would have loved to research more. The standards were very clear and if we were confused he was very available to answer any of our questions.
