We provided basic electrical, 2 15amp outlets. The source may be up to 100 feet away. It is your responsibility to bring adequate electrical cords. If you have specific electrical needs beyond the basic electric provided, please note them here:

An additional fee of \$250 will be assessed if you require a dedicated outlet, more electrical supply or special hook up. Approval is subject to the La Festa electrician upon receipt of this application.

You may use a generator; however, it must be a quiet run model.

Food Vendors - Health & Fire License requirements

Jersey City Cultural Affairs Division can answer any detailed questions, 201-547-6921

If you are using an open flame unit, propane charcoal or wood, the Jersey City Fire Department requires a fire license. You must obtain your open flame permit from the JC Fire Department; the Fee is \$125.00 per open flame unit. (Electrical Appliances or “sternos” do NOT count). Obtain the Fire License at Fire Prevention, 2 Jackson Square, Jersey City, NJ – 201-547-4255

The City of Jersey City also requires a Health License (Temporary Food Vendor Fee) if you sell any type of edible product. You must obtain the license; the fee is \$50.00. If you already have a Jersey City Health License, no need to apply but you must provide a copy when submitting your Contract and payment. Obtain the Temporary Food Vendor License at Jersey City Health Department, 1 Jackson Square, Jersey City, NJ – 201-547-6800.

Insurance Requirements

Food Vendors are required to have liability insurance of \$1,000,000 and provide a Certificate of Insurance naming La Festa Italiana as additional insured. This COI should be submitted with your signed contract.
